A BILL

To amend the Internal Revenue Code of 1986 to repeal the limitation on the amount of receipts attributable to military property which may be treated as exempt foreign trade income.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Defense Jobs and
5 Trade Promotion Act of 1999”.

1 **SEC. 2. REPEAL OF LIMITATION ON RECEIPTS ATTRIB-**
2 **UTABLE TO MILITARY PROPERTY WHICH MAY**
3 **BE TREATED AS EXEMPT FOREIGN TRADE IN-**
4 **COME.**

5 (a) **IN GENERAL.**—Subsection (a) of section 923 of
6 the Internal Revenue Code of 1986 (defining exempt for-
7 eign trade income) is amended by striking paragraph (5)
8 and by redesignating paragraph (6) as paragraph (5).

9 (b) **EFFECTIVE DATE.**—The amendment made by
10 subsection (a) shall apply to taxable years beginning after
11 the date of the enactment of this Act.
