A BILL

To amend part G of title I of the Omnibus Crime Control and Safe Streets Act of 1968 to allow railroad police officers to attend the Federal Bureau of Investigation National Academy for law enforcement training.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INCLUSION OF RAILROAD POLICE OFFICERS IN**
4 **FBI LAW ENFORCEMENT TRAINING.**

5 (a) IN GENERAL.—Section 701(a) of part G of title
6 I of the Omnibus Crime Control and Safe Streets Act of
7 1968 (42 U.S.C. 3771(a)) is amended—

8 (1) in paragraph (1)—

1 (A) by striking “State or unit of local gov-
2 ernment” and inserting “State, unit of local
3 government, or rail carrier”; and

4 (B) by inserting “, including railroad po-
5 lice officers” before the semicolon; and

6 (2) in paragraph (3)—

7 (A) by striking “State or unit of local gov-
8 ernment” and inserting “State, unit of local
9 government, or rail carrier”;

10 (B) by inserting “railroad police officer,”
11 after “deputies,”;

12 (C) by striking “State or such unit” and
13 inserting “State, unit of local government, or
14 rail carrier”; and

15 (D) by striking “State or unit.” and in-
16 serting “State, unit of local government, or rail
17 carrier.”.

18 (b) RAIL CARRIER COSTS.—Section 701 of part G
19 of title I of the Omnibus Crime Control and Safe Streets
20 Act of 1968 (42 U.S.C. 3771) is amended by adding at
21 the end the following:

22 “(d) RAIL CARRIER COSTS.—No Federal funds may
23 be used for any travel, transportation, or subsistence ex-
24 penses incurred in connection with the participation of a

1 railroad police officer in a training program conducted
2 under subsection (a).”.

3 (c) DEFINITIONS.—Section 701 of part G of title I
4 of the Omnibus Crime Control and Safe Streets Act of
5 1968 (42 U.S.C. 3771) is amended by adding at the end
6 the following:

7 “(e) DEFINITIONS.—In this section—

8 “(1) the terms ‘rail carrier’ and ‘railroad’ have
9 the meanings given such terms in section 20102 of
10 title 49, United States Code; and

11 “(2) the term ‘railroad police officer’ means a
12 peace officer who is commissioned in his or her
13 State of legal residence or State of primary employ-
14 ment and employed by a rail carrier to enforce State
15 laws for the protection of railroad property, per-
16 sonnel, passengers, or cargo.”.
