Mr. REID introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To give the city of Mesquite, Nevada, the right to purchase at fair market value certain parcels of public land in the city.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CONVEYANCE OF LAND TO CITY OF MESQUITE,**
4 **NEVADA.**

5 Section 3 of Public Law 99–548 (100 Stat. 3061;
6 110 Stat. 3009–202) is amended by adding at the end
7 the following:

8 “(e) FIFTH AREA.—

9 “(1) RIGHT TO PURCHASE.—For a period of 12
10 years after the date of enactment of this Act, the

1 city of Mesquite, Nevada, shall have the exclusive
2 right to purchase the parcels of public land de-
3 scribed in paragraph (2).

4 “(2) LAND DESCRIPTION.—The parcels of pub-
5 lic land referred to in paragraph (1) are as follows:

6 “(A) In T. 13 S., R. 70 E., Mount Diablo
7 Meridian, Nevada:

8 “(i) The portion of sec. 27 north of
9 Interstate Route 15.

10 “(ii) Sec. 28: NE $\frac{1}{4}$, S $\frac{1}{2}$ (except the
11 Interstate Route 15 right-of-way).

12 “(iii) Sec. 29: E $\frac{1}{2}$ NE $\frac{1}{4}$ SE $\frac{1}{4}$, SE
13 $\frac{1}{4}$ SE $\frac{1}{4}$.

14 “(iv) The portion of sec. 30 south of
15 Interstate Route 15.

16 “(v) The portion of sec. 31 south of
17 Interstate Route 15.

18 “(vi) Sec. 32: NE $\frac{1}{4}$ NE $\frac{1}{4}$ (except
19 the Interstate Route 15 right-of-way), the
20 portion of NW $\frac{1}{4}$ NE $\frac{1}{4}$ south of Inter-
21 state Route 15, and the portion of W $\frac{1}{2}$
22 south of Interstate Route 15.

23 “(vii) The portion of sec. 33 north of
24 Interstate Route 15.

1 “(B) In T. 14 S., R. 70 E., Mount Diablo
2 Meridian, Nevada:

3 “(i) Sec. 5: NW $\frac{1}{4}$.

4 “(ii) Sec. 6: N $\frac{1}{2}$.

5 “(C) In T. 13 S., R. 69 E., Mount Diablo
6 Meridian, Nevada:

7 “(i) The portion of sec. 25 south of
8 Interstate Route 15.

9 “(ii) The portion of sec. 26 south of
10 Interstate Route 15.

11 “(iii) The portion of sec. 27 south of
12 Interstate Route 15.

13 “(iv) Sec. 28: SW $\frac{1}{4}$ SE $\frac{1}{4}$.

14 “(v) Sec. 33: E $\frac{1}{2}$.

15 “(vi) Sec. 34.

16 “(vii) Sec. 35.

17 “(viii) Sec. 36.

18 “(3) NOTIFICATION.—Not later than 10 years
19 after the date of enactment of this subsection, the
20 city shall notify the Secretary which of the parcels
21 of public land described in paragraph (2) the city in-
22 tends to purchase.

23 “(4) CONVEYANCE.—Not later than 1 year
24 after receiving notification from the city under para-

1 graph (3), the Secretary shall convey to the city the
2 land selected for purchase.

3 “(5) WITHDRAWAL.—Subject to valid existing
4 rights, until the date that is 12 years after the date
5 of enactment of this subsection, the parcels of public
6 land described in paragraph (2) are withdrawn from
7 all forms of entry and appropriation under the pub-
8 lic land laws, including the mining laws, and from
9 operation of the mineral leasing and geothermal
10 leasing laws.

11 “(6) USE OF PROCEEDS.—The proceeds of the
12 sale of each parcel—

13 “(A) shall be deposited in the special ac-
14 count established under section 4(e)(1)(C) of
15 the Southern Nevada Public Land Management
16 Act of 1998 (112 Stat. 2345); and

17 “(B) shall be disposed of by the Secretary
18 as provided in section 4(e)(3) of that Act (112
19 Stat. 2346).

20 “(f) SIXTH AREA.—

21 “(1) IN GENERAL.—Not later than 1 year after
22 the date of enactment of this subsection, the Sec-
23 retary shall convey to the city of Mesquite, Nevada,
24 in accordance with section 47125 of title 49, United
25 States Code, up to 2,560 acres of public land to be

1 selected by the city from among the parcels of land
2 described in paragraph (2).

3 “(2) LAND DESCRIPTION.—The parcels of land
4 referred to in paragraph (1) are as follows:

5 “(A) In T. 13 S., R. 69 E., Mount Diablo
6 Meridian, Nevada:

7 “(i) The portion of sec. 28 south of
8 Interstate Route 15 (except S $\frac{1}{2}$ SE $\frac{1}{4}$).

9 “(ii) The portion of sec. 29 south of
10 Interstate Route 15.

11 “(iii) The portion of sec. 30 south of
12 Interstate Route 15.

13 “(iv) The portion of sec. 31 south of
14 Interstate Route 15.

15 “(v) Sec. 32.

16 “(vi) Sec. 33: W $\frac{1}{2}$.

17 “(B) In T. 14 S., R. 69 E., Mount Diablo
18 Meridian, Nevada:

19 “(i) Sec. 4.

20 “(ii) Sec. 5.

21 “(iii) Sec. 6.

22 “(iv) Sec. 8.

23 “(C) In T. 14 S., R. 68 E., Mount Diablo
24 Meridian, Nevada:

25 “(i) Sec. 1.

1 “(ii) Sec. 12.

2 “(3) WITHDRAWAL.—Subject to valid existing
3 rights, until the date that is 12 years after the date
4 of enactment of this subsection, the parcels of public
5 land described in paragraph (2) are withdrawn from
6 all forms of entry and appropriation under the pub-
7 lic land laws, including the mining laws, and from
8 operation of the mineral leasing and geothermal
9 leasing laws.”.
