Mr. ROTH introduced the following bill; which was read twice and referred to the Committee on Environment and Public Works

A BILL

To provide additional assistance for fire and emergency services, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “21st Century Fire and
5 Emergency Services Act of 2000”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) AGENCY.—The term “Agency” means the
9 Federal Emergency Management Agency.

1 (2) BURN PROGRAM.—The term “burn pro-
2 gram” means the Burn Services Grant Program es-
3 tablished by section 3(a).

4 (3) DIRECTOR.—The term “Director” means
5 the Director of the Agency.

6 (4) FIRE PROGRAM.—The term “fire program”
7 means the “Fire Services Grant Program” estab-
8 lished under section 4(a).

9 **SEC. 3. BURN SERVICES GRANT PROGRAM.**

10 (a) ESTABLISHMENT.—There is established within
11 the Agency a grant program to be known as the “Burn
12 Services Grant Program”.

13 (b) COMPETITIVE GRANTS.—The Director may make
14 a grant under the burn program, on a competitive basis,
15 to—

16 (1) a safety organization that has experience in
17 conducting burn safety programs, for the purpose of
18 assisting the organization in conducting or aug-
19 menting a burn prevention program;

20 (2) a hospital that serves as a regional burn
21 center, for the purpose of conducting acute burn
22 care research; or

23 (3) a governmental or nongovernmental entity,
24 for the purpose of providing after-burn treatment
25 and counseling to individuals that are burn victims.

1 (c) PROGRAM OFFICE.—The Director shall establish
2 within the Agency an office to—

3 (1) establish criteria for use by the Director in
4 awarding grants under the burn program; and

5 (2) administer grants awarded under the burn
6 program.

7 (d) AUTHORIZATION OF APPROPRIATIONS.—There is
8 authorized to be appropriated to carry out this section
9 \$10,000,000, to remain available until expended.

10 **SEC. 4. FIRE SERVICES GRANT PROGRAM.**

11 (a) ESTABLISHMENT.—The Director shall establish
12 within the Agency a grant program known as the “Fire
13 Services Grant Program” to award grants to volunteer,
14 paid, and combined volunteer-paid departments that pro-
15 vide fire and emergency medical services.

16 (b) USE OF FUNDS.—A grant awarded under the fire
17 program may be used to—

18 (1) acquire—

19 (A) personal protective equipment required
20 for firefighting personnel by the Occupational
21 Safety and Health Administration; and

22 (B) other personal protective equipment
23 for firefighting personnel;

- 1 (2) acquire additional firefighting equipment,
2 including equipment for communication and moni-
3 toring;
- 4 (3) establish wellness and fitness programs for
5 firefighting personnel to reduce the number of inju-
6 ries and deaths related to health and conditioning
7 problems;
- 8 (4) promote professional development of fire
9 code enforcement personnel;
- 10 (5) integrate computer technology to improve
11 records management and training capabilities;
- 12 (6) train firefighting personnel in—
 - 13 (A) firefighting;
 - 14 (B) emergency response; and
 - 15 (C) arson prevention and detection;
- 16 (7) enforce fire codes;
- 17 (8) fund fire prevention programs and public
18 education programs on—
 - 19 (A) arson prevention and detection; and
 - 20 (B) juvenile fire setter intervention; and
- 21 (9) modify fire stations, fire training facilities,
22 and other facilities to protect the health and safety
23 of firefighting personnel.

1 (c) APPLICATIONS.—An applicant for a grant award-
2 ed under the fire program shall submit to the Director
3 an application that includes—

4 (1) a demonstration of the financial need of the
5 applicant;

6 (2) evidence of a commitment by the applicant
7 to provide matching funds from non-Federal sources
8 for the project that is the subject of the application
9 in an amount that is at least equal to the amount
10 of funds requested in the application;

11 (3) a cost-benefit analysis linking the funds re-
12 quested to improvements in public safety; and

13 (4) a commitment by the applicant to provide
14 information to the National Fire Incident Reporting
15 System for the period for which the grant is re-
16 ceived.

17 (d) AUDITS.—The Director shall conduct audits of
18 grant recipients to ensure that grant funds are used for
19 the purposes for which the grant is awarded.

20 (e) AUTHORIZATION OF APPROPRIATIONS.—There is
21 authorized to be appropriated to carry out this section
22 \$80,000,000, to remain available until expended.

23 **SEC. 5. COOPERATIVE FORESTRY ASSISTANCE.**

24 The Secretary of Agriculture shall use the funds, fa-
25 cilities, and authorities of the Commodity Credit Corpora-

1 tion to carry out paragraphs (1) through (3) of section
2 10(b) of the Cooperative Forestry Assistance Act of 1978
3 (16 U.S.C. 2106(b)), not to exceed \$10,000,000, to re-
4 main available until expended.
