

S. CON. RES. 112

CONCURRENT RESOLUTION

1 *Resolved by the Senate (the House of Representatives*
2 *concurring)*, That, in the enrollment of the bill (H.R. 434)
3 to authorize a new trade and investment policy for sub-
4 Sahara Africa, the Clerk of the House of Representatives
5 shall make the following corrections:

6 (1) In section 112(b)(1), insert “(including fab-
7 rics not formed from yarns, if such fabrics are clas-
8 sifiable under heading 5602 or 5603 of the Har-
9 monized Tariff Schedule of the United States and
10 are wholly formed and cut in the United States)”
11 after “yarns wholly formed in the United States,”.

12 (2) In section 112(b)(2), insert “(including fab-
13 rics not formed from yarns, if such fabrics are clas-
14 sifiable under heading 5602 or 5603 of the Har-
15 monized Tariff Schedule of the United States and
16 are wholly formed in the United States)” after
17 “yarns wholly formed in the United States”.

18 (3) In section 112(b)(3), strike “countries, sub-
19 ject” and insert “countries (including fabrics not

1 formed from yarns, if such fabrics are classifiable
2 under heading 5602 or 5603 of the Harmonized
3 Tariff Schedule of the United States and are wholly
4 formed and cut in 1 or more beneficiary sub-Saha-
5 ran African countries), subject”.

6 (4) In section 112(b)(5)(A), insert “apparel ar-
7 ticles of” after “to the extent that”.

8 (5) In section 213(b)(2)(A) of the Caribbean
9 Basin Economic Recovery Act, as contained in sec-
10 tion 211(a) of the bill—

11 (A) in clause (i), strike “in a CBTPA ben-
12 efiary country” and insert “in 1 or more
13 CBTPA beneficiary countries”; and

14 (B) in clause (ii)—

15 (i) strike “cut in a CBTPA bene-
16 fiary country” and insert “cut in 1 or
17 more CBTPA beneficiary countries”; and

18 (ii) strike “assembled in such coun-
19 try” and insert “assembled in 1 or more
20 such countries”.

21 (6) In section 213(b)(2)(A)(i) of the Caribbean
22 Basin Economic Recovery Act, as contained in sec-
23 tion 211(a) of the bill, insert “(including fabrics not
24 formed from yarns, if such fabrics are classifiable
25 under heading 5602 or 5603 of the HTS and are

1 wholly formed and cut in the United States)” after
2 “yarns wholly formed in the United States,”.

3 (7) In section 213(b)(2)(A)(ii) of the Caribbean
4 Basin Economic Recovery Act, as contained in sec-
5 tion 211(a) of the bill, insert “(including fabrics not
6 formed from yarns, if such fabrics are classifiable
7 under heading 5602 or 5603 of the HTS and are
8 wholly formed in the United States)” after “yarns
9 wholly formed in the United States”.

10 (8) In section 213(b)(2)(A)(iii)(I) of the Carib-
11 bean Basin Economic Recovery Act, as contained in
12 section 211(a) of the bill, strike “United States, in
13 an amount” and insert “United States (including
14 fabrics not formed from yarns, if such fabrics are
15 classifiable under heading 5602 or 5603 of the HTS
16 and are formed in 1 or more CBTPA beneficiary
17 countries), in an amount”.

18 (9) In clause (v) of section 213(b)(2)(A) of the
19 Caribbean Basin Economic Recovery Act, as con-
20 tained in section 211(a) of the bill—

21 (A) strike “fibers, fabric, or yarn” each
22 place it appears in the heading and the text and
23 insert “fabrics or yarn”;

24 (B) strike “fibers, fabric, and yarn” and
25 insert “fabrics and yarn”; and

1 (C) insert “apparel articles of” after “to
2 the extent that”.

3 (10) In section 213(b)(2)(A)(vii)(IV) of the
4 Caribbean Basin Economic Recovery Act, as con-
5 tained in section 211(a) of the bill, strike “entered”
6 and insert “classifiable”.

7 (11) In section 213(b)(2)(A) of the Caribbean
8 Basin Economic Recovery Act, as contained in sec-
9 tion 211(a) of the bill, strike “(vii) TEXTILE LUG-
10 GAGE.—” and insert “(viii) TEXTILE LUGGAGE.—”.

11 (12) Strike section 412(a)(2) and insert the fol-
12 lowing:

13 “(2) in the flush paragraph at the end, by
14 striking “and (G)” and inserting “(G), and (H) (to
15 the extent described in section 507(6)(D))”.”.

16 (13) In the article description for subheading
17 9902.51.13 of the Harmonized Tariff Schedule of
18 the United States, as added by section 502(a) of the
19 bill, strike “of 64’s and linen worsted wool count
20 wool yarn”.

1 (14) In section 505(d), insert “to the United
2 States Customs Service” after “appropriate claim”.
