

CONCURRENT RESOLUTION

Whereas Israel has been actively seeking a comprehensive peace with all of her neighbors to bring about an end to the Arab-Israeli conflict;

Whereas southern Lebanon has for decades been the staging area for attacks against Israeli cities and towns by Hezbollah and by Palestinian terrorists, resulting in the death or wounding of hundreds of Israeli civilians;

Whereas United Nations Security Council Resolution 425 (March 19, 1978) calls upon Israel to withdraw its forces from all Lebanese territory;

Whereas the Government of Israel unanimously agreed to implement Security Council Resolution 425 and has stated its intention of redeploying its forces to the international border by July 7, 2000;

Whereas Security Council Resolution 425 also calls for “strict respect for the territorial integrity, sovereignty and political independence of Lebanon within its internationally recognized boundaries” and establishes a United Nations interim force to help restore Lebanese sovereignty; and

Whereas the Government of Syria currently deploys 30,000 Syrian troops in Lebanon: Now, therefore, be it

1 *Resolved by the Senate (the House of Representatives*
2 *concurring)*, That Congress—

1 (1) commends Israel for its decision to with-
2 draw its forces from southern Lebanon and for tak-
3 ing risks for peace in the Middle East;

4 (2) calls upon the United Nations Security
5 Council—

6 (A) to recognize Israel's fulfillment of its
7 obligations under Security Council Resolution
8 425 and to provide the necessary resources for
9 the United Nations Interim Force in Lebanon
10 (UNIFIL) to implement its mandate under that
11 resolution; and

12 (B) to insist upon the withdrawal of all
13 foreign forces from Lebanese territory so that
14 Lebanon may exercise sovereignty throughout
15 its territory;

16 (3) urges UNIFIL, in cooperation with the
17 Lebanese Armed Forces, to gain full control over
18 southern Lebanon, including taking actions to en-
19 sure the disarmament of Hezbollah and all other
20 such groups, in order to eliminate all terrorist activ-
21 ity originating from that area;

22 (4) appeals to the Government of Lebanon to
23 grant clemency and assure the safety and rehabilita-
24 tion into Lebanese society of all members of the
25 South Lebanon Army and their families;

1 (5) calls upon the international community to
2 ensure that southern Lebanon does not once again
3 become a staging ground for attacks against Israel
4 and to cooperate in bringing about the reconstruc-
5 tion and reintegration of southern Lebanon;

6 (6) recognizes Israel's right, enshrined in Chap-
7 ter 7, Article 51 of the United Nations Charter, to
8 defend itself and its people from attack and re-
9 asserts United States support for maintaining
10 Israel's qualitative military edge in order to ensure
11 Israel's long-term security; and

12 (7) urges all parties to reenter the peace proc-
13 ess with the Government of Israel in order to bring
14 peace and stability to all the Middle East.
