CONCURRENT RESOLUTION

1 *Resolved by the Senate (the House of Representatives*
2 *concurring)*, That the Secretary of the Senate, in the en-
3 rollment of the bill (S.1809) to improve service systems
4 for individuals with developmental disabilities, and for
5 other purposes, shall make the following corrections:

6 (1) Strike “1999” each place it appears (other
7 than in section 101(a)(2)) and insert “2000”.

8 (2) In section 101(a)(2), strike “are” and in-
9 sert “were”.

10 (3) In section 104(a)—

11 (A) in paragraphs (1), (3)(C), and (4),
12 strike “2000” each place it appears and insert
13 “2001”; and

14 (B) in paragraph (4), strike “fiscal year
15 2001” and insert “fiscal year 2002”.

16 (4) In section 124(c)(4)(B)(i), strike “2001”
17 and insert “2002”.

18 (5) In section 125(c)—

1 (A) in paragraph (5)(H), strike “assess”
2 and insert “access”; and

3 (B) in paragraph (7), strike “2001” and
4 insert “2002”.

5 (6) In section 129(a)—

6 (A) strike “fiscal year 2000” and insert
7 “fiscal year 2001”; and

8 (B) strike “fiscal years 2001 through
9 2006” and insert “fiscal years 2002 through
10 2007”.

11 (7) In section 144(e), strike “2001” and insert
12 “2002”.

13 (8) In section 145—

14 (A) strike “fiscal year 2000” and insert
15 “fiscal year 2001”; and

16 (B) strike “fiscal years 2001 through
17 2006” and insert “fiscal years 2002 through
18 2007”.

19 (9) In section 156—

20 (A) in subsection (a)(1)—

21 (i) strike “fiscal year 2000” and in-
22 sert “fiscal year 2001”; and

23 (ii) strike “fiscal years 2001 through
24 2006” and insert “fiscal years 2002
25 through 2007”; and

1 (B) in subsection (b), strike “2000” each
2 place it appears and insert “2001”.

3 (10) In section 163—

4 (A) strike “fiscal year 2000” and insert
5 “fiscal year 2001”; and

6 (B) strike “fiscal years 2001 through
7 2006” and insert “fiscal years 2002 through
8 2007”.

9 (11) In section 212, strike “2000 through
10 2006” and insert “2001 through 2007”.

11 (12) In section 305—

12 (A) in subsection (a)—

13 (i) strike “fiscal year 2000” and in-
14 sert “fiscal year 2001”; and

15 (ii) strike “fiscal years 2001 through
16 2006” and insert “fiscal years 2002
17 through 2007”; and

18 (B) in subsection (b)—

19 (i) strike “fiscal year 2000” and in-
20 sert “fiscal year 2001”; and

- 1 (ii) strike “fiscal years 2001 and
2 2002” and insert “fiscal years 2002 and
3 2003”.
