A BILL

To require the Attorney General to identify organizations that recruit juveniles to participate in violent and illegal activities related to the environment or to animal rights; and to amend the Juvenile Justice and Delinquency Prevention Act of 1974 to provide assistance to States to carry out activities to prevent the participation of juveniles in such activities.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Hands Off Our Kids
3 Act of 2001”.

4 **SEC. 2. IDENTIFICATION OF ORGANIZATIONS THAT RE-**
5 **CRUIT JUVENILES TO ENGAGE IN CERTAIN**
6 **VIOLENT AND ILLEGAL ACTIVITIES.**

7 The Attorney General shall establish and implement
8 a policy within the Department of Justice to identify orga-
9 nizations that recruit individuals in the United States who
10 are less than 18 years of age to participate in violent and
11 illegal activities related to the environment, to animal
12 rights, or to any other matter the Attorney General con-
13 sidered to be appropriate.

14 **SEC. 3. AMENDMENTS.**

15 Section 223(a)(10) of the Juvenile Justice and Delin-
16 quency Prevention Act of 1974 (42 U.S.C. 5633(a)(10))
17 is amended—

18 (1) in subparagraph (N) by striking “and” at
19 the end,

20 (2) in subparagraph (O) by striking the period
21 at the end and inserting “; and”, and

22 (3) by adding at the end the following:

23 “(P) programs to be carried out through
24 local education agencies (as defined in section
25 14101 of the Elementary and Secondary Edu-

1 cation Act of 1965 (20 U.S.C. 8801)
2 designed—

3 “(i) to educate juveniles about organi-
4 zations that recruit juveniles to participate
5 in violent and illegal activities to advance
6 a particular cause; and

7 “(ii) to combat participation by juve-
8 niles in such activities.”.

9 **SEC. 3. EFFECTIVE DATE.**

10 This Act and the amendments made by this Act shall
11 take effect on the 1st day of the 1st fiscal year beginning
12 after the date of the enactment of this Act.
