## A BILL

To amend the Act that established the Pu'uhonua O Honaunau National Historical Park to expand the boundaries of that park.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Pu‘uhonua o Hōnaunau*  
3 *National Historical Park Addition Act of 2002”.*

4 **SEC. 2. ADDITIONS TO PU‘UHONUA O HŌNAUNAU NA-**  
5 **TIONAL HISTORICAL PARK.**

6 *The first section of the Act of July 26, 1955 (69 Stat.*  
7 *376, ch. 385; 16 U.S.C. 397), is amended—*

8 *(1) by striking “That, when” and inserting the*  
9 *following:*

10 *“SECTION 1. (a) When”; and*

11 *(2) by adding at the end thereof the following*  
12 *new subsections:*

13 *“(b) The boundaries of Pu‘uhonua o Hōnaunau Na-*  
14 *tional Historical Park are hereby modified to include ap-*  
15 *proximately 238 acres of lands and interests therein within*  
16 *the area identified as ‘Parcel A’ on the map entitled*  
17 *‘Pu‘uhonua o Hōnaunau National Historical Park Pro-*  
18 *posed Boundary Additions, Ki‘ilae Village’, numbered*  
19 *PUHO–P 415/82,013 and dated May, 2001.*

20 *“(c) The Secretary of the Interior is authorized to ac-*  
21 *quire approximately 159 acres of lands and interests there-*  
22 *in within the area identified as ‘Parcel B’ on the map ref-*  
23 *erenced in subsection (b). Upon the acquisition of such*  
24 *lands or interests therein, the Secretary shall modify the*  
25 *boundaries of Pu‘uhonua o Hōnaunau National Historical*  
26 *Park to include such lands or interests therein.”.*

1 **SEC. 3. AUTHORIZATIONS OF APPROPRIATIONS.**

2 *There are authorized to be appropriated such sums as*

3 *may be necessary to carry out this Act.*
