**AN ACT**

To reauthorize various fishing conservation management  
programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fisheries Conservation  
5 Act of 2001”.

1 **TITLE I—INTERJURISDICTIONAL**  
2 **FISHERIES ACT OF 1986**

3 **SEC. 101. REAUTHORIZATION OF INTERJURISDICTIONAL**  
4 **FISHERIES ACT OF 1986.**

5 Section 308 of the Interjurisdictional Fisheries Act  
6 of 1986 (16 U.S.C. 4107) is amended—

7 (1) by amending subsection (a) to read as fol-  
8 lows:

9 “(a) GENERAL APPROPRIATIONS.—There are author-  
10 ized to be appropriated to the Department of Commerce  
11 for apportionment to carry out the purposes of this title—

12 “(1) \$4,900,000 for fiscal year 2002;

13 “(2) \$5,400,000 for each of fiscal years 2003  
14 and 2004; and

15 “(3) \$5,900,000 for each of fiscal years 2005  
16 and 2006.”; and

17 (2) in subsection (c) by striking “\$700,000 for  
18 fiscal year 1997, and \$750,000 for each of the fiscal  
19 years 1998, 1999, and 2000” and inserting  
20 “\$800,000 for fiscal year 2002, \$850,000 for each  
21 of fiscal years 2003 and 2004, and \$900,000 for  
22 each of fiscal years 2005 and 2006”.

1 **SEC. 102. PURPOSES OF THE INTERJURISDICTIONAL FISHERIES ACT OF 1986.**  
 2

3 Section 302 of the Interjurisdictional Fisheries Act  
 4 of 1986 (16 U.S.C. 4101) is amended by striking “and”  
 5 after the semicolon at the end of paragraph (1), striking  
 6 the period at the end of paragraph (2) and inserting “;  
 7 and”, and adding at the end the following:

8 “(3) to promote and encourage research in  
 9 preparation for the implementation of the use of eco-  
 10 systems and interspecies approaches to the conserva-  
 11 tion and management of interjurisdictional fishery  
 12 resources throughout their range.”

13 **TITLE II—ANADROMOUS FISH**  
 14 **CONSERVATION ACT**

15 **SEC. 201. REAUTHORIZATION OF ANADROMOUS FISH CON-**  
 16 **SERVATION ACT.**

17 Section 4 of the Anadromous Fish Conservation Act  
 18 (16 U.S.C. 757d) is amended to read as follows:

19 “AUTHORIZATION OF APPROPRIATIONS

20 “SEC. 4. (a)(1) There are authorized to be appro-  
 21 priated to carry out the purposes of this Act not to exceed  
 22 the following sums:

23 “(A) \$4,500,000 for fiscal year 2002;

24 “(B) \$4,750,000 for each of fiscal years 2003  
 25 and 2004; and

1           “(C) \$5,000,000 for each of fiscal years 2005  
2           and 2006.”

3           “(2) Sums appropriated under this subsection are au-  
4           thorized to remain available until expended.

5           “(b) Not more than \$625,000 of the funds appro-  
6           priated under this section in any one fiscal year shall be  
7           obligated in any one State.”

8   **SEC. 202. RESEARCH ON AND USE OF ECOSYSTEMS AND**  
9                           **INTERSPECIES APPROACHES TO THE CON-**  
10                          **SERVATION AND MANAGEMENT.**

11           The first section of the Anadromous Fish Conserva-  
12           tion Act (16 U.S.C. 757a) is amended in subsection (b)  
13           by inserting “(1)” after “(b)”, and by adding at the end  
14           the following:

15           “(2) In carrying out responsibilities under this sec-  
16           tion, the Secretary shall conduct, promote, and encourage  
17           research in preparation for the implementation of the use  
18           of ecosystems and interspecies approaches to the conserva-  
19           tion and management of anadromous and Great Lakes  
20           fishery resources.”

5             Section 7(a) of the Atlantic Striped Bass Conserva-  
6     tion Act (16 U.S.C. 1851 note) is amended by striking  
7     “and 2003” and inserting “2003, 2004, 2005, and 2006”.

8     **SEC. 302. REAUTHORIZATION OF ATLANTIC COASTAL FISH-**  
9                     **ERIES COOPERATIVE MANAGEMENT ACT.**

10            Section 811(a) of the Atlantic Coastal Fisheries Co-  
11     operative Management Act (16 U.S.C. 5108) is amended  
12     by striking “2005” and inserting “2006”.

13     **SEC. 303. AMENDMENTS TO ATLANTIC COASTAL FISHERIES**  
14                     **COOPERATIVE MANAGEMENT ACT.**

15            (a) FINDINGS.—Section 802(a) of the Atlantic Coast-  
16     al Fisheries Cooperative Management Act (16 U.S.C.  
17     5101(a)) is amended by adding at the end the following:

18                     “(7) The understanding of the interactions of  
19     species in the maritime environment and the devel-  
20     opment of ecosystems-based approaches to fishery  
21     conservation and management lead to better stew-  
22     ardship and sustainability of coastal fishery re-  
23     sources.

24                     “(8) Federal and State scientists should gather  
25     information on the interaction of species in the ma-

1        rine environment and provide this scientific informa-  
2        tion to Federal and State managers.”.

3        (b) PURPOSE.—Section 802(b) of such Act (16  
4 U.S.C. 5101(b)) is amended to read as follows:

5        “(b) PURPOSE.—The purpose of this title is to sup-  
6 port and encourage the development, implementation, and  
7 enforcement of effective interstate conservation and man-  
8 agement of Atlantic coastal fishery resources through the  
9 use of sound science and multispecies, adaptive, and eco-  
10 system-based management measures.”.

11        (c) STATE-FEDERAL COOPERATION IN MULTISPE-  
12 CIES AND ECOSYSTEMS INTERACTION RESEARCH.—Sec-  
13 tion 804(a) of such Act (16 U.S.C. 5103(a)) is amended  
14 by inserting “multispecies and ecosystems interaction re-  
15 search;” after “biological and socioeconomic research;”.

16        (d) ASSISTANCE FOR RESEARCH REGARDING INTER-  
17 RELATIONSHIPS AMONG ATLANTIC COASTAL FISHERY  
18 RESOURCES AND THEIR ECOSYSTEMS.—Section 808 of  
19 such Act (16 U.S.C. 5107) is amended by striking “and”  
20 after the semicolon at the end of paragraph (1), redesign-  
21 ating paragraph (2) as paragraph (3), and inserting after  
22 paragraph (1) the following:

23                “(2) research to understand the interrelation-  
24 ships among Atlantic coastal fishery resources and  
25 their ecosystems; and”.

8           “SEC. 10. (a) IN GENERAL.—There are authorized
