A BILL

To authorize the Secretary of the Interior to conduct a special resource study of the Lower Los Angeles River

and San Gabriel River watersheds in the State of California, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “San Gabriel River Wa-*
 5 *tersheds Study Act of 2002”.*

6 **SEC. 2. AUTHORIZATION OF STUDY.**

7 (a) *IN GENERAL.*—*The Secretary of the Interior (here-*
 8 *inafter in this Act referred to as the “Secretary”) shall con-*
 9 *duct a special resource study of the following areas:*

10 (1) *The San Gabriel River and its tributaries*
 11 *north of and including the city of Santa Fe Springs.*

12 (2) *The San Gabriel Mountains within the terri-*
 13 *tory of the San Gabriel and Lower Los Angeles Rivers*
 14 *and Mountains Conservancy (as defined in section*
 15 *32603(c)(1)(C) of the State of California Public Re-*
 16 *source Code).*

17 (b) *STUDY CONDUCT AND COMPLETION.*—*Section 8(c)*
 18 *of Public Law 91–383 (16 U.S.C. 1a–5(c)) shall apply to*
 19 *the conduct and completion of the study required by this*
 20 *section.*

21 (c) *CONSULTATION WITH FEDERAL, STATE, AND*
 22 *LOCAL GOVERNMENTS.*—*In conducting the study author-*
 23 *ized by this section, the Secretary shall consult with the San*
 24 *Gabriel and Lower Los Angeles Rivers and Mountains Con-*

1 *servancy and other appropriate Federal, State, and local*
2 *governmental entities.*

3 (d) *CONSIDERATIONS.—In conducting the study au-*
4 *thorized by this section, the Secretary shall consider re-*
5 *gional flood control and drainage needs and publicly owned*
6 *infrastructure, including, but not limited to, wastewater*
7 *treatment facilities.*

8 **SEC. 3. REPORT.**

9 *Not later than 3 years after funds are made available*
10 *for this Act, the Secretary shall submit to the Committee*
11 *on Energy and Natural Resources of the Senate and the*
12 *Committee on Resources of the House of Representatives a*
13 *report on the findings, conclusions, and recommendations*
14 *of the study.*
