## A BILL

To authorize the acquisition of additional lands for inclusion in the Fort Clatsop National Memorial in the State of Oregon, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Fort Clatsop National*  
3 *Memorial Expansion Act of 2002”.*

4 **SEC. 2. FINDINGS.**

5 *The Congress finds the following:*

6 *(1) Fort Clatsop National Memorial is the only*  
7 *unit of the National Park System solely dedicated to*  
8 *the Lewis and Clark Expedition.*

9 *(2) In 1805, the members of the Lewis and Clark*  
10 *Expedition built Fort Clatsop at the mouth of the Co-*  
11 *lumbia River near Astoria, Oregon, and they spent*  
12 *106 days at the fort waiting for the end of winter and*  
13 *preparing for their journey home.*

14 *(3) In 1958, Congress enacted Public Law 85–*  
15 *435 authorizing the establishment of Fort Clatsop Na-*  
16 *tional Memorial for the purpose of commemorating*  
17 *the culmination, and the winter encampment, of the*  
18 *Lewis and Clark Expedition following its successful*  
19 *crossing of the North American continent.*

20 *(4) The 1995 General Management Plan for Fort*  
21 *Clatsop National Memorial, prepared with input*  
22 *from the local community, recommends the expansion*  
23 *of the memorial to include the trail used by expedi-*  
24 *tion members to access the Pacific Ocean from the fort*  
25 *and the shore and forest lands surrounding the fort*  
26 *and trail to protect their natural settings.*

1           (5) *Expansion of Fort Clatsop National Memo-*  
2           *rial requires Federal legislation because the size of the*  
3           *memorial is currently limited by statute to 130 acres.*

4           (6) *Congressional action to allow for the expan-*  
5           *sion of Fort Clatsop National Memorial to include the*  
6           *trail to the Pacific Ocean would be timely and appro-*  
7           *priate before the start of the bicentennial celebration*  
8           *of the Lewis and Clark Expedition planned to take*  
9           *place during the years 2004 through 2006.*

10 **SEC. 3. EXPANSION OF FORT CLATSOP NATIONAL MEMO-**  
11 **RIAL, OREGON.**

12           (a) *REVISED BOUNDARIES.*—Section 2 of Public Law  
13 85–435 (16 U.S.C. 450mm–1) is amended—

14           (1) by inserting “(a) *INITIAL DESIGNATION OF*  
15           *LANDS.*—” before “The Secretary”;

16           (2) by striking “coast:” and all that follows  
17           through the end of the sentence and inserting “coast.”;  
18           and

19           (3) by adding at the end the following new sub-  
20           sections:

21           “(b) *AUTHORIZED EXPANSION.*—The Fort Clatsop Na-  
22           tional Memorial shall also include the lands depicted on  
23           the map entitled ‘Fort Clatsop Boundary Map’, numbered  
24           ‘405–80026C–CCO’, and dated June 1996.

1       “(c) *MAXIMUM DESIGNATED AREA.*—*The total area*  
2 *designated as the Fort Clatsop National Memorial shall not*  
3 *exceed 1,500 acres.*”.

4       (b) *AUTHORIZED ACQUISITION METHODS.*—*Section 3*  
5 *of Public Law 85–435 (16 U.S.C. 450mm–2) is amended—*

6           (1) *by inserting “(a) ACQUISITION METH-*  
7 *ODS.—” before “Within”; and*

8           (2) *by adding at the end the following new sub-*  
9 *section:*

10       “(b) *LIMITATION.*—*The lands (other than corporately*  
11 *owned timberlands) depicted on the map referred to in sec-*  
12 *tion 2(b) may be acquired by the Secretary of the Interior*  
13 *only by donation or purchase from willing sellers.*”.

14       (c) *MEMORANDUM OF UNDERSTANDING.*—*Section 4 of*  
15 *Public Law 85–435 (16 U.S.C. 450mm–3) is amended—*

16           (1) *by striking “Establishment” and all that fol-*  
17 *lows through “its establishment,” and inserting “(a)*  
18 *ADMINISTRATION.—”; and*

19           (2) *by adding at the end the following new sub-*  
20 *section:*

21       “(b) *MEMORANDUM OF UNDERSTANDING.*—*If the*  
22 *owner of corporately owned timberlands depicted on the*  
23 *map referred to in section 2(b) agrees to enter into a sale*  
24 *of such lands as a result of actual condemnation pro-*  
25 *ceedings or in lieu of condemnation proceedings, the Sec-*

1 *retary of the Interior shall enter into a memorandum of*  
2 *understanding with the owner regarding the manner in*  
3 *which such lands will be managed after acquisition by the*  
4 *United States.”.*

5 **SEC. 4. STUDY OF STATION CAMP SITE AND OTHER AREAS**  
6 **FOR POSSIBLE INCLUSION IN NATIONAL ME-**  
7 **MORIAL.**

8 *The Secretary of the Interior shall conduct a study of*  
9 *the area near McGowan, Washington, where the Lewis and*  
10 *Clark Expedition first camped after reaching the Pacific*  
11 *Ocean and known as the “Station Camp” site, as well as*  
12 *the Megler Rest Area and Fort Canby State Park, to deter-*  
13 *mine the suitability, feasibility, and national significance*  
14 *of these sites for inclusion in the National Park System.*  
15 *The study shall be conducted in accordance with section 8*  
16 *of Public Law 91–383 (16 U.S.C. 1a–5).*
