AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2002, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 Legislative Branch for the fiscal year ending September
6 30, 2002, and for other purposes, namely:

7 TITLE I—CONGRESSIONAL OPERATIONS

25 *For Senators' Official Personnel and Office Expense*
26 *Account, \$270,494,000.*

1 (1) *EMPLOYEE OF THE SENATE.*—The term “em-
2 ployee of the Senate” has the meaning given the term
3 in section 101 of the Congressional Accountability Act
4 of 1995 (2 U.S.C. 1301).

5 (2) *EMPLOYING OFFICE.*—The term “employing
6 office” means the employing office, as defined in such
7 section 101, of an employee of the Senate.

8 (3) *STUDENT LOAN.*—The term “student loan”
9 has the meaning given the term in section 5379 of
10 title 5, United States Code.

11 (b) *STUDENT LOAN REPAYMENT PROGRAM.*—The head
12 of an employing office may, in order to recruit or retain
13 highly qualified personnel, establish a program under which
14 the office may agree to repay (by direct payments on behalf
15 of an employee of the Senate) any student loan previously
16 taken out by such employee.

17 (c) *ADMINISTRATION.*—

18 (1) *IN GENERAL.*—The head of an employing of-
19 fice shall carry out the program in accordance with
20 the provisions of subsections (b) through (d) and sub-
21 section (f) of section 5379 of title 5, United States
22 Code.

23 (2) *APPLICATION.*—For purposes of this section,
24 references in such provisions—

1 (A) to an agency shall be considered to be
2 references to an employing office; and

3 (B) to an employee shall be considered to be
4 references to an employee of the Senate.

5 (d) *AUTHORIZATION OF APPROPRIATIONS.*—There are
6 authorized to be appropriated to carry out this section such
7 sums as may be necessary.

8 (e) *EFFECTIVE DATE.*—This section shall apply to fis-
9 cal year 2002 and each fiscal year thereafter.

10 *SEC. 3. (a) Agency contributions for employees whose*
11 *salaries are disbursed by the Secretary of the Senate from*
12 *the appropriations account “Expenses of the United States*
13 *Senate Caucus on International Narcotics Control” under*
14 *the heading “Congressional Operations” shall be paid from*
15 *the Senate appropriations account for “Salaries, Officers*
16 *and Employees”.*

17 (b) *This section shall apply to pay periods beginning*
18 *on or after October 1, 2001.*

19 *SEC. 4. (a) Section 5(a) under the subheading “ADMIN-*
20 *ISTRATIVE PROVISIONS” under the heading “SENATE”*
21 *under title I of the Legislative Branch Appropriations Act,*
22 *1996 (2 U.S.C. 58a note) is amended by striking “invoice*
23 *ends” and inserting “invoice begins”.*

1 (b) *The amendment made by subsection (a) shall take*
2 *effect on October 1, 2001, and shall apply to base service*
3 *periods beginning on or after that date.*

4 *SEC. 5. (a) Section 120 of Public Law 97–51 (2 U.S.C.*
5 *61g–6) is amended in the first sentence by striking*
6 *“\$75,000” and inserting “\$100,000”.*

7 (b) *This section shall apply with respect to fiscal year*
8 *2002 and each fiscal year thereafter.*

9 *SEC. 6. Effective on and after October 1, 2001, each*
10 *of the dollar amounts contained in the table under section*
11 *105(d)(1)(A) of the Legislative Branch Appropriations Act,*
12 *1968 (2 U.S.C. 61–1(d)(1)(A)) shall be deemed to be the*
13 *dollar amounts in that table, as adjusted by law and in*
14 *effect on September 30, 2001, increased by an additional*
15 *\$50,000 each.*

21 For salaries and expenses, as authorized by law,
22 \$15,910,000, including: Office of the Speaker,
23 \$1,866,000, including \$25,000 for official expenses of the
24 Speaker; Office of the Majority Floor Leader, \$1,830,000,
25 including \$10,000 for official expenses of the Majority

1 Leader; Office of the Minority Floor Leader, \$2,224,000,
2 including \$10,000 for official expenses of the Minority
3 Leader; Office of the Majority Whip, including the Chief
4 Deputy Majority Whip, \$1,562,000, including \$5,000 for
5 official expenses of the Majority Whip; Office of the Mi-
6 nority Whip, including the Chief Deputy Minority Whip,
7 \$1,168,000, including \$5,000 for official expenses of the
8 Minority Whip; Speaker's Office for Legislative Floor Ac-
9 tivities, \$431,000; Republican Steering Committee,
10 \$806,000; Republican Conference, \$1,342,000; Demo-
11 cratic Steering and Policy Committee, \$1,435,000; Demo-
12 cratic Caucus, \$713,000; nine minority employees,
13 \$1,293,000; training and program development—major-
14 ity, \$290,000; training and program development—minor-
15 ity, \$290,000; and Cloakroom Personnel—majority,
16 \$330,000; and minority \$330,000.

17 MEMBERS' REPRESENTATIONAL ALLOWANCES
18 INCLUDING MEMBERS' CLERK HIRE, OFFICIAL
19 EXPENSES OF MEMBERS, AND OFFICIAL MAIL

20 For Members' representational allowances, including
21 Members' clerk hire, official expenses, and official mail,
22 \$479,472,000.

1 COMMITTEE EMPLOYEES

2 STANDING COMMITTEES, SPECIAL AND SELECT

3 For salaries and expenses of standing committees,
4 special and select, authorized by House resolutions,
5 \$104,514,000: *Provided*, That such amount shall remain
6 available for such salaries and expenses until December
7 31, 2002.

8 COMMITTEE ON APPROPRIATIONS

9 For salaries and expenses of the Committee on Ap-
10 propriations, \$23,002,000, including studies and examina-
11 tions of executive agencies and temporary personal serv-
12 ices for such committee, to be expended in accordance with
13 section 202(b) of the Legislative Reorganization Act of
14 1946 and to be available for reimbursement to agencies
15 for services performed: *Provided*, That such amount shall
16 remain available for such salaries and expenses until De-
17 cember 31, 2002.

18 SALARIES, OFFICERS AND EMPLOYEES

19 For compensation and expenses of officers and em-
20 ployees, as authorized by law, \$101,766,000, including:
21 for salaries and expenses of the Office of the Clerk, includ-
22 ing not more than \$11,000, of which not more than
23 \$10,000 is for the Family Room, for official representa-
24 tion and reception expenses, \$15,408,000; for salaries and
25 expenses of the Office of the Sergeant at Arms, including

1 the position of Superintendent of Garages, and including
2 not more than \$750 for official representation and recep-
3 tion expenses, \$4,139,000; for salaries and expenses of the
4 Office of the Chief Administrative Officer, \$67,495,000,
5 of which \$3,525,000 shall remain available until expended,
6 including \$31,510,000 for salaries, expenses and tem-
7 porary personal services of House Information Resources,
8 of which \$31,390,000 is provided herein: *Provided*, That
9 of the amount provided for House Information Resources,
10 \$8,656,000 shall be for net expenses of telecommuni-
11 cations: *Provided further*, That House Information Re-
12 sources is authorized to receive reimbursement from Mem-
13 bers of the House of Representatives and other govern-
14 mental entities for services provided and such reimburse-
15 ment shall be deposited in the Treasury for credit to this
16 account; for salaries and expenses of the Office of the In-
17 spector General, \$3,756,000; for salaries and expenses of
18 the Office of General Counsel, \$894,000; for the Office
19 of the Chaplain, \$144,000; for salaries and expenses of
20 the Office of the Parliamentarian, including the Parlia-
21 mentarian and \$2,000 for preparing the Digest of Rules,
22 \$1,344,000; for salaries and expenses of the Office of the
23 Law Revision Counsel of the House, \$2,107,000; for sala-
24 ries and expenses of the Office of the Legislative Counsel
25 of the House, \$5,456,000; for salaries and expenses of the

1 Corrections Calendar Office, \$883,000; and for other au-
2 thorized employees, \$140,000.

3 ALLOWANCES AND EXPENSES

4 For allowances and expenses as authorized by House
5 resolution or law, \$157,436,000, including: supplies, mate-
6 rials, administrative costs and Federal tort claims,
7 \$3,379,000; official mail for committees, leadership of-
8 fices, and administrative offices of the House, \$410,000;
9 Government contributions for health, retirement, Social
10 Security, and other applicable employee benefits,
11 \$152,957,000; and miscellaneous items including pur-
12 chase, exchange, maintenance, repair and operation of
13 House motor vehicles, interparliamentary receptions, and
14 gratuities to heirs of deceased employees of the House,
15 \$690,000.

16 CHILD CARE CENTER

17 For salaries and expenses of the House of Represent-
18 atives Child Care Center, such amounts as are deposited
19 in the account established by section 312(d)(1) of the Leg-
20 islative Branch Appropriations Act, 1992 (40 U.S.C.
21 184g(d)(1)), subject to the level specified in the budget
22 of the Center, as submitted to the Committee on Appro-
23 priations of the House of Representatives.

1 ADMINISTRATIVE PROVISIONS

2 SEC. 101. (a) Effective October 1, 2001, the fol-
3 lowing four majority positions shall be transferred from
4 the Clerk to the Speaker:

5 (1) The position of chief of floor service.

6 (2) Two positions of assistant floor chief.

7 (3) One position of cloakroom attendant.

8 (b) Effective October 1, 2001, the following four mi-
9 nority positions shall be transferred from the Clerk to the
10 minority leader:

11 (1) The position of chief of floor service.

12 (2) Two positions of assistant floor chief.

13 (3) One position of cloakroom attendant.

14 (c) Each individual who is an incumbent of a position
15 transferred by subsection (a) or subsection (b) at the time
16 of the transfer shall remain subject to the House Employ-
17 ees Position Classification Act (2 U.S.C. 290 et seq.), ex-
18 cept that the authority of the Clerk and the committee
19 under the Act shall be exercised—

20 (1) by the Speaker, in the case of an individual
21 in a position transferred under subsection (a); and

22 (2) by the minority leader, in the case of an in-
23 dividual in a position transferred under subsection
24 (b).

1 SEC. 102. (a) The third sentence of section 104(a)(1)
2 of the Legislative Branch Appropriations Act, 1987 (as
3 incorporated by reference in section 101(j) of Public Law
4 99–500 and Public Law 99–591) (2 U.S.C. 117e(1)) is
5 amended by striking “for credit to the appropriate ac-
6 count” and all that follows and inserting the following:
7 “for credit to the appropriate account of the House of
8 Representatives, and shall be available for expenditure in
9 accordance with applicable law. For purposes of the pre-
10 vious sentence, in the case of receipts from the sale or
11 disposal of any audio or video transcripts prepared by the
12 House Recording Studio, the ‘appropriate account of the
13 House of Representatives’ shall be the account of the
14 Chief Administrative Officer of the House of Representa-
15 tives.”.

16 (b) The amendment made by subsection (a) shall
17 apply with respect to fiscal year 2002 and each succeeding
18 fiscal year.

19 SEC. 103. (a) REQUIRING AMOUNTS REMAINING IN
20 MEMBERS’ REPRESENTATIONAL ALLOWANCES TO BE
21 USED FOR DEFICIT REDUCTION OR TO REDUCE THE
22 FEDERAL DEBT.—Notwithstanding any other provision of
23 law, any amounts appropriated under this Act for
24 “HOUSE OF REPRESENTATIVES—SALARIES AND
25 EXPENSES—MEMBERS’ REPRESENTATIONAL ALLOW-

1 ANCES” shall be available only for fiscal year 2002. Any
2 amount remaining after all payments are made under such
3 allowances for fiscal year 2002 shall be deposited in the
4 Treasury and used for deficit reduction (or, if there is no
5 Federal budget deficit after all such payments have been
6 made, for reducing the Federal debt, in such manner as
7 the Secretary of the Treasury considers appropriate).

8 (b) REGULATIONS.—The Committee on House Ad-
9 ministration of the House of Representatives shall have
10 authority to prescribe regulations to carry out this section.

11 (c) DEFINITION.—As used in this section, the term
12 “Member of the House of Representatives” means a Rep-
13 resentative in, or a Delegate or Resident Commissioner
14 to, the Congress.

15 SEC. 104. (a) DAY FOR PAYING SALARIES OF THE
16 HOUSE OF REPRESENTATIVES.—The usual day for paying
17 salaries in or under the House of Representatives shall
18 be the last day of each month, except that if the last day
19 of a month falls on a Saturday, Sunday, or a legal public
20 holiday, the Chief Administrative Officer of the House of
21 Representatives shall pay such salaries on the first week-
22 day which precedes the last day.

23 (b) CONFORMING AMENDMENT.—(1) The first sec-
24 tion and section 2 of the Joint Resolution entitled “Joint
25 resolution authorizing the payment of salaries of the offi-

1 cers and employees of Congress for December on the 20th
 2 day of that month each year”, approved May 21, 1937
 3 (2 U.S.C. 60d and 60e), are each repealed.

4 (2) The last paragraph under the heading “Conti-
 5 gent Expense of the House” in the First Deficiency Ap-
 6 propriation Act, 1946 (2 U.S.C. 60e-1), is repealed.

7 (c) EFFECTIVE DATE.—This section and the amend-
 8 ments made by this section shall apply with respect to pay
 9 periods beginning after the expiration of the 1-year period
 10 which begins on the date of the enactment of this Act.

11 (2) JOINT ITEMS

12 For Joint Committees, as follows:

13 JOINT ECONOMIC COMMITTEE

14 For salaries and expenses of the Joint Economic
 15 Committee, \$3,424,000, to be disbursed by the Secretary
 16 of the Senate.

17 JOINT COMMITTEE ON TAXATION

18 For salaries and expenses of the Joint Committee on
 19 Taxation, \$6,733,000, to be disbursed by the Chief Ad-
 20 ministrative Officer of the House.

21 For other joint items, as follows:

22 OFFICE OF THE ATTENDING PHYSICIAN

23 For medical supplies, equipment, and contingent ex-
 24 penses of the emergency rooms, and for the Attending
 25 Physician and his assistants, including: (1) an allowance

1 of \$1,500 per month to the Attending Physician; (2) an
 2 allowance of \$500 per month each to three medical officers
 3 while on duty in the Office of the Attending Physician;
 4 (3) an allowance of \$500 per month to two assistants and
 5 \$400 per month each not to exceed 11 assistants on the
 6 basis heretofore provided for such assistants; and (4)
 7 \$1,253,904 for reimbursement to the Department of the
 8 Navy for expenses incurred for staff and equipment as-
 9 signed to the Office of the Attending Physician, which
 10 shall be advanced and credited to the applicable appropria-
 11 tion or appropriations from which such salaries, allow-
 12 ances, and other expenses are payable and shall be avail-
 13 able for all the purposes thereof, \$1,865,000, to be dis-
 14 bursed by the Chief Administrative Officer of the House
 15 of Representatives.

16 CAPITOL POLICE BOARD

17 CAPITOL POLICE

18 SALARIES

19 For the Capitol Police Board for salaries of officers,
 20 members, and employees of the Capitol Police, including
 21 overtime, hazardous duty pay differential, clothing allow-
 22 ance of not more than \$600 each for members required
 23 to wear civilian attire, and Government contributions for
 24 health, retirement, Social Security, and other applicable
 25 employee benefits, \$112,592,000, of which \$55,013,000 is

1 of the Senate or the Sergeant at Arms of the House of
2 Representatives designated by the Chairman of the Board,
3 \$11,081,000, to be disbursed by the Chief of the Capitol
4 Police or the Chief's delegee: *Provided*, That, notwith-
5 standing any other provision of law, the cost of basic train-
6 ing for the Capitol Police at the Federal Law Enforcement
7 Training Center for fiscal year 2002 shall be paid by the
8 Secretary of the Treasury from funds available to the De-
9 partment of the Treasury.

10 ADMINISTRATIVE PROVISIONS

11 SEC. 105. Amounts appropriated for fiscal year 2002
12 for the Capitol Police may be transferred between the
13 headings "SALARIES" and "GENERAL EXPENSES" upon
14 the approval of—

15 (1) the Committee on Appropriations of the
16 House of Representatives, in the case of amounts
17 transferred from the appropriation provided to the
18 Sergeant at Arms of the House of Representatives
19 under the heading "SALARIES";

20 (2) the Committee on Appropriations of the
21 Senate, in the case of amounts transferred from the
22 appropriation provided to the Sergeant at Arms and
23 Doorkeeper of the Senate under the heading "SALA-
24 RIES"; and

1 OFFICE OF COMPLIANCE

2 SALARIES AND EXPENSES

3 For salaries and expenses of the Office of Compli-
4 ance, as authorized by section 305 of the Congressional
5 Accountability Act of 1995 (2 U.S.C. 1385), \$2,059,000,
6 of which \$254,000 shall remain available until September
7 30, 2003.

8 CONGRESSIONAL BUDGET OFFICE

9 SALARIES AND EXPENSES

10 For salaries and expenses necessary to carry out the
11 provisions of the Congressional Budget Act of 1974 (Pub-
12 lic Law 93-344), including not more than \$3,000 to be
13 expended on the certification of the Director of the Con-
14 gressional Budget Office in connection with official rep-
15 resentation and reception expenses, \$30,780,000: *Pro-*
16 *vided*, That no part of such amount may be used for the
17 purchase or hire of a passenger motor vehicle.

18 ADMINISTRATIVE PROVISIONS

19 SEC. 106. (a) The Director of the Congressional
20 Budget Office may, by regulation, make applicable such
21 provisions of chapter 41 of title 5, United States Code,
22 as the Director determines necessary to provide hereafter
23 for training of individuals employed by the Congressional
24 Budget Office.

1 (b) The implementing regulations shall provide for
 2 training that, in the determination of the Director, is con-
 3 sistent with the training provided by agencies subject to
 4 chapter 41 of title 5, United States Code.

5 (c) Any recovery of debt owed to the Congressional
 6 Budget Office under this section and its implementing reg-
 7 ulations shall be credited to the appropriations account
 8 available for salaries and expenses of the Office at the time
 9 of recovery.

10 SEC. 107. Section 105(a) of the Legislative Branch
 11 Appropriations Act, 1997 (2 U.S.C. 606(a)), is amended
 12 by striking “or discarding.” and inserting “sale, trade-in,
 13 or discarding.”, and by adding at the end the following:
