A BILL

To direct the Secretary of Transportation to make grants for security improvements to over-the-road bus operations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Over-the-Road Bus Se-*
5 *curity and Safety Act of 2002”.*

6 **SEC. 2. EMERGENCY OVER-THE-ROAD BUS SECURITY AS-**
7 **SISTANCE.**

8 *(a) IN GENERAL.—The Secretary of Transportation*
9 *may make grants to private operators of over-the-road buses*
10 *for system-wide security improvements to their operations,*
11 *including the reimbursement of extraordinary security-re-*
12 *lated costs determined by the Secretary to have been in-*
13 *curred by such operators since September 11, 2001, and*
14 *including—*

15 *(1) constructing and modifying garages, facili-*
16 *ties, or over-the-road buses to assure their security;*

17 *(2) acquiring, upgrading, installing, or oper-*
18 *ating equipment, software, or accessorial services for*
19 *collection, storage, or exchange of passenger and driv-*
20 *er information through ticketing systems or otherwise,*
21 *and information links with government agencies;*

22 *(3) training employees in recognizing and re-*
23 *sponding to terrorist threats, evacuation procedures,*
24 *passenger screening procedures, and baggage inspec-*
25 *tion;*

1 (4) *hiring and training security officers or “bus*
2 *marshals”*;

3 (5) *installing cameras and video surveillance*
4 *equipment on over-the-road buses and at garages and*
5 *over-the-road bus facilities*;

6 (6) *creating a program for employee identifica-*
7 *tion or background investigation*;

8 (7) *establishing an emergency communications*
9 *system linked to police and emergency personnel*; and

10 (8) *implementing and operating passenger*
11 *screening programs at terminals and on over-the-road*
12 *buses.*

13 (b) *FEDERAL SHARE.*—*The Federal share of the cost*
14 *for which any grant is made under this Act shall be 90*
15 *percent.*

16 (c) *PRIORITY.*—*In making grants under this Act, the*
17 *Secretary shall give priority to private operators of over-*
18 *the-road buses that have increased fares, or realigned budget*
19 *priorities, to enhance bus transportation security from those*
20 *in effect in calendar year 2001.*

21 (d) *GRANT REQUIREMENTS.*—*A grant under this Act*
22 *shall be subject to all the terms and conditions that a grant*
23 *is subject to under section 3038(f) of the Transportation Eq-*
24 *uity Act for the 21st Century (49 U.S.C. 5310 note; 112*
25 *Stat. 393).*

1 **SEC. 3. PLAN REQUIREMENT.**

2 (a) *IN GENERAL.*—*The Secretary may not make a*
3 *grant under this Act to a private operator of over-the-road*
4 *buses until the operator has first submitted to the*
5 *Secretary—*

6 (1) *a plan of the operator for making security*
7 *improvements described in section 2 and the Sec-*
8 *retary has approved the plan; and*

9 (2) *such additional information as the Secretary*
10 *may require to ensure accountability for the obliga-*
11 *tion and expenditure of amounts made available to*
12 *the operator under the grant.*

13 (b) *COORDINATION.*—*An application for a grant under*
14 *section 2 for security improvements within a terminal*
15 *owned and operated by a port authority shall demonstrate*
16 *to the satisfaction of the Secretary that the applicant has*
17 *coordinated its security plan for the terminal with the port*
18 *authority.*

19 **SEC. 4. OVER-THE-ROAD BUS DEFINED.**

20 *In this Act, the term “over-the-road bus” means a bus*
21 *characterized by an elevated passenger deck located over a*
22 *baggage compartment.*

23 **SEC. 5. FUNDING.**

24 *There is authorized to be appropriated to the Secretary*
25 *of Transportation to carry out this Act \$200,000,000 for*

- 1 *each of fiscal years 2002 through 2004. Such sums shall*
- 2 *remain available until expended.*
