A BILL

To designate certain lands in the State of Colorado as components of the National Wilderness Preservation System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE AND DEFINITIONS.**

4 (a) SHORT TITLE.—This Act may be cited as the
5 “Colorado Wilderness Act of 2002”.

6 (b) DEFINITIONS.—As used in this Act, the term
7 “Secretary” means the Secretary of the Interior or the
8 Secretary of Agriculture, as appropriate.

1 **SEC. 2. ADDITIONS TO THE WILDERNESS PRESERVATION**
2 **SYSTEM.**

3 (a) ADDITIONS.—The following lands in the State of
4 Colorado administered by the Bureau of Land Manage-
5 ment or the United States Forest Service are hereby des-
6 ignated as wilderness and, therefore, as components of the
7 National Wilderness Preservation System:

8 (1) The following areas in the Glenwood
9 Springs Resource Area:

10 (A) Certain lands which comprise approxi-
11 mately 40,494 acres, as generally depicted on a
12 map entitled “Roan Plateau Wilderness Pro-
13 posal” dated March 22, 2002, which shall be
14 known as the Roan Plateau Wilderness.

15 (B) Certain lands which comprise approxi-
16 mately 15,155 acres, as generally depicted on a
17 map entitled “Bull Gulch Wilderness Proposal”
18 dated March 22, 2002, which shall be known as
19 the Bull Gulch Wilderness.

20 (C) Certain lands which comprise approxi-
21 mately 16,263 acres, as generally depicted on a
22 map entitled “Castle Peak Wilderness Pro-
23 posal” dated March 22, 2002, which shall be
24 known as the Castle Peak Wilderness.

25 (D) Certain lands which comprise approxi-
26 mately 316 acres, as generally depicted on a

1 map entitled “Maroon Bells Snowmass Wilder-
2 ness Proposal” dated March 22, 2002, which
3 shall be known as the Maroon Bells Wilderness.

4 (E) Certain lands which comprise approxi-
5 mately 11,701 acres, as generally depicted on a
6 map entitled “Grand Hogback Wilderness Pro-
7 posal” dated March 22, 2002, which shall be
8 known as the Grand Hogback Wilderness.

9 (2) The following areas in the Glenwood
10 Springs Resource Area and the White River Na-
11 tional Forest:

12 (A) Certain lands which comprise approxi-
13 mately 20,843 acres, as generally depicted on a
14 map entitled “Deep Creek Wilderness Pro-
15 posal”, dated March 22, 2002, which shall be
16 known as the Deep Creek Wilderness.

17 (B) Certain lands which comprise approxi-
18 mately 13,286 acres, as generally depicted on a
19 map entitled “Flat Tops Addition Wilderness
20 Proposal”, dated March 22, 2002, and which
21 are hereby incorporated in and shall be deemed
22 to be a part of the Flat Tops Wilderness des-
23 ignated by Public Law 94-146.

24 (C) Certain lands which comprise approxi-
25 mately 25,285 acres, as generally depicted on a

1 map entitled “Thompson Creek Wilderness Pro-
2 posal”, dated March 22, 2002, which shall be
3 known as the Thompson Creek Wilderness.

4 (3) The following lands in the Grand Junction
5 Resource Area:

6 (A) Certain lands which comprise approxi-
7 mately 21,110 acres, as generally depicted on a
8 map entitled “Bangs Canyon Wilderness Pro-
9 posal”, dated March 22, 2002, which shall be
10 known as the Bangs Canyon Wilderness.

11 (B) Certain lands which comprise approxi-
12 mately 25,881 acres, as generally depicted on a
13 map entitled “Demaree Canyon Wilderness Pro-
14 posal”, dated March 22, 2002, which shall be
15 known as the Demaree Canyon Wilderness.

16 (C) Certain lands which comprise approxi-
17 mately 15,702 acres, as generally depicted on a
18 map entitled “Cow Ridge Wilderness Proposal”,
19 dated March 22, 2002, which shall be known as
20 the Cow Ridge Wilderness.

21 (D) Certain lands which comprise approxi-
22 mately 14,090 acres, as generally depicted on a
23 map entitled “Granite Creek Wilderness Pro-
24 posal”, dated March 22, 2002, which shall be
25 known as the Granite Creek Wilderness.

1 (E) Certain lands which comprise approxi-
2 mately 12,429 acres, as generally depicted on a
3 map entitled “Gunnison River Wilderness Pro-
4 posal”, dated March 22, 2002, which shall be
5 known as the Gunnison River Wilderness.

6 (F) Certain lands which comprise approxi-
7 mately 32,126 acres, as generally depicted on a
8 map entitled “Hunter Canyon Wilderness Pro-
9 posal”, dated March 22, 2002, which shall be
10 known as the Hunter Canyon Wilderness.

11 (G) Certain lands which comprise approxi-
12 mately 7,649 acres, as generally depicted on a
13 map entitled “Kings Canyon Wilderness Pro-
14 posal”, dated March 22, 2002, which shall be
15 known as the Kings Canyon Wilderness.

16 (H) Certain lands which comprise approxi-
17 mately 30,551 acres, as generally depicted on a
18 map entitled “Little Bookcliffs Wilderness Pro-
19 posal”, dated March 22, 2002, which shall be
20 known as the Little Bookcliffs Wilderness.

21 (I) Certain lands which comprise approxi-
22 mately 20,585 acres, as generally depicted on a
23 map entitled “Maverick Canyon Wilderness
24 Proposal”, dated March 22, 2002, which shall
25 be known as Maverick Canyon Wilderness.

1 (J) Certain lands which comprise approxi-
2 mately 26,914 acres, as generally depicted on a
3 map entitled “The Palisade Wilderness Pro-
4 posal”, dated March 22, 2002, which shall be
5 known as The Palisade Wilderness.

6 (K) Certain lands which comprise approxi-
7 mately 18,687 acres, as generally depicted on a
8 map entitled “Prairie Canyon”, dated March
9 22, 2002, which shall be known as Prairie Can-
10 yon Wilderness.

11 (L) Certain lands which comprise approxi-
12 mately 5,142 acres, as generally depicted on a
13 map entitled “Sagebrush Pillows Wilderness
14 Proposal”, dated March 22, 2002, which shall
15 be known as the Sagebrush Pillows Wilderness.

16 (M) Certain lands which comprise approxi-
17 mately 27,569 acres, as generally depicted on a
18 map entitled “South Shale Ridge Wilderness
19 Proposal”, dated March 22, 2002, which shall
20 be known as the South Shale Ridge Wilderness.

21 (4) Certain lands in the Grand Junction and
22 Uncompahgre Resource Areas and the Uncompahgre
23 National Forest which comprise approximately
24 84,635 acres, as generally depicted on a map enti-
25 tled “Dominguez Canyons Wilderness Proposal”,

1 dated March 22, 2002, which shall be known as the
2 Dominguez Canyons Wilderness.

3 (5) Certain lands in the Grand Junction Re-
4 source Area and the Uncompahgre National Forest
5 which comprise approximately 39,144 acres, as gen-
6 erally depicted on a map entitled “Unaweep Wilder-
7 ness Proposal”, dated March 22, 2002, which shall
8 be known as the Unaweep Wilderness.

9 (6) Certain lands in the Grand Junction Re-
10 source Area, the San Juan Resource Area, and the
11 Manti-LaSal National Forest which comprise ap-
12 proximately 65,448 acres, as generally depicted on a
13 map entitled “Sewemup Mesa Wilderness Proposal”,
14 dated March 22, 2002, which shall be known as the
15 Sewemup Mesa Wilderness.

16 (7) The following lands in the Gunnison Re-
17 source Area:

18 (A) Certain lands in the Gunnison Re-
19 source Area which comprise approximately
20 3,388 acres, as generally depicted on a map en-
21 titled “Powderhorn Additions Wilderness Pro-
22 posal”, dated March 22, 2002, and which are
23 hereby incorporated in and shall be deemed to
24 be a part of the Powderhorn Wilderness des-
25 ignated by Public Law 103–77.

1 (B) Certain lands in the Gunnison Re-
2 source Area which comprise approximately
3 38,594 acres, as generally depicted on a map
4 entitled “Redcloud Peak Wilderness Proposal”,
5 dated March 22, 2002, which shall be known as
6 the Redcloud Peak Wilderness.

7 (C) Certain lands which comprise approxi-
8 mately 6,878 acres, as generally depicted on a
9 map entitled “West Elk Addition Wilderness
10 Proposal”, dated March 22, 2002, and which
11 are hereby incorporated in and shall be deemed
12 to be a part of the West Elk Wilderness des-
13 ignated by Public Law 88–577.

14 (8) Certain lands in the Gunnison Resource
15 Area and the Gunnison National Forest and Rio
16 Grande National Forest which comprise approxi-
17 mately 72,397 acres, as generally depicted on a map
18 entitled “Handies Peak Wilderness Proposal”, dated
19 March 22, 2002, which shall be known as the
20 Handies Peak Wilderness.

21 (9) Certain lands in the Kremmling Resource
22 Area which comprise approximately 33 acres, as
23 generally depicted on a map entitled “Platte River
24 Addition Wilderness Proposal”, dated March 22,
25 2002, and which are hereby incorporated in and

1 shall be deemed to be part of the Platte River Wil-
2 derness designated by Public Law 98–550.

3 (10) Certain lands in the Kremmling Resource
4 Area, the Arapaho National Forest, and the Routt
5 National Forest which comprise approximately
6 119,688 acres, as generally depicted on a map enti-
7 tled “Troublesome Wilderness Proposal”, dated
8 March 22, 2002, which shall be known as the Trou-
9 blesome Wilderness.

10 (11) Certain lands in the Royal Gorge Resource
11 Area and the Pike National Forest which comprise
12 approximately 24,464 acres, as generally depicted on
13 a map entitled “Browns Canyon Wilderness Pro-
14 posal”, dated March 22, 2002, which shall be known
15 as the Browns Canyon Wilderness.

16 (12) Certain lands in the Uncompahgre Re-
17 source Area and the Grand Mesa National Forest
18 which comprise approximately 10,742 acres as gen-
19 erally depicted on a map entitled “Adobe Badlands
20 Wilderness Area Proposal”, dated March 22, 2002,
21 which shall be known as the Adobe Badlands Wil-
22 derness.

23 (13) Certain lands in the Uncompahgre Re-
24 source Area and the Uncompahgre National Forest
25 which comprise approximately 14,503 acres, as gen-

1 erally depicted on a map entitled “Roubideau Addi-
2 tion Wilderness Proposal”, dated March 22, 2002,
3 which shall be known as the Roubideau Wilderness.

4 (14) The following areas in the San Juan Re-
5 source Area:

6 (A) Certain lands which comprise approxi-
7 mately 25,947 acres, as generally depicted on a
8 map entitled “Cross Canyon Wilderness Pro-
9 posal” dated March 22, 2002, which shall be
10 known as the Cross Canyon Wilderness.

11 (B) Certain lands which comprise approxi-
12 mately 41,133 acres, as generally depicted on a
13 map entitled “Dolores River Canyon Wilderness
14 Proposal”, dated March 22, 2002, which shall
15 be known as the Dolores River Canyon Wilder-
16 ness.

17 (C) Certain lands which comprise approxi-
18 mately 4,809 acres, as generally depicted on a
19 map entitled “Mares Tail Canyon Wilderness
20 Proposal” dated March 22, 2002, which shall
21 be known as the Mares Tail Wilderness.

22 (D) Certain lands which comprise approxi-
23 mately 33,467 acres, as generally depicted on a
24 map entitled “McKenna Peak Wilderness Pro-

1 posal” dated March 22, 2002, which shall be
2 known as the McKenna Peak Wilderness.

3 (E) Certain lands which comprise approxi-
4 mately 23,536 acres, as generally depicted on a
5 map entitled “San Luis Hills Wilderness Pro-
6 posal” dated March 22, 2002, which shall be
7 known as the San Luis Hills Wilderness.

8 (F) Certain lands which comprise approxi-
9 mately 14,598 acres, as generally depicted on a
10 map entitled “Weber-Menefee Mountain Wilder-
11 ness Proposal” dated March 22, 2002, which
12 shall be known as the Weber-Menefee Mountain
13 Wilderness.

14 (15) The following areas in the Little Snake
15 Resource Area:

16 (A) Certain lands which comprise approxi-
17 mately 50,543 acres, as generally depicted on a
18 map entitled “Cold Spring Mountain Wilder-
19 ness Proposal”, dated March 22, 2002, which
20 shall be known as the Cold Spring Mountain
21 Wilderness.

22 (B) Certain lands which comprise approxi-
23 mately 18,071 acres, as generally depicted on a
24 map entitled “Cross Mountain Wilderness Pro-

1 posals” dated March 22, 2002, which shall be
2 known as the Cross Mountain Wilderness.

3 (C) Certain lands which comprise approxi-
4 mately 34,010 acres, as generally depicted on a
5 map entitled “Diamond Breaks Wilderness Pro-
6 posal”, dated March 22, 2002, which shall be
7 known as the Diamond Breaks Wilderness.

8 (D) Certain lands which comprise approxi-
9 mately 6,753 acres, as generally depicted on a
10 map entitled “Dragon Canyon Wilderness Pro-
11 posal”, dated March 22, 2002, which shall be
12 known as the Dragon Canyon Wilderness.

13 (E) Certain lands which comprise approxi-
14 mately 56,249 acres, as generally depicted on a
15 map entitled “Dinosaur Adjacent Wilderness
16 Proposal” dated March 22, 2002, which shall
17 be known as the Dinosaur Wilderness.

18 (F) Certain lands which comprise approxi-
19 mately 86,569 acres, as generally depicted on a
20 map entitled “Vermillion Basin Wilderness Pro-
21 posal”, dated March 22, 2002, which shall be
22 known as the Vermillion Basin Wilderness.

23 (G) Certain lands which comprise approxi-
24 mately 12,436 acres, as generally depicted on a
25 map entitled “Yampa River Wilderness Pro-

1 posal” dated March 22, 2002, which shall be
2 known as the Yampa River Wilderness.

3 (16) Certain lands in the Royal Gorge Resource
4 Area which comprise approximately 17,318 acres, as
5 generally depicted on a map entitled “McIntyre Hills
6 Wilderness Proposal”, dated March 22, 2002, which
7 shall be known as the McIntyre Wilderness.

8 (17) Certain lands in the Royal Gorge Resource
9 Area and the Pike National Forest which comprise
10 approximately 38,174 acres, as generally depicted on
11 a map entitled “Beaver Creek Wilderness Proposal”,
12 dated March 22, 2002, which shall be known as the
13 Beaver Creek Wilderness.

14 (18) Certain lands in the San Juan Resource
15 Area and the San Juan National which comprise ap-
16 proximately 32,050 acres, as generally depicted on a
17 map entitled “Snaggletooth Wilderness Proposal”,
18 dated March 22, 2002, which shall be known as the
19 Snaggletooth Wilderness.

20 (19) Certain lands in the San Luis Resource
21 Area which comprise approximately 10,864 acres, as
22 generally depicted on a map entitled “Rio Grande
23 Wilderness Proposal”, dated March 22, 2002, which
24 shall be known as the Rio Grande Wilderness.

1 (20) The following areas in the White River Re-
2 source Area:

3 (A) Certain lands which comprise approxi-
4 mately 22,439 acres, as generally depicted on a
5 map entitled “Black Mountain-Windy Gulch
6 Wilderness Proposal”, dated March 22, 2002,
7 which shall be known as the Black Mountain-
8 Windy Gulch Wilderness.

9 (B) Certain lands which comprise approxi-
10 mately 24,951 acres, as generally depicted on a
11 map entitled “Big Ridge Wilderness Proposal”,
12 dated March 22, 2002, which shall be known as
13 the Big Ridge Wilderness.

14 (C) Certain lands which comprise approxi-
15 mately 16,781 acres, as generally depicted on a
16 map entitled “Bull Canyon Wilderness Pro-
17 posal” dated March 22, 2002, which shall be
18 known as the Bull Canyon Wilderness.

19 (D) Certain lands which comprise approxi-
20 mately 25,005 acres, as generally depicted on a
21 map entitled “Oil Spring Mountain Wilderness
22 Proposal”, dated March 22, 2002, which shall
23 be known as the Oil Spring Mountain Wilder-
24 ness.

1 (E) Certain lands which comprise approxi-
2 mately 20,903 acres, as generally depicted on a
3 map entitled “Pinyon Ridge Wilderness Pro-
4 posal”, dated March 22, 2002, which shall be
5 known as the Pinyon Ridge Wilderness.

6 (F) Certain lands which comprise approxi-
7 mately 15,679 acres, as generally depicted on a
8 map entitled “Pisgah Mountain Wilderness Pro-
9 posal”, dated March 22, 2002, which shall be
10 known as the Pisgah Mountain Wilderness.

11 (G) Certain lands which comprise approxi-
12 mately 30,735 acres, as generally depicted on a
13 map entitled “Skull Creek Wilderness Pro-
14 posal”, dated March 22, 2002, which shall be
15 known as the Skull Creek Wilderness.

16 (21) Certain lands in the Royal Gorge Resource
17 Area and the San Isabel National Forest which com-
18 prise approximately 44,372 acres, as generally de-
19 picted on a map entitled “Grape Creek Wilderness
20 Proposal”, dated March 22, 2002, which shall be
21 known as the Grape Creek Wilderness.

22 (b) MAPS AND DESCRIPTIONS.—As soon as prac-
23 ticable after the date of enactment of this Act, the appro-
24 priate Secretary shall file a map and a boundary descrip-
25 tion of each area designated as wilderness by this Act with

1 the Committee on Resources of the United States House
2 of Representatives and the Committee on Energy and
3 Natural Resources of the United States Senate. Each map
4 and description shall have the same force and effect as
5 if included in this Act, except that the appropriate Sec-
6 retary is authorized to correct clerical and typographical
7 errors in such boundary descriptions and maps. Such
8 maps and boundary descriptions shall be on file and avail-
9 able for public inspection in the Office of the Director of
10 the Bureau of Land Management, Department of the In-
11 terior, and in the Office of the Chief of the Forest Service,
12 Department of Agriculture, as appropriate.

13 (c) STATE AND PRIVATE LANDS.—Lands within the
14 exterior boundaries of any wilderness area designated
15 under this section that are owned by the State or by a
16 private entity shall be included within such wilderness area
17 if such lands are acquired by the United States. Such
18 lands may be acquired by the United States only as pro-
19 vided in the Wilderness Act (16 U.S.C. 1131 and fol-
20 lowing).

21 **SEC. 3. ADMINISTRATIVE PROVISIONS.**

22 (a) IN GENERAL.—Subject to valid existing rights,
23 lands designated as wilderness by this Act shall be man-
24 aged by the Secretary of Agriculture or the Secretary of
25 the Interior, as appropriate, in accordance with the Wil-

1 derness Act (16 U.S.C. 1131 et seq.) and this Act, except
2 that, with respect to any wilderness areas designated by
3 this Act, any reference in the Wilderness Act to the effec-
4 tive date of the Wilderness Act shall be deemed to be a
5 reference to the date of enactment of this Act.

6 (b) GRAZING.—Grazing of livestock in wilderness
7 areas designated by this Act shall be administered in ac-
8 cordance with the provisions of section 4(d)(4) of the Wil-
9 derness Act (16 U.S.C. 1133(d)(4)), as further inter-
10 preted by section 108 of Public Law 96–560, and, the
11 guidelines set forth in Appendix A of House Report 101–
12 405 of the 101st Congress.

13 (c) STATE JURISDICTION.—As provided in section
14 4(d)(7) of the Wilderness Act (16 U.S.C. 1133(d)(7)),
15 nothing in this Act shall be construed as affecting the ju-
16 risdiction or responsibilities of the State of Colorado with
17 respect to wildlife and fish in Colorado.

18 (d) WATER.—(1) With respect to each wilderness
19 area designated by this Act, Congress hereby reserves a
20 quantity of water sufficient to fulfill the purposes of this
21 Act. The priority date of such reserved rights shall be the
22 date of enactment of this Act.

23 (2) The appropriate Secretary and all other officers
24 of the United States shall take steps necessary to protect
25 the rights reserved by paragraph (1), including the filing

1 by the Secretary of a claim for the quantification of such
2 rights in any present or future appropriate stream adju-
3 dication in the courts of the State of Colorado in which
4 the United States is or may be joined and which is con-
5 ducted in accordance with the McCarran Amendment (43
6 U.S.C. 666).

7 (3) Nothing in this Act shall be construed as a relin-
8 quishment or reduction of any water rights reserved or
9 appropriated by the United States in the State of Colorado
10 on or before the date of enactment of this Act.

11 (4) The Federal water rights reserved by this Act are
12 specific to the wilderness areas located in the State of Col-
13 orado designated by this title. Nothing in this title related
14 to reserved Federal water rights shall be construed as es-
15 tablishing a precedent with regard to any future designa-
16 tions, nor shall it constitute an interpretation of any other
17 Act or any designation made pursuant thereto.
