Ms. NORTON introduced the following bill; which was referred to the
Committee on the Judiciary

A BILL

To assist local governments in conducting gun buyback
programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Nationwide Gun
5 Buyback Act of 2002”.

6 **SEC. 2. GRANT PROGRAM.**

7 (a) IN GENERAL.—The Secretary of the Treasury
8 may make grants to units of local government to conduct
9 gun buyback programs.

10 (b) REDUCTION OF INCIDENCE OF GUN VIOLENCE
11 TO BE GIVEN GREAT WEIGHT.—In assessing applications

1 for grants under this Act, the Secretary shall give greater
2 weight to the incidence of gun violence and the need to
3 reduce the availability of guns in the jurisdictions involved
4 than to any other factors.

5 (c) USE OF FUNDS.—A unit of local government to
6 which a grant is made under this Act shall use the grant
7 only to conduct a gun buyback program in accordance
8 with the approved application for the grant.

9 **SEC. 3. APPLICATIONS.**

10 (a) IN GENERAL.—The chief executive of a unit of
11 local government desiring a grant under this Act shall sub-
12 mit to the Secretary of the Treasury an application for
13 the grant, which shall be in such form and contain such
14 information as the Secretary may reasonably require.

15 (b) REQUIREMENTS.—An application for a grant
16 under this Act for a gun buyback program shall contain
17 assurances from the chief executive of the unit of local
18 government (after consultation with the local chief of po-
19 lice or equivalent officer) that—

20 (1) within 60 days after the date the program
21 collects a gun, the gun will be destroyed or, if the
22 gun is an inoperable curio or relic with historic sig-
23 nificance, donated to a museum for display;

24 (2) the local law enforcement authority is able
25 to collect guns safely under the program; and

1 (3) the unit of local government has the author-
2 ity to grant an appropriate amnesty to persons from
3 whom guns are obtained under the program.

4 (c) REGULATIONS.—Not later than 90 days after the
5 date of the enactment of this Act, the Secretary of the
6 Treasury shall promulgate regulations to implement this
7 Act, which shall delegate to the Director of the Bureau
8 of Alcohol, Tobacco and Firearms the authority to carry
9 out this Act, and shall specify the information that must
10 be included in an application for a grant under this Act,
11 and the requirements that units of local government must
12 meet to be eligible for such a grant.

13 **SEC. 4. DEFINITIONS.**

14 In this Act:

15 (1) GUN.—The term “gun” means a firearm
16 (as defined in section 921(a)(3) of title 18, United
17 States Code).

18 (2) GUN BUYBACK PROGRAM.—The term “gun
19 buyback program” means a program conducted by a
20 local law enforcement authority under which the au-
21 thority purchases guns from, or accepts gun dona-
22 tions made by individuals or groups desiring to dis-
23 pose of guns.

1 **SEC. 5. LIMITATIONS ON AUTHORIZATION OF APPROPRIA-**
2 **TIONS.**

3 For grants under this Act, there are authorized to
4 be appropriated to the Secretary of the Treasury not more
5 than \$100,000,000 for each fiscal year.
