A BILL

To amend title 18, United States Code, to provide a maximum term of supervised release of life for child sex offenders.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Lifetime Consequences
3 for Sex Offenders Act of 2002”.

4 **SEC. 2. SUPERVISED RELEASE TERM FOR CHILD SEX OF-**
5 **FENDERS.**

6 Section 3583 of title 18, United States Code, is
7 amended by adding at the end the following:

8 “(k) SUPERVISED RELEASE TERMS FOR SEX OF-
9 FENDERS.—Notwithstanding subsection (b), the author-
10 ized term of supervised release for any offense under chap-
11 ter 109A, 110, 117, or section 1591, 2421, 2422, 2423,
12 or 2425 is any term of years or life.”

13 **SECTION 1. SHORT TITLE.**

14 This Act may be cited as the “Lifetime Consequences
15 for Sex Offenders Act of 2002”.

16 **SEC. 2. SUPERVISED RELEASE TERM FOR SEX OFFENDERS.**

17 Section 3583 of title 18, United States Code, is amend-
18 ed by adding at the end the following:

19 “(k) SUPERVISED RELEASE TERMS FOR SEX OFFEND-
20 ERS.—Notwithstanding subsection (b), the authorized term
21 of supervised release for any offense under chapter 109A,
22 110, 117, or section 1591 is any term of years or life.”

Amend the title so as to read: “A bill to amend title
18, United States Code, to provide a maximum term of
supervised release of life for sex offenders.”
