Mr. PASTOR introduced the following bill; which was referred to the
Committee on Resources

A BILL

To direct the Secretary of the Interior to take lands in Yuma County, Arizona, into trust as part of the reservation of the Cocopah Tribe of Arizona, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cocopah Lands Act”.

5 **SEC. 2. FINDINGS.**

6 Congress finds the following:

7 (1) The reservation of the Cocopah Tribe of Ar-
8 izona is located in Yuma County, Arizona.

1 (2) That reservation was created by an Execu-
2 tive order signed by President Woodrow Wilson in
3 1917.

4 (3) That reservation is made up of three non-
5 contiguous tracts of land.

6 (4) The Tribe inhabits that reservation.

7 (5) The Tribe is in need of additional lands to
8 provide services such as adequate housing, infra-
9 structure, water, and services to its tribal members.

10 (6) The current land base of the reservation is
11 insufficient to provide such needs.

12 (7) The Tribe acquired six parcels of land con-
13 tiguous to its present reservation lands in 1986,
14 1993, and 1998, and these parcels are currently
15 classified as “Indian Lands” according to Federal
16 law.

17 (8) The acquired parcels are not commercially
18 viable for gaming and shall not be taken into trust
19 for gaming purposes.

20 (9) The best means of solving the Tribe’s land
21 needs to provide basic necessities to its tribal mem-
22 bers is to require the Secretary of the Interior to
23 take lands in Yuma County, Arizona, that are ac-
24 quired by the Tribe into trust for the Tribe subject
25 to the provisions of this Act.

1 **SEC. 3. DEFINITIONS.**

2 For the purposes of this Act, the following definitions
3 apply:

4 (1) **TRIBE.**—The term “Tribe” means the
5 Cocopah Tribe of Arizona.

6 (2) **SECRETARY.**—The term “Secretary” means
7 the Secretary of the Interior.

8 **SEC. 4. LANDS TO BE TAKEN INTO TRUST.**

9 (a) **LANDS TO BE TAKEN INTO TRUST.**—If the Tribe
10 transfers title to the land described in subsection (b) to
11 the Secretary, the Secretary shall take that land into trust
12 for the benefit of the Tribe, if at the time of such transfer
13 there are no adverse legal claims to such land, including
14 outstanding liens, mortgages, or taxes owed.

15 (b) **LAND DESCRIBED.**—The land referred to in sub-
16 section (a) is described as follows:

17 **PARCEL 1**

18 Lot 4 and the southwest quarter of the northwest
19 quarter of section 1, Township 10 South, Range 25 West
20 of the Gila and Salt River Base and Meridian, Yuma
21 County, Arizona. Except that portion of the southwest
22 quarter of the northwest quarter of said section 1, Town-
23 ship 10 South, Range 25 West, lying Southeasterly of the
24 North Right-of-Way line of the United States Bureau of
25 Reclamation Levee.

1 PARCEL 2

2 Lot 1 and the southeast quarter of the northeast
3 quarter of section 2, Township 10 South, Range 25 West
4 of the Gila and Salt River Base and Meridian, Yuma
5 County, Arizona.

6 PARCEL 3

7 That part of the East half of the southwest quarter
8 lying South of the East Main Bureau of Reclamation
9 Canal Right-of-Way in section 30, Township 9 South,
10 Range 23 West of the Gila and Salt River Base and Me-
11 ridian, Yuma County, Arizona.

12 PARCEL 4

13 A parcel of approximately 0.8866 acres consisting of
14 a portion of the southeast quarter of the southeast quarter
15 of section 30, Township 9 South, Range 23 West of the
16 Gila and Salt River Meridian, Yuma County, Arizona,
17 lying easterly of the United States Highway 95 right-of-
18 way and northerly of the Arizona Department of Trans-
19 portation County 15th Street right-of-way.

20 PARCEL 5

21 Lot 21, 24, and 25, section 29, lots 16 and 17, sec-
22 tion 30; and $N\frac{1}{2}SW\frac{1}{4}SE\frac{1}{4}$ of section 30, T.16S.; R22E;
23 SBM, Yuma County, Arizona.

PARCEL 6

1
2 POR NW4NE4, section 31, 16S 22E lying North of
3 United States Levee Exc N 220 feet subject to easement
4 on W 40 feet. APN# 111-27-0022B

5 (c) LANDS TO BE MADE PART OF THE RESERVA-
6 TION.—Land taken into trust pursuant to subsection (a)
7 shall be considered to be part of the Tribe’s initial reserva-
8 tion.

9 (d) SERVICE AREA.—For the purposes of the delivery
10 of Federal services to enrolled members of the Tribe, the
11 Tribe’s service area shall be Yuma County, Arizona.

12 (e) GAMING PROHIBITED.—Land taken into trust for
13 the benefit of the Tribe under this Act shall not be used
14 for gaming under the Indian Gaming Regulatory Act.

15 **SEC. 5. REGULATIONS.**

16 The Secretary may promulgate such regulations as
17 may be necessary to carry out this Act.
