A BILL

To authorize the presentation of a gold medal on behalf of the Congress to the next of kin or other personal representative of Justin W. Dart, Jr., on behalf of the entire disability community and in recognition of his many contributions to the Nation throughout his lifetime, especially his tireless work to secure passage of the Americans with Disabilities Act of 1990, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CONGRESSIONAL GOLD MEDAL.**

2 (a) PRESENTATION AUTHORIZED.—In recognition of
3 Justin W. Dart, Jr., as one of the true champions of the
4 rights of individuals with disabilities and his many con-
5 tributions to the Nation throughout his lifetime, especially
6 his tireless work to secure passage of the Americans with
7 Disabilities Act of 1990, the Speaker of the House of Rep-
8 resentatives and the President Pro Tempore of the Senate
9 shall make appropriate arrangements for the presentation,
10 on behalf of the Congress, of a gold medal of appropriate
11 design, to the next of kin or other personal representative
12 of Justin W. Dart, Jr., on behalf of the entire disability
13 community.

14 (b) DESIGN AND STRIKING.—For purposes of the
15 presentation referred to in subsection (a), the Secretary
16 of the Treasury shall strike a gold medal with suitable em-
17 blems, devices, and inscriptions to be determined by the
18 Secretary.

19 **SEC. 2. DUPLICATE MEDALS.**

20 The Secretary of the Treasury may strike and sell
21 duplicates in bronze of the gold medal struck pursuant
22 to section 1 under such regulations as the Secretary may
23 prescribe, at a price sufficient to cover the cost thereof,
24 including labor, materials, dies, use of machinery, and
25 overhead expenses, and the cost of the gold medal.

1 **SEC. 3. NATIONAL MEDALS.**

2 The medals struck pursuant to this Act are national
3 medals for purposes of chapter 51 of title 31, United
4 States Code.

5 **SEC. 4. FUNDING.**

6 (a) **AUTHORITY TO USE FUND AMOUNTS.**—There is
7 authorized to be charged against the United States Mint
8 Public Enterprise Fund such amounts as may be nec-
9 essary to pay for the costs of the medals authorized by
10 this Act.

11 (b) **PROCEEDS OF SALE.**—Amounts received from the
12 sale of duplicate bronze medals under section 2 shall be
13 deposited in the United States Mint Public Enterprise
14 Fund.
