## A BILL

To amend the Consolidated Farm and Rural Development Act to authorize the Secretary of Agriculture to make grants to nonprofit organizations to finance the construction, refurbishing, and servicing of individually-owned household water well systems in rural areas for individuals with low or moderate incomes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Affordable Drinking  
5 Water Act of 2001”.

1 **SEC. 2. FINDINGS.**

2 Congress finds that—

3 (1) affordable access to safe, reliable drinking  
4 water is in the public interest;

5 (2) approximately 10,000,000 households in the  
6 United States receive drinking water from household  
7 water well systems;

8 (3) according to a national survey, more than  
9 80 percent of those well owners express a preference  
10 for water from their household water well system  
11 over water from a community drinking water system  
12 or bottled water;

13 (4) many consumers and farms in the United  
14 States receive drinking water from older household  
15 water well systems that are not constructed to cur-  
16 rent standards;

17 (5) those systems should be upgraded to ensure  
18 consumer and farm access to the safest and most re-  
19 liable sources of drinking water;

20 (6) the Department of Agriculture, including  
21 the Rural Utilities Service, has no program focused  
22 on funding the construction, refurbishment, or serv-  
23 icing of individually-owned household water well sys-  
24 tems; and

1           (7) centralized water systems are not always  
2           the most cost-efficient way to deliver safe, reliable  
3           drinking water to rural customers.

4 **SEC. 3. GRANTS TO NONPROFIT ORGANIZATIONS TO FI-**  
5 **NANCE THE CONSTRUCTION, REFURBISHING,**  
6 **AND SERVICING OF INDIVIDUALLY-OWNED**  
7 **HOUSEHOLD WATER WELL SYSTEMS IN**  
8 **RURAL AREAS FOR INDIVIDUALS WITH LOW**  
9 **OR MODERATE INCOMES.**

10       (a) IN GENERAL.—Subtitle A of the Consolidated  
11 Farm and Rural Development Act (7 U.S.C. 1922 et seq.)  
12 is amended by inserting after section 306D (7 U.S.C.  
13 1926d) the following:

14 **“SEC. 306E. GRANTS TO NONPROFIT ORGANIZATIONS TO FI-**  
15 **NANCE THE CONSTRUCTION, REFURBISHING,**  
16 **AND SERVICING OF INDIVIDUALLY-OWNED**  
17 **HOUSEHOLD WATER WELL SYSTEMS IN**  
18 **RURAL AREAS FOR INDIVIDUALS WITH LOW**  
19 **OR MODERATE INCOMES.**

20       “(a) DEFINITION OF ELIGIBLE INDIVIDUAL.—In this  
21 section, the term ‘eligible individual’ means an individual  
22 who is a member of a household, the combined income of  
23 whose members for the most recent 12-month period for  
24 which the information is available, is not more than 100  
25 percent of the median nonmetropolitan household income

1 for the State or territory in which the individual resides,  
2 according to the most recent decennial census of the  
3 United States.

4 “(b) GRANTS.—The Secretary may make grants to  
5 private nonprofit organizations for the purpose of assist-  
6 ing eligible individuals in obtaining financing for the con-  
7 struction, refurbishing, and servicing of individual house-  
8 hold water well systems in rural areas that are owned (or  
9 to be owned) by the eligible individuals.

10 “(c) USE OF FUNDS.—A grant made under this sec-  
11 tion may be—

12 “(1) used, or invested to provide income to be  
13 used, to carry out subsection (b); and

14 “(2) used to pay administrative expenses associ-  
15 ated with providing the assistance described in sub-  
16 section (b).

17 “(d) PRIORITY IN AWARDING GRANTS.—In awarding  
18 grants under this section, the Secretary shall give priority  
19 to an applicant that has substantial expertise and experi-  
20 ence in promoting the safe and productive use of individ-  
21 ually-owned household water well systems and ground  
22 water.”.

23 (b) EFFECTIVE DATE.—The amendment made by  
24 this section takes effect on October 1, 2001.
