Mrs. MYRICK, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2216) making supplemental appropriations for the fiscal year ending September 30, 2001, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 2216) making supplemental appro-  
6 priations for the fiscal year ending September 30, 2001,  
7 and for other purposes. The first reading of the bill shall

1 be dispensed with. All points of order against consider-  
2 ation of the bill are waived. General debate shall be con-  
3 fined to the bill and shall not exceed one hour equally di-  
4 vided and controlled by the chairman and ranking minor-  
5 ity member of the Committee on Appropriations. After  
6 general debate the bill shall be considered for amendment  
7 under the five-minute rule. The amendment printed in  
8 part A of the report of the Committee on Rules accom-  
9 panying this resolution shall be considered as adopted in  
10 the House and in the Committee of the Whole. Points of  
11 order against provisions in the bill, as amended, for failure  
12 to comply with clause 2 of rule XXI are waived. The  
13 amendment printed in part B of the report of the Com-  
14 mittee on Rules may be offered only by a Member des-  
15 ignated in the report and only at the appropriate point  
16 in the reading of the bill, shall be considered as read, shall  
17 not be subject to amendment, and shall not be subject to  
18 a demand for division of the question in the House or in  
19 the Committee of the Whole. All points of order against  
20 the amendment printed in part B of the report are waived.  
21 During consideration of the bill for further amendment,  
22 the Chairman of the Committee on the Whole may accord  
23 priority in recognition on the basis of whether the Member  
24 offering an amendment has caused it to be printed in the  
25 portion of the Congressional Record designated for that

1 purpose in clause 8 of rule XVIII. Amendments so printed  
2 shall be considered as read. During consideration of the  
3 bill, as amended, points of order against amendments for  
4 failure to comply with clause 2(e) of rule XXI are waived.  
5 At the conclusion of consideration of the bill for amend-  
6 ment the Committee shall rise and report the bill, as  
7 amended, to the House with such further amendments as  
8 may have been adopted. The previous question shall be  
9 considered as ordered on the bill and amendments thereto  
10 to final passage without intervening motion except one  
11 motion to recommit with or without instructions.
