Ms. PRYCE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2620) making appropriations for the Departments of Veterans Affairs and Housing and Urban Development and for sundry independent agencies, boards, commissions, corporations, and offices for the fiscal year ending September 30, 2002, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 2620) making appropriations for
3 the Departments of Veterans Affairs and Housing and
4 Urban Development and for sundry independent agencies,
5 boards, commissions, corporations, and offices for the fis-
6 cal year ending September 30, 2002, and for other pur-
7 poses. The first reading of the bill shall be dispensed with.
8 All points of order against consideration of the bill are
9 waived. General debate shall be confined to the bill and
10 shall not exceed one hour equally divided and controlled
11 by the chairman and ranking minority member of the
12 Committee on Appropriations. After general debate the
13 bill shall be considered for amendment under the five-
14 minute rule. Points of order against provisions in the bill
15 for failure to comply with clause 2 of rule XXI are waived
16 except as follows: beginning with “,except that” on page
17 64, line 12, through “drinking water contaminants” on
18 line 17. Where points of order are waived against part
19 of a paragraph, points of order against a provision in an-
20 other part of such paragraph may be made only against
21 such provision and not against the entire paragraph. The
22 amendment printed in the report of the Committee on
23 Rules accompanying this resolution may be offered only
24 by a Member designated in the report and only at the ap-
25 propriate point in the reading of the bill, shall be consid-

1 ered as read, shall not be subject to amendment, and shall
2 not be subject to a demand for division of the question
3 in the House or in the Committee of the Whole. All points
4 of order against the amendment printed in the report are
5 waived. During consideration of the bill for amendment,
6 the Chairman of the Committee of the Whole may accord
7 priority in recognition on the basis of whether the Member
8 offering an amendment has caused to be printed in the
9 portion of the Congressional Record designated for that
10 purpose in clause 8 of rule XVIII. Amendments so printed
11 shall be considered as read. During consideration of the
12 bill, points of order against amendments for failure to
13 comply with clause 2(e) of rule XXI are waived. At the
14 conclusion of consideration of the bill for amendment the
15 Committee shall rise and report the bill to the House with
16 such amendments as may have been adopted. The previous
17 question shall be considered as ordered on the bill and
18 amendments thereto to final passage without intervening
19 motion except one motion to recommit with or without in-
20 structions.
