Ms. PRYCE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2647) making appropriations for the Legislative Branch for the fiscal year ending September 30, 2002, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 2647) making appropriations for  
6 the Legislative Branch for the fiscal year ending Sep-  
7 tember 30, 2002, and for other purposes. The first reading

1 of the bill shall be dispensed with. Points of order against  
2 consideration of the bill for failure to comply with clause  
3 4(c) of rule XIII are waived. General debate shall be con-  
4 fined to the bill and shall not exceed one hour equally di-  
5 vided and controlled by the chairman and ranking minor-  
6 ity member of the Committee on Appropriations. After  
7 general debate the bill shall be considered for amendment  
8 under the five-minute rule. The bill shall be considered  
9 as read. Points of order against provisions in the bill for  
10 failure to comply with clause 2 of rule XXI are waived.  
11 No amendment to the bill shall be in order except those  
12 printed in the report of the Committee on Rules accom-  
13 panying this resolution. Each such amendment may be of-  
14 fered only in the order printed in the report, may be of-  
15 fered only by a Member designated in the report, shall  
16 be considered as read, shall be debatable for the time spec-  
17 ified in the report equally divided and controlled by the  
18 proponent and an opponent, shall not be subject to amend-  
19 ment, and shall not be subject to a demand for division  
20 of the question in the House or in the Committee of the  
21 Whole. All points of order against such amendments are  
22 waived. At the conclusion of consideration of the bill for  
23 amendment the Committee shall rise and report the bill  
24 to the House with such amendments as may have been  
25 adopted. The previous question shall be considered as or-

- 1 dered on the bill and amendments thereto to final passage
- 2 without intervening motion except one motion to recommit
- 3 with or without instructions.
