# RESOLUTION

Providing for consideration of the bill (H.R. 3167) to endorse the vision for further enlargement of the NATO Alliance articulated by President George W. Bush on June 15, 2001, and by former President William J. Clinton on October 22, 1996, and for other purposes.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order without intervention of any point of  
3 order to consider in the House the bill (H.R. 3167) to  
4 endorse the vision of further enlargement of the NATO  
5 Alliance articulated by President George W. Bush on June

1 15, 2001, and by former President William J. Clinton on  
2 October 22, 1996, and for other purposes. The bill shall  
3 be considered as read for amendment. The amendment  
4 recommended by the Committee on International Rela-  
5 tions now printed in the bill shall be considered as adopt-  
6 ed. The previous question shall be considered as ordered  
7 on the bill, as amended, and on any further amendment  
8 thereto to final passage without intervening motion except:  
9 (1) one hour of debate on the bill, as amended, equally  
10 divided and controlled by the chairman and ranking mi-  
11 nority member of the Committee on International Rela-  
12 tions; (2) a further amendment in the nature of a sub-  
13 stitute printed in the Congressional Record pursuant to  
14 clause 8 of rule XVIII, if offered by Representative Lantos  
15 of California or his designee, which shall be considered as  
16 read and shall be separately debatable for one hour equally  
17 divided and controlled by the proponent and an opponent;  
18 and (3) one motion to recommit with or without instruc-  
19 tions.
