## RESOLUTION

Providing for consideration of the bill (H.R. 2269) to amend title I of the Employee Retirement Income Security Act of 1974 and the Internal Revenue Code of 1986 to promote the provision of retirement investment advice to workers managing their retirement income assets.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order without intervention of any point of  
3 order to consider in the House the bill (H.R. 2269) to  
4 amend title I of the Employee Retirement Income Security  
5 Act of 1974 and the Internal Revenue Code of 1986 to

1 promote the provision of retirement investment advice to  
2 workers managing their retirement income assets. The bill  
3 shall be considered as read for amendment. In lieu of the  
4 amendments recommended by the Committee on Edu-  
5 cation and the Workforce and the Committee on Ways and  
6 Means now printed in the bill, the amendment in the na-  
7 ture of a substitute printed in part A of the report of the  
8 Committee on Rules accompanying this resolution shall be  
9 considered as adopted. The previous question shall be con-  
10 sidered as ordered on the bill, as amended, and on any  
11 further amendment thereto to final passage without inter-  
12 vening motion except: (1) one hour and 40 minutes of de-  
13 bate on the bill, as amended, with one hour equally divided  
14 and controlled by the chairman and ranking minority  
15 member of the Committee on Education and the Work-  
16 force and 40 minutes equally divided and controlled by the  
17 chairman and ranking minority member of the Committee  
18 on Ways and Means; (2) the further amendment printed  
19 in part B of the report of the Committee on Rules, if of-  
20 fered by Representative George Miller of California or his  
21 designee, which shall be in order without intervention of  
22 any point of order, shall be considered as read, and shall  
23 be separately debatable for one hour equally divided and  
24 controlled by the proponent and an opponent; and (3) one  
25 motion to recommit with or without instructions.
