Mr. ISRAEL submitted the following resolution; which was referred to the Committee on Rules

RESOLUTION

Providing for consideration of the bill (H.R. 3341) to provide a short-term enhanced safety net for Americans losing their jobs and to provide our Nation's economy with a necessary boost.

1 *Resolved*, That immediately upon adoption of this res-
2 olution the Speaker shall, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 3341) to provide a short-term en-
6 hanced safety net for Americans losing their jobs and to
7 provide our Nation's economy with a necessary boost. The
8 first reading of the bill shall be dispensed with. All points

1 of order against consideration of the bill are waived. Gen-
2 eral debate shall be confined to the bill and shall not ex-
3 ceed one hour equally divided and controlled by the chair-
4 man and ranking minority member of the Committee on
5 Ways and Means. After general debate the bill shall be
6 considered for amendment under the five-minute rule. The
7 bill shall be considered by title rather than by section.
8 Each title shall be considered as read. Before the consider-
9 ation of any other amendment to the bill, it shall be in
10 order to consider and dispose of an amendment to strike
11 title III. Such amendment shall not be subject to debate.
12 During consideration of the bill for further amendment,
13 the Chairman of the Committee of the Whole may accord
14 priority in recognition on the basis of whether the Member
15 offering an amendment has caused it to be printed in the
16 portion of the Congressional Record designated for that
17 purpose in clause 8 of rule XVIII. Amendments so printed
18 shall be considered as read. At the conclusion of consider-
19 ation of the bill for amendment the Committee shall rise
20 and report the bill to the House with such amendments
21 as may have been adopted. The previous question shall
22 be considered as ordered on the bill and amendments
23 thereto to final passage without intervening motion except
24 one motion to recommit with or without instructions.

1 SEC. 2. If the Committee of the Whole rises and re-
2 ports that it has come to no resolution on the bill, then
3 on the next legislative day the House shall, immediately
4 after the third daily order of business under clause 1 of
5 rule XIV, resolve into the Committee of the Whole for fur-
6 ther consideration of the bill.
