Mr. BENNETT introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To adjust the boundaries of the Mount Nebo Wilderness Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Mount Nebo Wilder-
5 ness Boundary Adjustment Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) MAP.—The term “map” means the map en-
9 titled “Mt. Nebo Wilderness Boundary Adjustment”,
10 numbered 531 and dated May 29, 2001.

1 (2) WILDERNESS.—The term “Wilderness”
2 means the Mount Nebo Wilderness.

3 **SEC. 3. BOUNDARY ADJUSTMENTS.**

4 (a) REMOVAL OF LAND.—The boundary of the Wil-
5 derness is adjusted to exclude the following:

6 (1) BIRCH CREEK.—The approximately 5.0
7 acres of land depicted on the map as “Birch Creek”.

8 (2) GARDNER CANYON.—The approximately
9 177.8 acres of land depicted on the map as “Gard-
10 ner Canyon”.

11 (3) INGRAM CANYON.—The approximately 15.4
12 acres of land depicted on the map as “Ingram Can-
13 yon”.

14 (4) MENDENHALL CANYON.—The approxi-
15 mately 9.8 acres of land depicted on the map as
16 “Mendenhall Canyon”.

17 (5) MONUMENT SPRINGS.—The approximately
18 8.4 acres of land depicted on the map as “Monu-
19 ment Springs”.

20 (6) WASH CANYON.—The approximately 31.4
21 acres of land depicted on the map as “Wash Can-
22 yon”.

23 (7) WILLOW NORTH A.—The approximately 3.4
24 acres of land depicted on the map as “Willow North
25 A”.

1 (8) WILLOW NORTH B.—The approximately 6.6
2 acres of land depicted on the map as “Willow North
3 B”.

4 (9) WILLOW SOUTH.—The approximately 21.5
5 acres of land depicted on the map as “Willow
6 South”.

7 (b) ADDITION OF LAND.—

8 (1) IN GENERAL.—Subject to valid existing
9 rights, the boundary of the Wilderness is adjusted to
10 include the approximately 293.2 acres of land de-
11 picted on the map for addition to the Wilderness.

12 (2) UTAH WILDERNESS ACT.—The Utah Wil-
13 derness Act of 1984 (Public Law 94–428; 98 Stat.
14 1657) shall apply to the land added to the Wilder-
15 ness by paragraph (1).

16 (c) TECHNICAL BOUNDARY ADJUSTMENT.—The
17 boundary of the Wilderness is adjusted to exclude the ap-
18 proximately 21.26 acres of private property located in An-
19 drews Canyon, Utah, and depicted on the map as “Dale”.

20 **SEC. 4. MAP.**

21 (a) AVAILABILITY OF MAP.—The map and the docu-
22 ment entitled “Mount Nebo, Proposed Boundary Adjust-
23 ments, Parcel Descriptions (See Map # 531)” and dated
24 June 4, 2001, shall be on file and available for inspection
25 in the office of the Chief of the Forest Service.

1 (b) TECHNICAL CORRECTIONS.—The Secretary of
2 Agriculture may make technical corrections to the map.
