Mr. ENZI (for himself and Mr. JOHNSON) introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To amend the Food Security Act of 1985 to extend and improve the environmental quality incentive program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ENVIRONMENTAL QUALITY INCENTIVE PRO-**
4 **GRAM.**

5 (a) DEFINITION OF MAXIMIZE ENVIRONMENTAL
6 BENEFITS PER DOLLAR EXPENDED.—Section 1240A of
7 the Food Security Act of 1985 (16 U.S.C. 3839aa–1) is
8 amended—

9 (1) by redesignating paragraphs (4) and (5) as
10 paragraphs (5) and (6), respectively; and

1 (2) by inserting after paragraph (3) the fol-
2 lowing:

3 “(4) MAXIMIZE ENVIRONMENTAL BENEFITS
4 PER DOLLAR EXPENDED.—

5 “(A) IN GENERAL.—The term ‘maximize
6 environmental benefits per dollar expended’
7 means to maximize environmental benefits to
8 the extent the Secretary, in consultation with
9 local work groups (as defined in section 1466.3
10 of title 7, Code of Federal Regulations (or a
11 successor regulation)), determines is practicable
12 and appropriate, taking into account the
13 amount of funding made available to carry out
14 this chapter.

15 “(B) LIMITATION.—The term ‘maximize
16 environmental benefits per dollar expended’
17 does not require the Secretary—

18 “(i) to provide the least cost contract
19 or practice; or

20 “(ii) to require the development of a
21 plan under section 1240E as part of an
22 application for the program.”.

23 (b) EXTENSION OF PROGRAM.—

24 (1) IN GENERAL.—Section 1240B(a)(1) of the
25 Food Security Act of 1985 (16 U.S.C. 3839aa–

1 2(a)(1) is amended by striking “2002” and insert-
2 ing “2011”.

3 (2) FUNDING.—Section 1241 of the Food Secu-
4 rity Act of 1985 (16 U.S.C. 3841) is amended—

5 (A) in subsection (a) and subsection
6 (b)(2), by striking “2002” each place it appears
7 and inserting “2011”; and

8 (B) in subsection (b)(1), by striking
9 “2002,” and inserting “2011, to remain avail-
10 able until expended,”.

11 (c) APPLICATION AND TERM.—Section 1240B(b)(2)
12 of the Food Security Act of 1985 (16 U.S.C. 3839aa-
13 2(b)(2)) is amended by striking “less than 5,” and insert-
14 ing “less than 3,”.

15 (d) TIMING OF EXPENDITURES.—Section 1240G of
16 the Food Security Act of 1985 (16 U.S.C. 3839aa-7) is
17 amended by striking subsection (e).
