Mrs. BOXER introduced the following bill; which was read twice and referred to the Committee on Finance

## A BILL

To require the Secretary of Labor to establish a trade adjustment assistance program for certain service workers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TRADE ADJUSTMENT ASSISTANCE.**

4 Not later than 180 days after the date of enactment  
5 of the Trade Adjustment Assistance Reform Act of 2002,  
6 the Secretary shall establish a program to provide assist-  
7 ance under chapter 2 of title II of the Trade Act of 1974  
8 (19 U.S.C. 2271 et seq.), as amended by the Trade Ad-  
9 justment Assistance Reform Act of 2002, to provide trade  
10 adjustment assistance to any domestic operator of a motor

1 carrier who is adversely affected by competition from any  
2 foreign owned or operated motor carrier.

3 **SEC. 2. DATA COLLECTION AND REPORT.**

4 (a) DATA COLLECTION SYSTEM.—Not later than 180  
5 days after the date of enactment of the Trade Adjustment  
6 Assistance Reform Act of 2002, the Secretary shall put  
7 in place a system to collect data on adversely affected serv-  
8 ice workers that includes the number of workers by State,  
9 industry, and cause of dislocation for each worker.

10 (b) REPORT.—Not later than 2 years after the date  
11 of enactment of the Trade Adjustment Assistance Reform  
12 Act of 2002, the Secretary shall report to Congress pro-  
13 posed methods to extend the programs under chapter 2  
14 of title II of the Trade Act of 1974 (19 U.S.C. 2271 et  
15 seq.) to adversely affected service workers. The report  
16 shall include any recommendations for legislation that the  
17 Secretary considers appropriate regarding such programs.

18 **SEC. 3. DEFINITIONS.**

19 In this Act:

20 (1) SECRETARY.—The term “Secretary” means  
21 the Secretary of Labor.

22 (2) TRADE ADJUSTMENT ASSISTANCE REFORM  
23 ACT OF 2002.—The term “Trade Adjustment As-  
24 sistance Reform Act of 2002” means the Trade Ad-  
25 justment Assistance Reform Act of 2002, or any

1 other Act enacted during the second session of the  
2 107th Congress to provide trade adjustment assist-  
3 ance.
