A BILL

To designate the Cedar Creek Battlefield and Belle Grove Plantation National Historical Park as a unit of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Cedar Creek Battle-
3 field and Belle Grove Plantation National Historical Park
4 Act”.

5 **SEC. 2. PURPOSE.**

6 The purpose of this Act is to establish the Cedar
7 Creek Battlefield and Belle Grove Plantation National
8 Historical Park in order to—

9 (1) help preserve, protect, and interpret a na-
10 tionally significant Civil War landscape and ante-
11 bellum plantation for the education, inspiration, and
12 benefit of present and future generations;

13 (2) serve as a focal point to recognize and inter-
14 pret important events and geographic locations rep-
15 resenting key Civil War battles in the Shenandoah
16 Valley, including those battlefields associated with
17 the Thomas J. (Stonewall) Jackson campaign of
18 1862 and the decisive campaigns of 1864;

19 (3) tell the rich story of the Battle of Cedar
20 Creek and its significance in the conduct of the war
21 in the Shenandoah Valley; and

22 (4) preserve the significant historic, natural,
23 cultural, military, and scenic resources found in the
24 Cedar Creek Battlefield and Belle Grove Plantation
25 areas through partnerships with local landowners
26 and the community.

1 **SEC. 3. FINDINGS.**

2 Congress finds the following:

3 (1) The Battle of Cedar Creek, also known as
4 the battle of Belle Grove, was a major event of the
5 Civil War and the history of this country. It rep-
6 resented the end of the Civil War's Shenandoah Val-
7 ley campaign of 1864 and contributed to the reelec-
8 tion of President Abraham Lincoln and the eventual
9 outcome of the war.

10 (2) 2,500 acres of the Cedar Creek Battlefield
11 and Belle Grove Plantation were designated a na-
12 tional historic landmark in 1969 because of their
13 ability to illustrate and interpret important eras and
14 events in the history of the United States. The
15 Cedar Creek Battlefield, Belle Grove Manor House,
16 the Heater House, and Harmony Hall (a National
17 Historic Landmark) are also listed on the Virginia
18 Landmarks Register.

19 (3) The Secretary of the Interior has approved
20 the Shenandoah Valley Battlefields National His-
21 toric District Management Plan, September 2000,
22 which preserves the District's historic character, and
23 protects and interprets 10 significant Civil War bat-
24 tlefields within the District, including the Cedar
25 Creek battlefield.

1 (4) The Shenandoah Valley Battlefields Na-
2 tional Historic District Management Plan and the
3 National Park Service Special Resource Study recog-
4 nize the Cedar Creek battlefield as the most signifi-
5 cant Civil War resource within the Historic District.

6 (5) The Shenandoah Valley Battlefields Na-
7 tional Historic District Management Plan, which
8 was developed with extensive public participation
9 over a 3-year period and is administered by the
10 Shenandoah Valley Battlefields Foundation, rec-
11 ommends that Cedar Creek Battlefield be estab-
12 lished as a new unit of the National Park System to
13 provide permanent protection for the battlefield and
14 to serve as the central site to increase the public's
15 education and awareness of the War's legacy
16 throughout the Historic District.

17 (6) The Cedar Creek Battlefield Foundation,
18 organized in 1988 to preserve and interpret the
19 Cedar Creek Battlefield and the 1864 Valley Cam-
20 paign, has acquired 308 acres of land within the
21 boundaries of the National Historic Landmark. The
22 foundation annually hosts a major reenactment and
23 living history event on the Cedar Creek Battlefield.

24 (7) Belle Grove Plantation is a Historic Site of
25 the National Trust for Historic Preservation that oc-

1 cupies 383 acres within the National Historic Land-
2 mark. The Belle Grove Manor House was built by
3 Isaac Hite, a Revolutionary War patriot married to
4 the sister of President James Madison, who was a
5 frequent visitor at Belle Grove. President Thomas
6 Jefferson assisted with the design of the house. Dur-
7 ing the Civil War Belle Grove was at the center of
8 the decisive battle of Cedar Creek. Belle Grove is
9 managed locally by Belle Grove, Incorporated, and
10 has been open to the public since 1967. The house
11 has remained virtually unchanged since it was built
12 in 1797, offering visitors an experience of the life
13 and times of the people who lived there in the 18th
14 and 19th centuries.

15 (8) The panoramic views of the mountains, nat-
16 ural areas, and waterways provide visitors with an
17 inspiring setting of great natural beauty. The his-
18 toric, natural, cultural, military, and scenic re-
19 sources found in the Cedar Creek Battlefield and
20 Belle Grove Plantation areas are nationally and re-
21 gionally significant.

22 (9) The existing, independent, not-for-profit or-
23 ganizations dedicated to the protection and interpre-
24 tation of the resources described above provide the
25 foundation for public-private partnerships to further

1 the success of protecting, preserving, and inter-
2 preting these resources.

3 ~~(10) None of these resources, sites, or stories of~~
4 ~~the Shenandoah Valley are protected by or inter-~~
5 ~~preted within the National Park System.~~

6 **SEC. 4. DEFINITIONS.**

7 In this Act:

8 (1) COMMISSION.—The term “Commission”
9 means the Cedar Creek Battlefield and Belle Grove
10 Plantation National Historical Park Advisory Com-
11 mission established by section 9.

12 (2) MAP.—The term “Map” means the map en-
13 titled “Cedar Creek Battlefield and Belle Grove
14 Plantation National Historic Park”, numbered
15 ~~CECR-80,000~~, and dated ~~June 12, 2002~~.

16 (3) PARK.—The term “Park” means the Cedar
17 Creek Battlefield and Belle Grove Plantation Na-
18 tional Historical Park established under section 5
19 and depicted on the Map.

20 (4) SECRETARY.—The term “Secretary” means
21 the Secretary of the Interior.

1 **SEC. 5. ESTABLISHMENT OF CEDAR CREEK BATTLEFIELD**
2 **AND BELLE GROVE PLANTATION NATIONAL**
3 **HISTORICAL PARK.**

4 (a) **ESTABLISHMENT.**—There is established the
5 Cedar Creek Battlefield and Belle Grove Plantation Na-
6 tional Historical Park, consisting of approximately 3,000
7 acres, as generally depicted on the Map.

8 (b) **AVAILABILITY OF MAP.**—The Map shall be on file
9 and available for public inspection in the offices of the Na-
10 tional Park Service of the Department of the Interior.

11 **SEC. 6. ACQUISITION OF PROPERTY.**

12 (a) **REAL PROPERTY.**—The Secretary may acquire
13 land or interests in land within the boundaries of the
14 Park, from willing sellers only, by donation, purchase with
15 donated or appropriated funds, or exchange.

16 (b) **BOUNDARY REVISION.**—After acquiring land for
17 the Park, the Secretary shall—

18 (1) revise the boundary map of the Park to in-
19 clude newly acquired land within the boundary; and

20 (2) administer newly acquired land subject to
21 applicable laws (including regulations).

22 (c) **PERSONAL PROPERTY.**—The Secretary may ac-
23 quire personal property associated with, and appropriate
24 for, interpretation of the Park.

25 (d) **CONSERVATION EASEMENTS AND COVENANTS.**—
26 The Secretary is authorized to acquire conservation ease-

1 ments and enter into covenants regarding lands in or adja-
 2 cent to the Park from willing sellers only. Such conserva-
 3 tion easements and covenants shall have the effect of pro-
 4 tecting the scenic, natural, and historic resources on adja-
 5 cent lands and preserving the natural or historic setting
 6 of the park when viewed from within or outside the Park.

7 (e) **SUPPORT FACILITIES.**—The National Park Serv-
 8 ice is authorized to acquire from willing sellers up to 50
 9 acres of land outside the park boundary, but in close prox-
 10 imity to the park, to develop facilities for one or more of
 11 the following:

- 12 (1) Visitors.
- 13 (2) Administrative functions.
- 14 (3) Museums.
- 15 (4) Curatorial functions.
- 16 (5) Maintenance.

17 **SEC. 7. ADMINISTRATION.**

18 The Secretary shall administer the Park in accord-
 19 ance with this Act and the provisions of law generally ap-
 20 plicable to units of the National Park System, including—

- 21 (1) the Act entitled “An Act to establish a Na-
 22 tional Park Service, and for other purposes”, ap-
 23 proved August 25, 1916 (16 U.S.C. 1 et seq.); and
- 24 (2) the Act entitled “An Act to provide for the
 25 preservation of historic American sites, buildings,

1 objects, and antiquities of national significance, and
2 for other purposes", approved August 21, 1935 (16
3 U.S.C. 461 et seq.).

4 **SEC. 8. MANAGEMENT OF PARK.**

5 (a) **MANAGEMENT PLAN.**—The Secretary, in con-
6 sultation with the Commission, shall prepare a manage-
7 ment plan for the Park. In particular, the management
8 plan shall contain provisions to address the needs of own-
9 ers of non-Federal land, including independent nonprofit
10 organizations within the boundaries of the Park.

11 (b) **SUBMISSION OF PLAN TO CONGRESS.**—Not later
12 than 3 years after the date of the enactment of this Act,
13 the Secretary shall submit the management plan for the
14 Park to Congress.

15 **SEC. 9. CEDAR CREEK BATTLEFIELD AND BELLE GROVE**
16 **PLANTATION NATIONAL HISTORICAL PARK**
17 **ADVISORY COMMISSION.**

18 (a) **ESTABLISHMENT.**—There is established the
19 Cedar Creek Battlefield and Belle Grove Plantation Na-
20 tional Historical Park Advisory Commission.

21 (b) **DUTIES.**—The Commission shall—

22 (1) advise the Secretary in the preparation and
23 implementation of a general management plan de-
24 scribed in section 8; and

1 (2) advise the Secretary with respect to the
2 identification of sites of significance outside the
3 Park boundary deemed necessary to fulfill the pur-
4 poses of this Act.

5 (e) MEMBERSHIP.—

6 (1) COMPOSITION.—The Commission shall be
7 composed of 15 members appointed by the Secretary
8 so as to include the following:

9 (A) 1 representative from the Common-
10 wealth of Virginia.

11 (B) 1 representative each from the local
12 governments of Strasburg, Middletown, Fred-
13 erick County, Shenandoah County, and Warren
14 County.

15 (C) 2 representatives of private landowners
16 within the Park.

17 (D) 1 representative from a citizen interest
18 group.

19 (E) 1 representative from the Cedar Creek
20 Battlefield Foundation.

21 (F) 1 representative from Belle Grove, In-
22 corporated.

23 (G) 1 representative from the National
24 Trust for Historic Preservation.

1 (H) ~~1~~ representative from the Shenandoah
2 Valley Battlefields Foundation.

3 (I) ~~1~~ ex-officio representative from the Na-
4 tional Park Service.

5 (J) ~~1~~ ex-officio representative from the
6 United States Forest Service.

7 (2) CHAIRPERSON.—The Chairperson of the
8 Commission shall be elected by the members to serve
9 a term of one year renewable for one additional year.

10 (3) VACANCIES.—A vacancy on the Commission
11 shall be filled in the same manner in which the origi-
12 nal appointment was made.

13 (4) TERMS OF SERVICE.—

14 (A) IN GENERAL.—Each member shall be
15 appointed for a term of ~~3~~ years and may be re-
16 appointed for not more than ~~2~~ successive terms.

17 (B) INITIAL MEMBERS.—Of the members
18 first appointed under paragraph (1), the Sec-
19 retary shall appoint—

20 (i) ~~4~~ members for a term of ~~1~~ year;

21 (ii) ~~5~~ members for a term of ~~2~~ years;

22 and

23 (iii) ~~6~~ members for a term of ~~3~~ years.

1 (5) EXTENDED SERVICE.—A member may
2 serve after the expiration of that member's term
3 until a successor has taken office.

4 (6) MAJORITY RULE.—The Commission shall
5 act and advise by affirmative vote for a majority of
6 its members.

7 (7) MEETINGS.—The Commission shall meet at
8 least quarterly at the call of the chairperson or a
9 majority of the members of the Commission.

10 (8) QUORUM.—8 members shall constitute a
11 quorum.

12 (d) COMPENSATION.—Members shall serve without
13 pay. Members who are full-time officers or employees of
14 the United States, the Commonwealth of Virginia, or any
15 political subdivision thereof shall receive no additional pay
16 on account of their service on the Commission.

17 (e) HEARINGS; PUBLIC INVOLVEMENT.—The Com-
18 mission may, for purposes of carrying out this Act, hold
19 such hearings, sit and act at such times and places, take
20 such public testimony, and receive such evidence, as the
21 Commission considers appropriate. The Commission may
22 not issue subpoenas or exercise any subpoena authority.

23 (f) FACA NONAPPLICABILITY.—The Federal Advi-
24 sory Committee Act shall not apply to the Commission.

1 **SEC. 10. CONSERVATION OF CEDAR CREEK BATTLEFIELD**
2 **AND BELLE GROVE PLANTATION NATIONAL**
3 **HISTORICAL PARK.**

4 (a) ENCOURAGEMENT OF CONSERVATION.—The Sec-
5 retary and the Commission shall encourage conservation
6 of the historic and natural resources within and in prox-
7 imity of the Park by landowners, local governments, orga-
8 nizations, and businesses.

9 (b) PROVISION OF TECHNICAL ASSISTANCE.—The
10 Secretary may provide technical assistance to local govern-
11 ments, in cooperative efforts which complement the values
12 of the Park.

13 (c) COOPERATION BY FEDERAL AGENCIES.—Any
14 Federal entity conducting or supporting activities directly
15 affecting the Park shall consult, cooperate, and, to the
16 maximum extent practicable, coordinate its activities with
17 the Secretary in a manner that—

18 (1) is consistent with the purposes of this Act
19 and the standards and criteria established pursuant
20 to the general management plan developed pursuant
21 to section 8;

22 (2) is not likely to have an adverse effect on the
23 resources of the Park; and

24 (3) is likely to provide for full public participa-
25 tion in order to consider the views of all interested
26 parties.

1 **SEC. 11. ENDOWMENT.**

2 (a) **IN GENERAL.**—In accordance with the provisions
3 of subsection (b), the Secretary is authorized to receive
4 and expend funds from an endowment to be established
5 with the National Park Foundation, or its successors and
6 assigns.

7 (b) **CONDITIONS.**—Funds from the endowment re-
8 ferred to in subsection (a) shall be expended exclusively
9 as the Secretary, in consultation with the Commission,
10 may designate for the interpretation, preservation, and
11 maintenance of the Park resources and public access
12 areas. No expenditure shall be made pursuant to this sec-
13 tion unless the Secretary determines that such an expendi-
14 ture is consistent with the purposes of this Act.

15 **SEC. 12. COOPERATIVE AGREEMENTS.**

16 (a) **IN GENERAL.**—In order to further the purposes
17 of this Act, the Secretary is authorized to enter into coop-
18 erative agreements with interested public and private enti-
19 ties and individuals (including the National Trust for His-
20 toric Preservation, Belle Grove, Inc., the Cedar Creek Bat-
21 tlefield Foundation, the Shenandoah Valley Battlefields
22 Foundation, and the Counties of Frederick, Shenandoah,
23 and Warren), through technical and financial assistance,
24 including encouraging the conservation of historic and
25 natural resources within and near the Park.

1 (b) **TECHNICAL AND FINANCIAL ASSISTANCE.**—The
 2 Secretary may provide to any person, organization, or gov-
 3 ernmental entity technical and financial assistance for the
 4 purposes of this Act, including the following:

5 (1) Preserving historic structures within the
 6 Park.

7 (2) Maintaining the natural or cultural land-
 8 scape of the Park.

9 (3) Local preservation planning, interpretation,
 10 and management of public visitation for the Park.

11 (4) Furthering the goals of the Shenandoah
 12 Valley Battlefields Foundation and National His-
 13 toric District Management Plan.

14 **SEC. 13. ROLES OF KEY PARTNER ORGANIZATIONS.**

15 (a) **IN GENERAL.**—In recognition that central por-
 16 tions of the Park are presently owned and operated for
 17 the benefit of the public by key partner organizations, the
 18 Secretary shall acknowledge and support the continued
 19 participation of these partner organizations in the man-
 20 agement of the Park.

21 (b) **PARK PARTNERS.**—Roles of the current key part-
 22 ners include the following:

23 (1) **CEDAR CREEK BATTLEFIELD FOUNDA-**
 24 **TION.**—The Cedar Creek Battlefield Foundation
 25 may—

1 (A) continue to own, operate, and manage
2 the lands acquired by the Foundation within
3 the Park;

4 (B) continue to conduct reenactments and
5 other events within the Park; and

6 (C) transfer ownership interest in portions
7 of their land to the National Park Service by
8 donation, sale, or other means that meet the
9 legal requirements of National Park Service
10 land acquisitions.

11 (2) NATIONAL TRUST FOR HISTORIC PRESERVA-
12 TION AND BELLE GROVE INCORPORATED.—The Na-
13 tional Trust for Historic Preservation and Bell
14 Grove Incorporated may continue to own, operate,
15 and manage Belle Grove Plantation and its struc-
16 tures and grounds within the Park boundary. Belle
17 Grove Incorporated may continue to own the house
18 and grounds known as Bowman's Fort or Harmony
19 Hall for the purpose of permanent preservation, with
20 a long-term goal of opening the property to the pub-
21 lic.

22 (3) SHENANDOAH COUNTY.—Shenandoah
23 County may continue to own, operate, and manage
24 the Keister park site within the Park for the benefit
25 of the public.

1 (4) GATEWAY COMMUNITIES.—The adjacent
2 historic towns of Strasburg and Middletown shall be
3 acknowledged as Gateway Communities to the Park.

4 (5) SHENANDOAH VALLEY BATTLEFIELDS
5 FOUNDATION.—The Shenandoah Valley Battlefields
6 Foundation may continue to administer and manage
7 the Shenandoah Valley Battlefields National His-
8 toric District in partnership with the National Park
9 Service and in accordance with the Management
10 Plan for the District in which the Park is located.

11 **SEC. 14. AUTHORIZATION OF APPROPRIATIONS.**

12 There is authorized to be appropriated such sums as
13 are necessary to carry out this Act.

14 **SECTION 1. SHORT TITLE.**

11 *in the Shenandoah Valley Battlefields National His-*
12 *toric District representing key Civil War battles in*
13 *the Shenandoah Valley, including those battlefields as-*
14 *sociated with the Thomas J. (Stonewall) Jackson*
15 *campaign of 1862 and the decisive campaigns of*
16 *1864.*

24 Creek Battlefield and the 1864 Valley Campaign, has
25 acquired 308 acres of land within the boundaries of

1 *the National Historic Landmark. The foundation an-*
2 *nually hosts a major re-enactment and living history*
3 *event on the Cedar Creek Battlefield.*

4 (5) *Belle Grove Plantation is a Historic Site of*

10 **SEC. 4. DEFINITIONS.**

20 (3) *PARK.*—*The term “Park” means the Cedar*
21 *Creek and Belle Grove National Historical Park es-*
22 *tablished under section 5 and depicted on the Map.*

23 (4) *SECRETARY.*—*The term “Secretary” means*
24 *the Secretary of the Interior.*

1 **SEC. 5. ESTABLISHMENT OF CEDAR CREEK AND BELLE**
2 **GROVE NATIONAL HISTORICAL PARK.**

3 (a) *ESTABLISHMENT.*—*There is established the Cedar*
4 *Creek and Belle Grove National Historical Park, consisting*
5 *of approximately 3,000 acres, as generally depicted on the*
6 *Map.*

7 (b) *AVAILABILITY OF MAP.*—*The Map shall be on file*
8 *and available for public inspection in the offices of the Na-*
9 *tional Park Service, Department of the Interior.*

10 **SEC. 6. ACQUISITION OF PROPERTY.**

11 (a) *REAL PROPERTY.*—*The Secretary may acquire*
12 *land or interests in land within the boundaries of the Park,*
13 *from willing sellers only, by donation, purchase with do-*
14 *nated or appropriated funds, or exchange.*

15 (b) *BOUNDARY REVISION.*—*After acquiring land for*
16 *the Park, the Secretary shall—*

17 (1) *revise the boundary of the Park to include*
18 *newly acquired land within the boundary; and*

19 (2) *administer newly acquired land subject to*
20 *applicable laws (including regulations).*

21 (c) *PERSONAL PROPERTY.*—*The Secretary may ac-*
22 *quire personal property associated with, and appropriate*
23 *for, interpretation of the Park.*

24 (d) *CONSERVATION EASEMENTS AND COVENANTS.*—
25 *The Secretary is authorized to acquire conservation ease-*
26 *ments and enter into covenants regarding lands in or adja-*

1 *cent to the Park from willing sellers only. Such conservation*
2 *easements and covenants shall have the effect of protecting*
3 *the scenic, natural, and historic resources on adjacent lands*
4 *and preserving the natural or historic setting of the Park*
5 *when viewed from within or outside the Park.*

6 *(e) SUPPORT FACILITIES.—The National Park Service*
7 *is authorized to acquire from willing sellers, land outside*
8 *the Park boundary but in close proximity to the Park, for*
9 *the development of visitor, administrative, museum, curato-*
10 *rial, and maintenance facilities.*

11 **SEC. 7. ADMINISTRATION.**

12 *The Secretary shall administer the Park in accordance*
13 *with this Act and the provisions of law generally applicable*
14 *to units of the National Park System, including—*

15 *(1) the Act entitled “An Act to establish a Na-*
16 *tional Park Service, and for other purposes”, ap-*
17 *proved August 25, 1916 (16 U.S.C. 1 et seq.); and*

18 *(2) the Act entitled “An Act to provide for the*
19 *preservation of historic American sites, buildings, ob-*
20 *jects, and antiquities of national significance, and for*
21 *other purposes”, approved August 21, 1935 (16*
22 *U.S.C. 461 et seq.).*

23 **SEC. 8. MANAGEMENT OF PARK.**

24 *(a) MANAGEMENT PLAN.—The Secretary, in consulta-*
25 *tion with the Commission, shall prepare a management*

1 *plan for the Park. In particular, the management plan*
2 *shall contain provisions to address the needs of owners of*
3 *non-Federal land, including independent nonprofit organi-*
4 *zations within the boundaries of the Park.*

5 (b) *SUBMISSION OF PLAN TO CONGRESS.—Not later*
6 *than 3 years after the date of the enactment of this Act,*
7 *the Secretary shall submit the management plan for the*
8 *Park to the Committee on Resources of the House of Rep-*
9 *resentatives and the Committee on Energy and Natural Re-*
10 *sources of the Senate.*

11 **SEC. 9. CEDAR CREEK AND BELLE GROVE NATIONAL HIS-**
12 **TORICAL PARK ADVISORY COMMISSION.**

13 (a) *ESTABLISHMENT.—There is established the Cedar*
14 *Creek and Belle Grove National Historical Park Advisory*
15 *Commission.*

16 (b) *DUTIES.—The Commission shall—*

17 (1) *advise the Secretary in the preparation and*
18 *implementation of a general management plan de-*
19 *scribed in section 8; and*

20 (2) *advise the Secretary with respect to the iden-*
21 *tification of sites of significance outside the Park*
22 *boundary deemed necessary to fulfill the purposes of*
23 *this Act.*

24 (c) *MEMBERSHIP.—*

1 (1) *COMPOSITION.*—*The Commission shall be*
2 *composed of 15 members appointed by the Secretary*
3 *so as to include the following:*

4 (A) *1 representative from the Common-*
5 *wealth of Virginia.*

6 (B) *1 representative each from the local 20*
7 *governments of Strasburg, Middletown, Frederick*
8 *County, Shenandoah County, and Warren Coun-*
9 *ty.*

10 (C) *2 representatives of private landowners*
11 *within the Park.*

12 (D) *1 representative from a citizen interest*
13 *group.*

14 (E) *1 representative from the Cedar Creek*
15 *Battlefield Foundation.*

16 (F) *1 representative from Belle Grove, In-*
17 *corporated.*

18 (G) *1 representative from the National*
19 *Trust for Historic Preservation.*

20 (H) *1 representative from the Shenandoah*
21 *Valley Battlefields Foundation.*

22 (I) *1 ex-officio representative from the Na-*
23 *tional Park Service.*

24 (J) *1 ex-officio representative from the*
25 *United States Forest Service.*

1 (2) *CHAIRPERSON.*—*The Chairperson of the*
2 *Commission shall be elected by the members to serve*
3 *a term of one year renewable for one additional year.*

4 (3) *VACANCIES.*—*A vacancy on the Commission*
5 *shall be filled in the same manner in which the origi-*
6 *nal appointment was made.*

7 (4) *TERMS OF SERVICE.*—

8 (A) *IN GENERAL.*—*Each member shall be*
9 *appointed for a term of 3 years and may be re-*
10 *appointed for not more than 2 successive terms.*

11 (B) *INITIAL MEMBERS.*—*Of the members*
12 *first appointed under paragraph (1), the Sec-*
13 *retary shall appoint—*

14 (i) *4 members for a term of 1 year;*

15 (ii) *5 members for a term of 2 years;*

16 *and*

17 (iii) *6 members for a term of 3 years.*

18 (5) *EXTENDED SERVICE.*—*A member may serve*
19 *after the expiration of that member's term until a*
20 *successor has taken office.*

21 (6) *MAJORITY RULE.*—*The Commission shall act*
22 *and advise by affirmative vote of a majority of its*
23 *members.*

1 (7) *MEETINGS.*—*The Commission shall meet at*
2 *least quarterly at the call of the chairperson or a ma-*
3 *jority of the members of the Commission.*

4 (8) *QUORUM.*—*8 members shall constitute a*
5 *quorum.*

6 (d) *COMPENSATION.*—*Members shall serve without*
7 *pay. Members who are full-time officers or employees of the*
8 *United States, the Commonwealth of Virginia, or any polit-*
9 *ical subdivision thereof shall receive no additional pay on*
10 *account of their service on the Commission.*

11 (e) *TRAVEL EXPENSES.*—*While away from their homes*
12 *or regular places of business in the performance of service*
13 *for the Commission, members shall be allowed travel ex-*
14 *penses, including per diem in lieu of subsistence, in the*
15 *same manner as persons employed intermittently in the*
16 *Government service are allowed expenses under section 5703*
17 *of title 5, United States Code.*

18 (f) *HEARINGS; PUBLIC INVOLVEMENT.*—*The Commis-*
19 *sion may, for purposes of carrying out this Act, hold such*
20 *hearings, sit and act at such times and places, take such*
21 *public testimony, and receive such evidence, as the Commis-*
22 *sion considers appropriate. The Commission may not issue*
23 *subpoenas or exercise any subpoena authority.*

1 **SEC. 10. CONSERVATION OF CEDAR CREEK AND BELLE**
2 **GROVE NATIONAL HISTORICAL PARK.**

3 (a) *ENCOURAGEMENT OF CONSERVATION.*—The Sec-
4 retary and the Commission shall encourage conservation of
5 the historic and natural resources within and in proximity
6 of the Park by landowners, local governments, organiza-
7 tions, and businesses.

8 (b) *PROVISION OF TECHNICAL ASSISTANCE.*—The Sec-
9 retary may provide technical assistance to local govern-
10 ments, in cooperative efforts which complement the values
11 of the Park.

12 (c) *COOPERATION BY FEDERAL AGENCIES.*—Any Fed-
13 eral entity conducting or supporting activities directly af-
14 fecting the Park shall consult, cooperate, and, to the max-
15 imum extent practicable, coordinate its activities with the
16 Secretary in a manner that—

17 (1) *is consistent with the purposes of this Act*
18 *and the standards and criteria established pursuant*
19 *to the general management plan developed pursuant*
20 *to section 8;*

21 (2) *is not likely to have an adverse effect on the*
22 *resources of the Park; and*

23 (3) *is likely to provide for full public participa-*
24 *tion in order to consider the views of all interested*
25 *parties.*

1 **SEC. 11. ENDOWMENT.**

2 (a) *IN GENERAL.*—*In accordance with the provisions*
3 *of subsection (b), the Secretary is authorized to receive and*
4 *expend funds from an endowment to be established with the*
5 *National Park Foundation, or its successors and assigns.*

6 (b) *CONDITIONS.*—*Funds from the endowment referred*
7 *to in subsection (a) shall be expended exclusively as the Sec-*
8 *retary, in consultation with the Commission, may designate*
9 *for the interpretation, preservation, and maintenance of the*
10 *Park resources and public access areas. No expenditure*
11 *shall be made pursuant to this section unless the Secretary*
12 *determines that such expenditure is consistent with the pur-*
13 *poses of this Act.*

14 **SEC. 12. COOPERATIVE AGREEMENTS.**

15 (a) *IN GENERAL.*—*In order to further the purposes of*
16 *this Act, the Secretary is authorized to enter into coopera-*
17 *tive agreements with interested public and private entities*
18 *and individuals (including the National Trust for Historic*
19 *Preservation, Belle Grove, Inc., the Cedar Creek Battlefield*
20 *Foundation, the Shenandoah Valley Battlefields Founda-*
21 *tion, and the Counties of Frederick, Shenandoah, and War-*
22 *ren), through technical and financial assistance, including*
23 *encouraging the conservation of historic and natural re-*
24 *sources of the Park.*

25 (b) *TECHNICAL AND FINANCIAL ASSISTANCE.*—*The*
26 *Secretary may provide to any person, organization, or gov-*

1 *ernmental entity technical and financial assistance for the*
 2 *purposes of this Act, including the following:*

3 (1) *Preserving historic structures within the*
 4 *Park.*

5 (2) *Maintaining the natural or cultural land-*
 6 *scape of the Park.*

7 (3) *Local preservation planning, interpretation,*
 8 *and management of public visitation for the Park.*

9 (4) *Furthering the goals of the Shenandoah Val-*
 10 *ley Battlefields Foundation related to the Park.*

11 **SEC. 13. ROLES OF KEY PARTNER ORGANIZATIONS.**

12 (a) *IN GENERAL.*—*In recognition that central portions*
 13 *of the Park are presently owned and operated for the benefit*
 14 *of the public by key partner organizations, the Secretary*
 15 *shall acknowledge and support the continued participation*
 16 *of these partner organizations in the management of the*
 17 *Park.*

18 (b) *PARK PARTNERS.*—*Roles of the current key part-*
 19 *ners include the following:*

20 (1) *CEDAR CREEK BATTLEFIELD FOUNDATION.*—

21 *The Cedar Creek Battlefield Foundation may—*

22 (A) *continue to own, operate, and manage*
 23 *the lands acquired by the Foundation with the*
 24 *Park;*

1 (B) continue to conduct re-enactments and
2 other events within the Park; and

3 (C) transfer ownership interest in portions
4 of their land to the National Park Service by do-
5 nation, sale, or other means that meet the legal
6 requirements of National Park Service land ac-
7 quisitions.

8 (2) NATIONAL TRUST FOR HISTORIC PRESERVA-
9 TION AND BELLE GROVE INCORPORATED.—The Na-
10 tional Trust for Historic Preservation and Belle
11 Grove Incorporated may continue to own, operate,
12 and manage Belle Grove Plantation and its structures
13 and grounds within the Park boundary. Belle Grove
14 Incorporated may continue to own the house and
15 grounds known as Bowman’s Fort or Harmony Hall
16 for the purpose of permanent preservation, with a
17 long-term goal of opening the property to the public.

18 (3) SHENANDOAH COUNTY.—Shenandoah County
19 may continue to own, operate, and manage the Keis-
20 ter park site within the Park for the benefit of the
21 public.

22 (4) PARK COMMUNITY PARTNERS.—The Sec-
23 retary shall cooperate with the Park’s adjacent his-
24 toric towns of Strasburg and Middletown, Virginia,

1 *as well as Frederick, Shenandoah, and Warren coun-*
2 *ties in furthering the purposes of the Park.*

3 (5) *SHENANDOAH VALLEY BATTLEFIELDS FOUN-*
4 *DATION.—The Shenandoah Valley Battlefields Foun-*
5 *dation may continue to administer and manage the*
6 *Shenandoah Valley Battlefields National Historic*
7 *District in partnership with the National Park Serv-*
8 *ice and in accordance with the Management Plan for*
9 *the District in which the Park is located.*

10 **SEC. 14. AUTHORIZATION OF APPROPRIATIONS.**

11 *There is authorized to be appropriated such sums as*
12 *are necessary to carry out this Act.*
