## A BILL

To authorize the President to award posthumously the Congressional Gold Medal to the passengers and crew of

United Airlines flight 93 in the aftermath of the terrorist attack on the United States on September 11, 2001.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Honoring the Pas-  
5 sengers and Crew of United Flight 93 Act”.

6 **SEC. 2. FINDINGS.**

7        Congress finds that—

8            (1) on September 11, 2001, United Airlines  
9        Flight 93 took off at 8:44 a.m. from Newark, New  
10        Jersey, destined for San Francisco, California;

11            (2) the plane was hijacked by 4 terrorists short-  
12        ly after it took off;

13            (3) it is widely presumed that the terrorists who  
14        took control of United Airlines Flight 93 intended to  
15        use the aircraft as a weapon and crash it into the  
16        United States Capitol Building in Washington, D.C.;

17            (4) the passengers and crew of United Airlines  
18        Flight 93 learned from cellular phone conversations  
19        with their loved ones of the fate of the 3 other air-  
20        craft that were hijacked earlier that same day and  
21        used as weapons to murder thousands of innocent  
22        people and destroy American landmarks;

23            (5) the passengers and crew of United Airlines  
24        Flight 93, recognizing the potential danger that the

1 aircraft they were aboard posed to large numbers of  
2 innocent Americans, American institutions, and the  
3 symbols of American democracy, took heroic and  
4 noble action to ensure that the aircraft they were  
5 aboard could not be used as a weapon;

6 (6) the 40 passengers and crew of United Air-  
7 lines Flight 93, in the ultimate act of selfless cour-  
8 age and supreme sacrifice, fought to recapture their  
9 flight from the terrorists; and

10 (7) the struggle of the crew and passengers of  
11 United Airlines Flight 93 against the terrorists  
12 caused the Boeing 757 to crash down in a sparsely  
13 populated area near Shanksville, Pennsylvania at  
14 10:10 a.m., September 11, 2001, possibly saving  
15 countless lives in the Nation's Capital.

16 **SEC. 3. CONGRESSIONAL GOLD MEDAL.**

17 (a) PRESENTATION AUTHORIZED.—

18 (1) IN GENERAL.—The President is authorized,  
19 on behalf of Congress, to award posthumously a gold  
20 medal of appropriate design to each of—

21 (A) the United Airlines Flight 93 crew  
22 members—

5 (B) the United Airlines Flight 93

15 (2) MODALITIES.—The modalities of presen-  
16 tation of the medals struck under this Act shall be  
17 determined by the President, after consultation with  
18 the Speaker of the House of Representatives, the  
19 Majority Leader of the Senate, the Minority Leader  
20 of the Senate, and the Minority Leader of the House  
21 of Representatives.

22 (b) DESIGN AND STRIKING.—For purposes of the  
23 presentation referred to in subsection (a), the Secretary  
24 of the Treasury (in this Act referred to as the “Sec-  
25 retary”) shall strike gold medals with suitable emblems,

1 devices, and inscriptions, to be determined by the Sec-  
2 retary.

3 **SEC. 4. STATUS AS NATIONAL MEDALS.**

4       The medals struck under this Act are national medals  
5 for purposes of chapter 51 of title 31, United States Code.

6 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

7       There are authorized to be appropriated to the Sec-  
8 retary such sums as may be necessary to carry out this  
9 Act.
