RESOLUTION

Expressing the sense of the Senate regarding the success of the Varela Project's collection of 10,000 certified signatures in support of a national referendum and the delivery of these signatures to the Cuban National Assembly.

Whereas Article 88 of the Cuban Constitution states that the Cuban National Assembly should schedule a national ref-

erendum if it receives the verified signatures of 10,000 legal voters;

Whereas on May 10, 2002, a group of Cuban citizens led by Oswaldo Paya delivered 11,020 verified signatures to the Cuban National Assembly in support of a referendum;

Whereas Mr. Paya's petition drive is inspired by the 19th-century priest and Cuban independence hero, Padre Felix Varela, and is known as the Varela Project;

Whereas the Varela Project seeks a referendum on civil liberties, including freedom of speech, amnesty for political prisoners, support for private business, a new electoral law, and a general election;

Whereas the Varela Project is supported by 140 opposition organizations in Cuba and has received no money or support from foreign citizens or foreign governments;

Whereas the Varela Project is the largest petition drive in Cuban history;

Whereas the Varela Project seeks amnesty for all of those who have been detained, sanctioned, or jailed for political motives and who have not participated in acts directly threatening the lives of others;

Whereas the Varela Project seeks to guarantee citizens the right to form private businesses, to carry out economic activities that could be productive and of service, and to establish contracts between workers and businesses for the development of these businesses in fair and just conditions so that no one may obtain profits by exploiting the work of others;

Whereas the Varela Project is a step in moving Cuba toward achieving international standards for human rights;

Whereas the goal of United States policy in Cuba is to promote a peaceful transition to democracy through an active policy of supporting the forces of change on the island; and

Whereas the Varela Project is engaged in the promotion of a peaceful transition to democracy in Cuba: Now, therefore, be it

Whereas Article 88 of the Cuban Constitution provides for Cuban citizens to submit legislative proposals to the Cuban National Assembly for its consideration;

Whereas on May 10, 2002, a group of Cuban citizens led by Oswaldo Paya delivered 11,020 verified signatures to the Cuban National Assembly in support of a referendum;

2 (1) supports the constitutional right of the citi-
3 zens of Cuba who have signed the Varela Project to
4 petition the Cuban National Assembly for a ref-
5 erendum;

6 (2) calls on the Cuban government to accept
7 the Varela Project petition and, in accordance with
8 its obligation under Article 88 of the Cuban Con-
9 stitution, to hold a referendum on civil liberties, in-
10 cluding freedom of speech, an amnesty for political
11 prisoners, support for private business, a new elec-
12 toral law, and a general election;

13 (3) praises the bravery of Oswaldo Paya and
14 his colleagues in collecting 11,020 verified signatures
15 in support of the Varela Project;

16 (4) calls on the Cuban government to provide
17 its citizens with internationally accepted standards
18 for civil and human rights, and the opportunity to
19 vote in free and fair elections;

20 (5) urges the President and his representatives
21 to take all appropriate steps to support the Varela
22 Project and any future efforts by the Cuban people

1 to assert their constitutional right to petition the
2 National Assembly in support of a referendum; and

8 SEC. 2. The Secretary of the Senate shall transmit

11 *(1) supports the constitutional right of the citi-*
12 *zens of Cuba who have signed the Varela Project to*
13 *petition the Cuban National Assembly for a ref-*
14 *erendum;*

15 *(2) calls on the Cuban National Assembly to give*
16 *serious consideration to the Varela Project petition in*
17 *accordance with Article 88 of the Cuban Constitution*
18 *and to the holding of a referendum on civil liberties,*
19 *including freedom of speech, an amnesty for political*
20 *prisoners, support for private business, a new elec-*
21 *toral law, and a general election;*

22 *(3) praises the bravery of Oswaldo Paya and his*
23 *colleagues in collecting 11,020 verified signatures in*
24 *support of the Varela Project;*

1 (4) calls on the Cuban government to provide its
2 citizens with internationally accepted standards for
3 civil and human rights, and the opportunity to vote
4 in free and fair elections; and

5 (5) urges the President to support the right of the
6 citizens of Cuba who have signed the Varela Project
7 to petition the Cuban National Assembly for a ref-
8 erendum and the peaceful transition to democracy.

9 SEC. 2. The Secretary of the Senate shall transmit a
