CONCURRENT RESOLUTION

1 *Resolved by the House of Representatives (the Senate*
2 *concurring)*, That when the House adjourns on any legisla-
3 tive day from Friday, November 21, 2003, through Fri-
4 day, November 28, 2003, on a motion offered pursuant
5 to this concurrent resolution by its Majority Leader or his

1 designee, it stand adjourned until 2 p.m. on Tuesday, De-
2 cember 2, 2003, or until the time of any reassembly pursu-
3 ant to section 2 of this concurrent resolution, whichever
4 occurs first; that when the House adjourns on any legisla-
5 tive day from Tuesday, December 2, 2003, through the
6 remainder of the first session of the One Hundred Eighth
7 Congress, on a motion offered pursuant to this concurrent
8 resolution by its Majority Leader or his designee, it stand
9 adjourned sine die, or until the time of any reassembly
10 pursuant to section 2 of this concurrent resolution, which-
11 ever occurs first; that when the Senate recesses or ad-
12 journals at the close of business on any day from Friday,
13 November 21, 2003, through Friday, November 28, 2003,
14 on a motion offered pursuant to this concurrent resolution
15 by its Majority Leader or his designee, it stand recessed
16 or adjourned until noon on Tuesday, December 2, 2003,
17 or at such other time on that day as may be specified by
18 its Majority Leader or his designee in the motion to recess
19 or adjourn, or until the time of any reassembly pursuant
20 to section 2 of this concurrent resolution, whichever occurs
21 first; and that when the Senate adjourns at the close of
22 business on any day from Tuesday, December 2, 2003,
23 through the remainder of the first session of the One Hun-
24 dred Eighth Congress, on a motion offered pursuant to
25 this concurrent resolution by its Majority Leader or his

1 designee, it stand adjourned sine die, or until the time of
2 any reassembly pursuant to section 2 of this concurrent
3 resolution, whichever occurs first.

4 SEC. 2. The Speaker of the House and the Majority
5 Leader of the Senate, or their respective designees, acting
6 jointly after consultation with the Minority Leader of the
7 House and the Minority Leader of the Senate, shall notify
8 the Members of the House and the Senate, respectively,
9 to reassemble at such place and time as they may des-
10 ignate whenever, in their opinion, the public interest shall
11 warrant it.
