Mr. TIAHRT (for himself, Mr. RYUN of Kansas, Mr. MORAN of Kansas, and Mr. MOORE) submitted the following concurrent resolution; which was referred to the Committee on House Administration

CONCURRENT RESOLUTION

Providing for the acceptance of a statue of President Dwight D. Eisenhower, presented by the people of Kansas, for placement in the Capitol, and for other purposes.

Whereas Dwight D. Eisenhower gave a lifetime of service to the Nation as a military officer, leader of the victorious Allied armies in World War II, first supreme commander of the North Atlantic Treaty Organization, and as President of the United States;

Whereas Dwight D. Eisenhower was raised in Abilene, Kansas;

Whereas Dwight D. Eisenhower was the 34th President of the United States from 1953 to 1961, and during his presidency he saw the end of the Korean War, main-

tained peace during the Cold War, desegregated the military, marking the beginning of the modern civil rights movement, and implemented the interstate highway program, among other accomplishments;

Whereas Dwight D. Eisenhower and his wife Mamie are buried in the Place of Meditation, on the grounds of the Eisenhower Center and Presidential Library and Museum in Abilene, Kansas, a premier historical institution recognized around the world; and

Whereas the great State of Kansas desires to honor its most famous son for his many contributions and to keep his legacy alive for future generations: Now, therefore, be it

1 *Resolved by the House of Representatives (the Senate*
2 *concurring),*

3 **SECTION 1. ACCEPTANCE OF STATUE OF DWIGHT D. EISEN-**
4 **HOWER FROM THE PEOPLE OF KANSAS FOR**
5 **PLACEMENT IN THE CAPITOL.**

6 (a) IN GENERAL.—The statue of Dwight D. Eisen-
7 hower, furnished by the people of Kansas for placement
8 in the Capitol in accordance with section 1814 of the Re-
9 vised Statutes of the United States (40 U.S.C. 187), is
10 accepted in the name of the United States, and the thanks
11 of Congress are extended to the people of Kansas for pro-
12 viding this commemoration of one of the most eminent
13 persons from Kansas.

14 (b) PRESENTATION CEREMONY.—The State of Kan-
15 sas is authorized to use the Rotunda of the Capitol on
16 June 4, 2003, for a presentation ceremony for the statue.

1 The Architect of the Capitol and the Capitol Police Board
2 shall take such action as may be necessary with respect
3 to physical preparations and security for the ceremony.

4 (c) DISPLAY IN ROTUNDA.—The statue shall be dis-
5 played in the Rotunda of the Capitol for a period of not
6 more than 6 months, after which time the statue shall be
7 moved to its permanent location.

8 **SEC. 2. TRANSMITTAL TO GOVERNOR OF KANSAS.**

9 The Clerk of the House of Representatives shall
10 transmit a copy of this resolution to the Governor of Kan-
11 sas.
