## AN ACT

To revise the boundary of the Petrified Forest National  
Park in the State of Arizona, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Petrified Forest Na-  
3 tional Park Expansion Act of 2004”.

4 **SEC. 2. DEFINITIONS.**

5 In this Act:

6 (1) MAP.—The term “map” means the map en-  
7 titled “Proposed Boundary Adjustments, Petrified  
8 Forest National Park”, numbered 110/80,044, and  
9 dated June 2004.

10 (2) PARK.—The term “Park” means the Pet-  
11 rified Forest National Park in the State.

12 (3) SECRETARY.—The term “Secretary” means  
13 the Secretary of the Interior.

14 (4) STATE.—The term “State” means the State  
15 of Arizona.

16 **SEC. 3. BOUNDARY REVISION.**

17 (a) IN GENERAL.—The Secretary is authorized to re-  
18 vise the boundary of the Park to include approximately  
19 125,000 acres as depicted on the map.

20 (b) AVAILABILITY OF MAP.—The map shall be on file  
21 and available for public inspection in the appropriate of-  
22 fices of the National Park Service.

23 **SEC. 4. ACQUISITION OF ADDITIONAL LAND.**

24 (a) PRIVATE LAND.—The Secretary may acquire  
25 from a willing seller, by donation, purchase with donated  
26 or appropriated funds, or exchange, any private land or

1 interests in private land within the revised boundary of  
2 the Park. In acquiring private land and interests in pri-  
3 vate land within the revised boundary of the Park, the  
4 Secretary shall undertake to acquire such private land and  
5 interests in private land first by donation or exchange.

6 (b) STATE LAND.—

7 (1) IN GENERAL.—The Secretary may, with the  
8 consent of the State and in accordance with Federal  
9 and State law, acquire from the State any State  
10 land or interests in State land within the revised  
11 boundary of the Park.

12 (2) PLAN.—Not later than 3 years after the  
13 date of the enactment of this Act, the Secretary  
14 shall, in coordination with the State, develop a plan  
15 for acquisition for State land or interests in State  
16 land under paragraph (1).

17 (3) MANAGEMENT AGREEMENT.—If the Sec-  
18 retary is unable to acquire the State land under  
19 paragraph (1) within the 3-year period required by  
20 paragraph (2), the Secretary may enter into an  
21 agreement that would allow the National Park Serv-  
22 ice to manage State land within the revised bound-  
23 ary of the Park.

1 **SEC. 5. ADMINISTRATION.**

2 (a) IN GENERAL.—Subject to applicable laws, all  
3 land and interests in land acquired under this Act shall  
4 be administered by the Secretary as part of the Park.

5 (b) TRANSFER OF JURISDICTION.—The Secretary  
6 shall transfer to the National Park Service administrative  
7 jurisdiction over any land under the jurisdiction of the  
8 Secretary that—

9 (1) is depicted on the map as being within the  
10 boundaries of the Park; and

11 (2) is not under the administrative jurisdiction  
12 of the National Park Service on the date of enact-  
13 ment of this Act.

14 (c) EXCHANGE AFTER ENACTMENT.—Upon comple-  
15 tion of an exchange of land after the date of the enactment  
16 of this Act, the Secretary shall transfer administrative ju-  
17 risdiction over the exchanged lands within the boundary  
18 of the Park as depicted on the map to the National Park  
19 Service.

20 (d) GRAZING.—

21 (1) IN GENERAL.—The Secretary shall permit  
22 the continuation of grazing on land transferred to  
23 the Secretary under this Act, subject to applicable  
24 laws, regulations, and Executive orders.

25 (2) TERMINATION OF LEASES OR PERMITS.—  
26 Nothing in this subsection prohibits the Secretary

1 from accepting the voluntary termination of a graz-  
2 ing permit or grazing lease within the Park.

3 (e) AMENDMENT TO GENERAL MANAGEMENT  
4 PLAN.—Not later than 3 years after the date of the enact-  
5 ment of this Act, the Secretary shall amend the general  
6 management plan for the Park to address the use and  
7 management of any additional land acquired under this  
8 Act.

9 **SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

10 There are authorized to be appropriated such sums  
11 as are necessary to carry out this Act.
