A BILL

To reauthorize the Temporary Assistance for Needy Families block grant program through fiscal year 2003, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Welfare Reform Exten-
5 sion Act of 2003”.

6 **SEC. 2. REFERENCES.**

7 Except as otherwise expressly provided, wherever in
8 this Act an amendment or repeal is expressed in terms

1 of an amendment to, or repeal of, a section or other provi-
2 sion, the amendment or repeal shall be considered to be
3 made to a section or other provision of the Social Security
4 Act.

5 **SEC. 3. CONTINUATION OF TANF BLOCK GRANT FUNDING.**

6 (a) STATE FAMILY ASSISTANCE GRANT.—Section
7 403(a)(1) (42 U.S.C. 603(a)(1)) is amended—

8 (1) in subparagraph (A), by striking “and
9 2002” and inserting “2002, and 2003”; and

10 (2) by striking subparagraphs (B) through (E)
11 and inserting the following:

12 “(B) STATE FAMILY ASSISTANCE
13 GRANT.—The State family assistance grant
14 payable to a State for a fiscal year shall be the
15 amount that bears the same ratio to the
16 amount specified in subparagraph (C) of this
17 paragraph as the amount required to be paid to
18 the State under this paragraph for fiscal year
19 2002 (determined without regard to any reduc-
20 tion pursuant to section 409 or 412(a)(1))
21 bears to the total amount required to be paid
22 under this paragraph for fiscal year 2002 (as so
23 determined).

24 “(C) APPROPRIATION.—Out of any money
25 in the Treasury of the United States not other-

1 wise appropriated, there are appropriated for
2 fiscal year 2003 \$16,566,542,000 for grants
3 under this paragraph.”.

4 (b) MATCHING GRANTS FOR THE TERRITORIES.—
5 Section 1108(b)(2) (42 U.S.C. 1308(b)(2)) is amended by
6 striking “2002” and inserting “2003”.

7 (c) BONUS TO REWARD DECREASE IN ILLEGITIMACY
8 RATIO.—Section 403(a)(2) (42 U.S.C. 603(a)(2)) is
9 amended—

10 (1) in subparagraph (C)(ii), by striking “and
11 2002” and inserting “2002, and 2003”; and

12 (2) in subparagraph (D), by striking “2002”
13 and inserting “2003”.

14 (d) SUPPLEMENTAL GRANTS FOR POPULATION IN-
15 CREASES IN CERTAIN STATES.—Section 403(a)(3)(H) (42
16 U.S.C. 603(a)(3)(H)) is amended—

17 (1) in the subparagraph heading, by striking
18 “of grants for fiscal year 2002”;

19 (2) in clause (i), by striking “fiscal year 2002”
20 and inserting “each of fiscal years 2002 and 2003”;

21 (3) in clause (ii), by striking “2002” and in-
22 serting “2003”; and

23 (4) in clause (iii), by striking “fiscal year
24 2002” and inserting “each of fiscal years 2002 and
25 2003”.

1 (e) CONTINGENCY FUND.—

2 (1) IN GENERAL.—Section 403(b)(2) (42
3 U.S.C. 603(b)(2)) is amended by striking “and
4 2002” and inserting “2002, and 2003”.

5 (2) CONFORMING AMENDMENT.—Section
6 403(b)(3)(C)(ii) (42 U.S.C. 603(b)(3)(C)(ii)) is
7 amended by striking “2002” and inserting “2003”.

8 (f) FEDERAL LOANS FOR STATE WELFARE PRO-
9 GRAMS.—Section 406(d) (42 U.S.C. 606(d)) is amended
10 by striking “2002” and inserting “2003”.

11 (g) MAINTENANCE OF EFFORT.—Section 409(a)(7)
12 (42 U.S.C. 609(a)(7)) is amended—

13 (1) in subparagraph (A), by striking “or 2003”
14 and inserting “2003, or 2004”; and

15 (2) in subparagraph (B)(ii), by striking “2002”
16 and inserting “2003”.

17 (h) GRANTS TO INDIAN TRIBES.—Paragraphs (1)(A)
18 and (2)(A) of section 412(a) (42 U.S.C. 612(a)(1)(A) and
19 (2)(A)) are each amended by striking “and 2002” and in-
20 serting “2002, and 2003”.

21 (i) CENSUS BUREAU STUDY.—Section 414(b) (42
22 U.S.C. 614(b)) is amended by striking “and 2002” and
23 inserting “2002, and 2003”.

1 **SEC. 4. CONTINUATION OF MANDATORY CHILD CARE**
2 **FUNDING.**

3 Section 418(a)(3)(F) (42 U.S.C. 618(a)(3)(F)) is
4 amended by striking “fiscal year 2002” and inserting
5 “each of fiscal years 2002 and 2003”.

6 **SEC. 5. CONTINUATION OF CHILD WELFARE DEMONSTRATION**
7 **AUTHORITY.**

8 Section 1130(a)(2) (42 U.S.C. 1320a-9(a)(2)) is
9 amended by striking “2002” and inserting “2003”.

10 **SEC. 6. CONTINUATION OF ABSTINENCE EDUCATION FUND-**
11 **ING.**

12 Section 510(d) (42 U.S.C. 710(d)) is amended by
13 striking “2002” and inserting “2003”.

14 **SEC. 7. CONTINUATION OF TRANSITIONAL MEDICAL AS-**
15 **SISTANCE.**

16 (a) IN GENERAL.—Section 1925(f) (42 U.S.C.
17 1396r-6(f)) is amended by striking “2002” and inserting
18 “2003”.

19 (b) CONFORMING AMENDMENT.—Section
20 1902(e)(1)(B) (42 U.S.C. 1396a(e)(1)(B)) is amended by
21 striking “2002” and inserting “2003”.

22 **SEC. 8. EFFECTIVE DATE.**

23 The amendments made by this Act shall take effect
24 on July 1, 2003.
