Mr. MORAN of Kansas (for himself, Mr. SMITH of New Jersey, Mr. EVANS, Mr. FILNER, and Mr. GUTIERREZ) introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to provide for the appointment of chiropractors in the Veterans Health Administration of the Department of Veterans Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Department of Vet-
5 erans Affairs Chiropractic Employment Act”.

1 **SEC. 2. APPOINTMENT OF CHIROPRACTORS IN THE VET-**
2 **ERANS HEALTH ADMINISTRATION.**

3 (a) APPOINTMENTS.—Section 7401 of title 38,
4 United States Code, is amended—

5 (1) by inserting “and chiropractic care” in the
6 matter preceding paragraph (1) after “medical
7 care”; and

8 (2) by inserting “chiropractors” in paragraph
9 (1) after “podiatrists”.

10 (b) QUALIFICATIONS OF APPOINTEES.—Section
11 7402(b) of such title is amended—

12 (1) by redesignating paragraph (10) as para-
13 graph (11); and

14 (2) by inserting after paragraph (9) the fol-
15 lowing new paragraph (10):

16 “(10) CHIROPRACTOR.—To be eligible to be ap-
17 pointed to a chiropractor position, a person must—

18 “(A) hold the degree of doctor of chiropractic,
19 or its equivalent, from a college of chiropractic ap-
20 proved by the Secretary; and

21 “(B) be licensed to practice chiropractic in a
22 State.”.

23 (c) PERIOD OF APPOINTMENTS AND PROMOTIONS.—
24 Section 7403(a)(2) of such title is amended by adding at
25 the end the following new subparagraph:

26 “(H) Chiropractors.”.

1 (d) GRADES AND PAY SCALES.—Section 7404(b)(1)
2 of such title is amended by striking the third center head-
3 ing in the table and inserting the following:

“CLINICAL PODIATRIST, CHIROPRACTOR, AND OPTOMETRIST
SCHEDULE”.

4 (e) TEMPORARY AND PART-TIME APPOINTMENTS.—
5 Section 7405(a) of such title is amended—

6 (1) by adding at the end of paragraph (1) the
7 following new subparagraph:

8 “(E) Chiropractors.”; and

9 (2) by adding at the end of paragraph (2) the
10 following new subparagraph:

11 “(D) Chiropractors.”.

12 (f) RESIDENCIES AND INTERNSHIPS.—Section
13 7406(c) of such title is amended—

14 (1) in paragraph (1)—

15 (A) by inserting “and chiropractic” after
16 “medical” the first place it appears; and

17 (B) by inserting “or chiropractic” after
18 “medical” the second place it appears;

19 (2) in paragraph (2), by inserting “or chiro-
20 practic” after “medical” in the matter preceding
21 subparagraph (A) and in subparagraph (B);

22 (3) in paragraph (3), by inserting “or chiro-
23 practic” after “medical” in subparagraph (A); and

1 (4) in paragraph (4), by inserting “or chiro-
2 practic” after “medical” in subparagraph (C).

3 (g) MALPRACTICE AND NEGLIGENCE PROTECTION.—

4 Section 7316(a) of such title is amended—

5 (1) by inserting “or chiropractic” after “med-
6 ical” in paragraphs (1) and (2); and

7 (2) by inserting “chiropractor,” after “podia-
8 trist,” in paragraph (2).

9 (h) TREATMENT AS SCARCE MEDICAL SPECIALISTS
10 FOR CONTRACTING PURPOSES.—Section 7409(a) of such
11 title is amended by inserting “chiropractors,” in the sec-
12 ond sentence after “optometrists,”.

13 (i) REIMBURSEMENT OF CONTINUING PROFES-
14 SIONAL EDUCATION EXPENSES.—Section 7411 of such
15 title is amended by striking “or dentist” and inserting “,
16 dentist, or chiropractic”.

17 (j) COLLECTIVE BARGAINING EXEMPTION.—Section
18 7421(b) of such title is amended by adding at the end
19 the following new paragraph:

20 “(8) Chiropractors.”.

21 (k) EFFECTIVE DATE.—The amendments made by
22 this section shall take effect at the end of the 180-day
23 period beginning on the date of the enactment of this Act.
