14 *SECTION. 1. GROSS RATE OF COMPENSATION IN OF-*
 15 *FICES OF SENATORS. Effective on and after October 1, 2003,*
 16 *each of the dollar amounts contained in the table under sec-*
 17 *tion 105(d)(1)(A) of the Legislative Branch Appropriations*
 18 *Act, 1968 (2 U.S.C. 61-1(d)(1)(A)) shall be deemed to be*
 19 *the dollar amounts in that table, as adjusted by law and*
 20 *in effect on September 30, 2003, increased by an additional*
 21 *\$50,000 each.*

22 *SEC. 2. PAYMENT OF EXPENSES OF CONFERENCES OF*
 23 *MAJORITY AND MINORITY. (a) IN GENERAL.—Section 120*
 24 *of Public Law 97-51 (2 U.S.C. 61g-6) is amended in the*
 25 *first sentence by striking “an amount, not in excess of*
 26 *\$100,000,” and inserting “such amount as necessary”.*

1 (b) *EFFECTIVE DATE.*—*This section shall apply with*
2 *respect to fiscal year 2004, and each fiscal year thereafter.*

3 *SEC. 3. PROVISIONS RELATING TO SENATE COMMIS-*
4 *SION ON ART. (a) AUTHORITY TO ACQUIRE AND DIS-*
5 *POSE.*—

6 (1) *IN GENERAL.*—*The Senate Commission on*
7 *Art (referred to in this section as the “Commission”)*
8 *may—*

9 (A) *accept gifts of money; and*

10 (B) *acquire (by gift, purchase, or otherwise)*
11 *any work of art, historical object, document, or*
12 *material relating to historical matters, or ex-*
13 *hibit, for placement or exhibition in the Senate*
14 *Wing of the Capitol, the Senate Office Buildings,*
15 *or in rooms, spaces, or corridors thereof.*

16 (2) *ACCESSION OR DISPOSAL.*—*All works of art,*
17 *historical objects, documents, or material related to*
18 *historical matters, or exhibits, acquired by the Com-*
19 *mission may, as determined by the Commission and*
20 *after consultation with the Curatorial Advisory*
21 *Board, be—*

22 (A) *retained for accession to the United*
23 *States Senate Collection or other use; or*

24 (B) *disposed of by sale or other transaction.*

1 (3) *REPEAL.*—*Senate Resolution 95, 92d Con-*
2 *gress, agreed to April 1, 1971, and enacted into law*
3 *by section 901(a) of Public Law 100–696 (2 U.S.C.*
4 *2106) is repealed.*

5 (b) *ADVISORY BOARDS.*—

6 (1) *CURATORIAL ADVISORY BOARD.*—*There is es-*
7 *tablished a Board which shall be chaired by the Sen-*
8 *ate Curator. The Curatorial Advisory Board shall*
9 *provide advice and assistance to the Commission on*
10 *the acquisition, care, and disposition of items for or*
11 *within the United States Senate Collection, and on*
12 *such other matters as the Commission determines ap-*
13 *propriate.*

14 (2) *ADDITIONAL ADVISORY BOARDS.*—

15 (A) *IN GENERAL.*—*The Commission, or the*
16 *chairman and vice chairman acting jointly on*
17 *behalf of the Commission and after giving notice*
18 *to the Commission, may establish 1 or more ad-*
19 *ditional advisory boards.*

20 (B) *TERM.*—*The term of existence for an*
21 *additional advisory board—*

22 (i) *shall be specified by the Commis-*
23 *sion but no longer than 4 years; and*

24 (ii) *shall be renewable.*

1 (C) *PURPOSE.*—*The purpose of an addi-*
2 *tional advisory board shall be to provide advice*
3 *and assistance to the Commission and to further*
4 *the purposes of the Commission.*

5 (3) *APPOINTMENTS.*—

6 (A) *IN GENERAL.*—*Subject to subparagraph*
7 *(B), the Curatorial Advisory Board and other*
8 *advisory boards established by the Commission*
9 *under paragraph (2) shall be composed of mem-*
10 *bers appointed by the Commission, or the chair-*
11 *man and vice chairman acting jointly on behalf*
12 *of the Commission and after giving notice to the*
13 *Commission.*

14 (B) *APPLICABLE RULES.*—*Members ap-*
15 *pointed under subparagraph (A)—*

16 (i) *shall be appointed from public and*
17 *private life and shall serve at the pleasure*
18 *of the Commission; and*

19 (ii) *in the case of individuals ap-*
20 *pointed to the Curatorial Advisory Board,*
21 *shall be experts or have significant experi-*
22 *ence in the field of arts, historic preserva-*
23 *tion, or other appropriate fields.*

24 *Each member of the Commission may have ap-*
25 *pointed to an advisory board created by the*

1 *Commission at least 1 individual requested by*
2 *that member.*

3 (4) *MEMBERS.*—*A member of a board under this*
4 *subsection—*

5 (A) *may, at the discretion of the Commis-*
6 *sion, be reimbursed for actual and necessary ex-*
7 *penditures incurred in the performance of the official*
8 *duties of the board from any funds available to*
9 *the Commission in accordance with applicable*
10 *Senate regulations for such expenses; and*

11 (B) *shall not, by virtue of such member's*
12 *service on the board, be deemed to be an officer,*
13 *employee, or agent of the Senate and may not*
14 *bind the Senate in any contract or obligation.*

15 (5) *TERMS FOR ADDITIONAL ADVISORY BOARD*
16 *MEMBERS.*—*Members appointed to the other advisory*
17 *boards created under paragraph (2) shall serve for*
18 *terms as stated in their appointment, but no longer*
19 *than a term of 4 years, except that any member may*
20 *be reappointed upon the expiration of their term.*

21 (6) *REGULATIONS.*—*The Commission, or the*
22 *chairman and vice chairman acting jointly on behalf*
23 *of the Commission and after giving notice to the Com-*
24 *mission, in consultation with the Committee on Rules*
25 *and Administration, may promulgate such regula-*

1 *tions governing advisory boards established under this*
2 *subsection as are necessary to carry out the purposes*
3 *of this subsection.*

4 (7) *ASSISTANCE.*—*The Executive Secretary of the*
5 *Commission shall provide assistance to an advisory*
6 *board as authorized by the Commission.*

7 (c) *ESTABLISHMENT OF SENATE PRESERVATION*
8 *FUND.*—

9 (1) *ESTABLISHMENT.*—*There is established in*
10 *the Treasury a fund, to be known as the “Senate*
11 *Preservation Fund” (in this section referred to as the*
12 *“fund”), which shall consist of amounts deposited and*
13 *credited under paragraph (3).*

14 (2) *PAYMENT OF COSTS.*—*The fund shall be*
15 *available to the Commission for the payment of acqui-*
16 *sition and transaction costs incurred for acquisitions*
17 *under subsection (a), for official activities of any ad-*
18 *visory board established under subsection (b), and for*
19 *any purposes for which funds from the contingent*
20 *fund of the Senate may be used under section 316(a)*
21 *of Public Law 101–302 (2 U.S.C. 2107).*

22 (3) *DEPOSITS, CREDITS, AND DISBURSEMENTS.*—

23 (A) *DEPOSITS.*—*The Commission shall de-*
24 *posit in the fund amounts appropriated for use*

1 *of the fund, gifts of money, and proceeds of*
2 *transactions under subsection (a).*

3 *(B) CREDITS.—The Secretary of the Treas-*
4 *ury shall credit to the fund the interest on, and*
5 *the proceeds from sale or redemption of, obliga-*
6 *tions held in the fund.*

7 *(C) DISBURSEMENTS.—Disbursements from*
8 *the fund shall be made on vouchers approved by*
9 *the Commission and signed by the Executive*
10 *Secretary of the Commission.*

11 *(4) INVESTMENTS.—*

12 *(A) IN GENERAL.—The Secretary of the*
13 *Treasury shall invest any portion of the fund*
14 *that, as determined by the Commission, is not*
15 *required to meet current withdrawals.*

16 *(B) TYPE OF OBLIGATION.—Each invest-*
17 *ment required by this paragraph shall be made*
18 *in an interest bearing obligation of the United*
19 *States or an obligation guaranteed as to the*
20 *principal and interest by the United States that,*
21 *as determined by the Commission, has a matu-*
22 *rity suitable for the fund.*

23 *(C) COMMISSION APPROVAL.—In carrying*
24 *out this subsection, the Secretary of the Treasury*
25 *may make such purchases, sales, and redemption*

1 *of obligations as may be approved by the Com-*
2 *mission.*

3 (5) *SERVICES AND SUPPORT.*—*The Library of*
4 *Congress shall provide financial management and*
5 *disbursing services and support to the Commission as*
6 *may be required and mutually agreed to by the Li-*
7 *brarian of Congress and the Executive Secretary of*
8 *the Commission.*

9 (6) *AUDITS.*—*The Comptroller General of the*
10 *United States shall conduct annual audits of the Sen-*
11 *ate Preservation Fund and shall report the results of*
12 *each audit to the Commission.*

13 (d) *ADMINISTRATIVE CHANGES.*—

14 (1) *SENATE COMMISSION ON ART.*—*Section 1 of*
15 *Senate Resolution 382, 90th Congress, agreed to Octo-*
16 *ber 1, 1968, and enacted into law by section 901(a)*
17 *of Public Law 100–696 (2 U.S.C. 2101) is*
18 *amended—*

19 (A) *in subsection (b), by striking the first*
20 *sentence and inserting “The Majority Leader*
21 *and Minority Leader of the Senate shall be the*
22 *chairman and vice chairman, respectively, of the*
23 *Commission.”; and*

24 (B) *by striking subsection (c) and inserting*
25 *the following:*

1 “(c) *The Secretary of the Senate shall appoint a Sen-*
2 *ate Curator approved by the Senate Commission on Art.*
3 *The Senate Curator shall be an employee of the Secretary*
4 *of the Senate assigned to assist the Commission. The Sec-*
5 *retary of the Senate shall assign additional employees to*
6 *assist the Commission, and provide such other assistance,*
7 *as the Commission determines necessary.”.*

8 (2) *PURCHASE OF ART.—The first sentence of*
9 *section 316(a) of Public Law 101–302 (2 U.S.C.*
10 *2107(a)) is amended by inserting after “in which in-*
11 *curring,” the following: “for the purchase of art and*
12 *historical objects for the United States Senate Collec-*
13 *tion, for exhibits and public education relating to the*
14 *United States Senate Collection, for administrative*
15 *and transitional expenses of the Senate Commission*
16 *on Art, and”.*

17 *SEC. 4. ORIENTATION SEMINARS. The first sentence of*
18 *section 107(a) of the Supplemental Appropriations Act,*
19 *1979 (Public Law 96–38; 2 U.S.C. 69a) is amended by*
20 *striking “\$10,000” and inserting “\$25,000”.*

21 *SEC. 5. EXPENSE ALLOWANCES FOR CERTAIN OFFI-*
22 *CERS OF THE SENATE. (a) IN GENERAL.—Section 119(a)*
23 *of the joint resolution entitled “Joint resolution making*
24 *continuing appropriations for the fiscal year 1982, and for*

1 *other purposes*”, approved October 1, 1981 (2 U.S.C. 65c)
 2 *is amended by striking “\$3,000” and inserting “\$6,000”.*

3 (b) *EFFECTIVE DATE.*—*The amendment made by this*
 4 *section shall apply with respect to fiscal year 2004, and*
 5 *each fiscal year thereafter.*

6 *SEC. 6. CONSULTANTS.* *With respect to fiscal year*
 7 *2004, the first sentence of section 101(a) of the Supple-*
 8 *mental Appropriations Act, 1977 (2 U.S.C. 61h–6(a)) shall*
 9 *be applied by substituting “nine individual consultants”*
 10 *for “eight individual consultants”.*

14 *JOINT CONGRESSIONAL COMMITTEE ON INAUGURAL*
 15 *CEREMONIES OF 2005*

16 *For all construction expenses, salaries, and other ex-*
 17 *penses associated with conducting the inaugural ceremonies*
 18 *of the President and Vice President of the United States,*
 19 *January 20, 2005, in accordance with such program as*
 20 *may be adopted by the joint congressional committee au-*
 21 *thorized to conduct the inaugural ceremonies of 2005,*
 22 *\$1,250,000 to be disbursed by the Secretary of the Senate*
 23 *and to remain available until September 30, 2005. Funds*
 24 *made available under this heading shall be available for*

 2 *the compensation of any employee of the Committee on*

 9 *when appropriate) out of funds made available under this*
 10 *heading.*

11 *JOINT ECONOMIC COMMITTEE*

12 *For salaries and expenses of the Joint Economic Com-*
 13 *mittee, \$3,988,000, to be disbursed by the Secretary of the*
 14 *Senate.*

15 *JOINT COMMITTEE ON TAXATION*

16 *For salaries and expenses of the Joint Committee on*
 17 *Taxation, \$8,112,000, to be disbursed by the Chief Adminis-*
 18 *trative Officer of the House.*

19 *For other joint items, as follows:*

20 *OFFICE OF THE ATTENDING PHYSICIAN*

21 *For medical supplies, equipment, and contingent ex-*
 22 *penses of the emergency rooms, and for the Attending Physi-*
 23 *cian and his assistants, including: (1) an allowance of*
 24 *\$2,175 per month to the Attending Physician; (2) an allow-*
 25 *ance of \$725 per month each to 4 medical officers while*

1 *on duty in the Office of the Attending Physician; (3) an*
2 *allowance of \$725 per month to 2 assistants and \$580 per*
3 *month each not to exceed 11 assistants on the basis here-*
4 *tofore provided for such assistants; and (4) \$1,566,000 for*
5 *reimbursement to the Department of the Navy for expenses*
6 *incurred for staff and equipment assigned to the Office of*
7 *the Attending Physician, which shall be advanced and cred-*
8 *ited to the applicable appropriation or appropriations from*
9 *which such salaries, allowances, and other expenses are pay-*
10 *able and shall be available for all the purposes thereof,*

13 *CAPITOL GUIDE SERVICE AND SPECIAL SERVICES OFFICE*

14 *For salaries and expenses of the Capitol Guide Service*
15 *and Special Services Office, \$3,511,000, to be disbursed by*
16 *the Secretary of the Senate: Provided, That no part of such*
17 *amount may be used to employ more than 70 individuals:*
18 *Provided further, That the Capitol Guide Board is author-*
19 *ized, during emergencies, to employ not more than 2 addi-*
20 *tional individuals for not more than 120 days each, and*
21 *not more than 10 additional individuals for not more than*
22 *6 months each, for the Capitol Guide Service.*

23 *STATEMENTS OF APPROPRIATIONS*

24 *For the preparation, under the direction of the Com-*
25 *mittees on Appropriations of the Senate and the House of*

1 *Representatives, of the statements for the 1st session of the*
2 *108th Congress, showing appropriations made, indefinite*
3 *appropriations, and contracts authorized, together with a*
4 *chronological history of the regular appropriations bills as*
5 *required by law, \$30,000, to be paid to the persons des-*
6 *ignated by the chairmen of such committees to supervise*
7 *the work.*

8 *CAPITOL POLICE*

9 *SALARIES*

10 *For salaries of employees of the Capitol Police, includ-*
11 *ing overtime, hazardous duty pay differential, and Govern-*
12 *ment contributions for health, retirement, social security,*
13 *and other applicable employee benefits, \$207,000,000, to be*
14 *disbursed by the Chief of the Capitol Police or his designee.*

15 *GENERAL EXPENSES*

16 *For necessary expenses of the Capitol Police, including*
17 *motor vehicles, communications and other equipment, secu-*
18 *rity equipment and installation, uniforms, weapons, sup-*
19 *plies, materials, training, medical services, forensic services,*
20 *stenographic services, personal and professional services, the*
21 *employee assistance program, the awards program, postage,*
22 *communication services, travel advances, relocation of in-*
23 *structor and liaison personnel for the Federal Law Enforce-*
24 *ment Training Center, and not more than \$5,000 to be ex-*
25 *pendent on the certification of the Chief of the Capitol Police*

1 *in connection with official representation and reception ex-*
 2 *penses, \$33,000,000, of which \$1,700,000 shall remain*
 3 *available until expended, to be disbursed by the Chief of*
 4 *the Capitol Police or his designee: Provided, That, notwith-*
 5 *standing any other provision of law, the cost of basic train-*
 6 *ing for the Capitol Police at the Federal Law Enforcement*
 7 *Training Center for fiscal year 2004 shall be paid by the*
 8 *Secretary of Homeland Security from funds available to the*
 9 *Department of Homeland Security.*

10 *ADMINISTRATIVE PROVISIONS*

11 *(INCLUDING TRANSFER OF FUNDS)*

12 *SEC. 1001. TRANSFER AUTHORITY. Amounts appro-*
 13 *priated for fiscal year 2004 for the Capitol Police may be*
 14 *transferred between the headings “SALARIES” and “GEN-*
 15 *ERAL EXPENSES” upon the approval of the Committees on*
 16 *Appropriations of the Senate and the House of Representa-*
 17 *tives.*

18 *SEC. 1002. AUTHORIZATION OF WEAPONS. Section*
 19 *1824 of the Revised Statutes (2 U.S.C. 1941) is amended—*

20 *(1) in the first sentence—*

21 *(A) by striking “The Sergeant at Arms of*
 22 *the Senate and the Sergeant at Arms of the*
 23 *House of Representatives” and inserting “The*
 24 *Capitol Police Board”; and*

1 (B) by striking all beginning with “payable
2 out” through the period and inserting “payable
3 from appropriations to the Capitol Police upon
4 certification of payment by the Chief of the Cap-
5 itol Police.”; and

6 (2) in the second sentence—

7 (A) by inserting “or other arms as author-
8 ized by the Capitol Police Board” after “fur-
9 nished”; and

10 (B) by striking “the Sergeant at Arms of
11 the Senate and the Sergeant at Arms of the
12 House of Representatives” and inserting “the
13 Capitol Police Board”.

14 SEC. 1003. LEGAL REPRESENTATION AUTHORITY. (a)
15 IN GENERAL.—

16 (1) AUTHORIZATION OF REPRESENTATION.—Any
17 counsel described under paragraph (2) may for the
18 purposes of providing legal assistance and representa-
19 tion to the United States Capitol Police Board or the
20 United States Capitol Police enter an appearance in
21 any proceeding before any court of the United States
22 or of any State or political subdivision thereof, with-
23 out compliance with any requirement for admission
24 to practice before such court.

10 *clearing buffer zones around highly populous communities*
