A BILL

To improve homeland security, public safety, and citizen activated emergency response capabilities through the use of enhanced 911 wireless services, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “E-911 Implementation*
 5 *Act of 2003”.*

6 **SEC. 2. COORDINATION OF E-911 IMPLEMENTATION.**

7 *Part C of title I of the National Telecommunications*
 8 *and Information Administration Organization Act (47*
 9 *U.S.C. 901 et seq.) is amended by adding at the end the*
 10 *following:*

11 **“SEC. 158. COORDINATION OF E-911 IMPLEMENTATION.**

12 *“(a) E-911 IMPLEMENTATION COORDINATION OF-*
 13 *FICE.—*

14 *“(1) ESTABLISHMENT.—The Assistant Secretary*
 15 *shall establish an E-911 Implementation Coordina-*
 16 *tion Office to facilitate coordination and communica-*
 17 *tion between Federal, State, and local emergency com-*
 18 *munications systems, emergency personnel, public*

1 *safety organizations, telecommunications carriers,*
2 *and telecommunications equipment manufacturers*
3 *and vendors involved in the implementation of E-911*
4 *services.*

5 “(2) *PURPOSE OF OFFICE.*—*The Office shall—*

6 “(A) *take actions, in concert with coordina-*
7 *tors designated in accordance with subsection*
8 *(b)(3)(A)(ii), to improve such coordination and*
9 *communication;*

10 “(B) *develop, collect, and disseminate infor-*
11 *mation concerning practices, procedures, and*
12 *technology used in the implementation of E-911*
13 *services;*

14 “(C) *advise and assist eligible entities in*
15 *the preparation of implementation plans re-*
16 *quired under subsection (b)(3)(A)(iii);*

17 “(D) *receive, review, and recommend the*
18 *approval or disapproval of applications for*
19 *grants under subsection (b); and*

20 “(E) *oversee the use of funds provided by*
21 *such grants in fulfilling such implementation*
22 *plans.*

23 “(3) *REPORTS.*—*The Assistant Secretary shall*
24 *provide an annual report to Congress by the first day*
25 *of October of each year on the activities of the Office*

1 *to improve coordination and communication with re-*
2 *spect to the implementation of E-911 services.*

3 *“(b) PHASE II E-911 IMPLEMENTATION GRANTS.—*

4 *“(1) MATCHING GRANTS.—The Assistant Sec-*
5 *retary, after consultation with the Secretary of Home-*
6 *land Security and the Chairman of the Federal Com-*
7 *munications Commission, and acting through the Of-*
8 *fice, shall provide grants to eligible entities for the*
9 *implementation of phase II E-911 services through*
10 *planning, infrastructure improvements, telecommuni-*
11 *cations equipment purchases, and personnel training.*

12 *“(2) MATCHING REQUIREMENT.—The Federal*
13 *share of the cost of a project eligible for a grant under*
14 *this section shall not exceed 50 percent. The non-Fed-*
15 *eral share of the cost shall be provided from non-Fed-*
16 *eral sources.*

17 *“(3) COORDINATION REQUIRED.—In providing*
18 *grants under paragraph (1), the Assistant Secretary*
19 *shall require an eligible entity to certify in its appli-*
20 *cation that—*

21 *“(A) in the case of an eligible entity that is*
22 *a State government, the entity—*

23 *“(i) has coordinated its application*
24 *with the public safety answering points (as*
25 *such term is defined in section 222(h)(4) of*

1 *the Communications Act of 1934) located*
2 *within the jurisdiction of such entity;*

3 “(ii) *has designated a single officer or*
4 *governmental body of the entity to serve as*
5 *the coordinator of implementation of E-911*
6 *services, except that such designation need*
7 *not vest such coordinator with direct legal*
8 *authority to implement E-911 services or*
9 *manage emergency communications oper-*
10 *ations;*

11 “(iii) *has established a plan for the co-*
12 *ordination and implementation of E-911*
13 *services; and*

14 “(iv) *has integrated telecommuni-*
15 *cations services involved in the implementa-*
16 *tion and delivery of phase II E-911 serv-*
17 *ices; or*

18 “(B) *in the case of an eligible entity that is*
19 *not a State, the entity has complied with clauses*
20 *(i), (iii), and (iv) of subparagraph (A), and the*
21 *State in which it is located has complied with*
22 *clause (ii) of such subparagraph.*

23 “(4) *CRITERIA.—The Assistant Secretary shall*
24 *issue regulations within 180 days of the enactment of*
25 *the E-911 Implementation Act of 2003, after a public*

1 *comment period of not less than 60 days, prescribing*
2 *the criteria for selection for grants under this section,*
3 *and shall update such regulations as necessary.*

4 *“(c) DIVERSION OF E-911 CHARGES.—*

5 *“(1) DESIGNATED E-911 CHARGES.—For the*
6 *purposes of this subsection, the term ‘designated E-*
7 *911 charges’ means any taxes, fees, or other charges*
8 *imposed by a State or other taxing jurisdiction*
9 *that—*

10 *“(A) appear on telecommunications services*
11 *customers’ bills; and*

12 *“(B) are designated or presented as dedi-*
13 *cated to deliver or improve E-911 services.*

14 *“(2) CERTIFICATION.—Each applicant for a*
15 *matching grant under this section shall certify to the*
16 *Assistant Secretary at the time of application, and*
17 *each applicant that receives such a grant shall certify*
18 *to the Assistant Secretary annually thereafter during*
19 *any period of time during which the funds from the*
20 *grant are available to the applicant, that no portion*
21 *of any designated E-911 charges imposed by a State*
22 *or other taxing jurisdiction within which the appli-*
23 *cant is located are being obligated or expended for*
24 *any purpose other than the purposes for which such*
25 *charges are designated or presented.*

1 “(3) *CONDITION OF GRANT.*—Each applicant for
2 a grant under this section shall agree, as a condition
3 of receipt of the grant, that if the State or other tax-
4 ing jurisdiction within which the applicant is located,
5 during any period of time during which the funds
6 from the grant are available to the applicant, obli-
7 gates or expends designated E-911 charges for any
8 purpose other than the purposes for which such
9 charges are designated or presented, all of the funds
10 from such grant shall be returned to the Secretary.

11 “(4) *PENALTY FOR PROVIDING FALSE INFORMA-*
12 *TION.*—Any applicant that provides a certification
13 under paragraph (1) knowing that the information
14 provided in the certification was false shall—

15 “(A) not be eligible to receive the grant
16 under subsection (b);

17 “(B) return any grant awarded under sub-
18 section (b) during the time that the certification
19 was not valid; and

20 “(C) not be eligible to receive any subse-
21 quent grants under subsection (b).

22 “(d) *AUTHORIZATION; TERMINATION.*—

23 “(1) *AUTHORIZATION.*—There are authorized to
24 be appropriated to the Department of Commerce not

1 *more than \$100,000,000 for each of the fiscal years*
2 *2004 through 2008 for grants under this section.*

3 *“(2) TERMINATION.—The provisions of this sec-*
4 *tion shall cease to be effective on October 1, 2008.*

5 *“(e) DEFINITIONS.—As used in this section:*

6 *“(1) OFFICE.—The term ‘Office’ means the E-*
7 *911 Implementation Coordination Office.*

8 *“(2) ELIGIBLE ENTITY.—*

9 *“(A) IN GENERAL.—The term ‘eligible enti-*
10 *ty’ means a State or local government or a tribal*
11 *organization (as defined in section 4(l) of the In-*
12 *dian Self-Determination and Education Assist-*
13 *ance Act (25 U.S.C. 450b(l)).*

14 *“(B) INSTRUMENTALITIES.—Such term in-*
15 *cludes public authorities, boards, commissions,*
16 *and similar bodies created by one or more eligi-*
17 *ble entities described in subparagraph (A) to*
18 *provide E-911 services.*

19 *“(C) EXCEPTION.—Such term does not in-*
20 *clude any entity that has failed to submit the*
21 *most recently required certification under sub-*
22 *section (c) within 30 days after the date on*
23 *which such certification is due.*

24 *“(3) E-911 SERVICES.—The term ‘E-911 serv-*
25 *ices’ means both phase I and phase II enhanced 911*

1 *services, as described in section 20.18 of the Commis-*
2 *sion’s regulations (47 CFR 20.18), as in effect on the*
3 *date of enactment of this section, or as subsequently*
4 *revised by the Federal Communications Commission.*

5 “(4) *PHASE II E-911 SERVICES.*—*The term*
6 *‘phase II E-911 services’ means only phase II en-*
7 *hanced 911 services, as described in such section 20.18*
8 *(47 CFR 20.18), as in effect on such date, or as subse-*
9 *quently revised by the Federal Communications Com-*
10 *mission.’.*”

11 **SEC. 3. REPORT ON THE DEPLOYMENT OF E-911 PHASE II**
12 **SERVICES BY TIER III SERVICE PROVIDERS.**

13 *Within 90 days after the date of enactment of this Act,*
14 *the Federal Communications Commission shall submit a re-*
15 *port to the Committee on Energy and Commerce of the*
16 *House of Representatives and the Committee on Commerce,*
17 *Science, and Transportation of the Senate detailing—*

18 (1) *the number of tier III commercial mobile*
19 *service providers that are offering phase II E-911*
20 *services;*

21 (2) *the number of requests for waivers from com-*
22 *pliance with the Commission’s phase II E-911 service*
23 *requirements received by the Commission from such*
24 *tier III providers;*

1 (3) *the number of waivers granted or denied by*
2 *the Commission to such tier III providers;*

3 (4) *how long each waiver request remained pend-*
4 *ing before it was granted or denied;*

5 (5) *how many waiver requests are pending at the*
6 *time of the filing of the report;*

7 (6) *when the pending requests will be granted or*
8 *denied;*

9 (7) *actions the Commission has taken to reduce*
10 *the amount of time a waiver request remains pend-*
11 *ing; and*

12 (8) *the technologies that are the most effective in*
13 *the deployment of phase II E-911 services by such*
14 *tier III providers.*
