## A BILL

To designate the Federal building located at 324 Twenty-Fifth Street in Ogden, Utah, as the “James V. Hansen Federal Building”.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SEC. 1. DESIGNATION.**

2 The Federal building located at ~~324 Twenty-Fifth~~  
3 Street in Ogden, Utah, shall be known and designated as  
4 the “James V. Hansen Federal Building”.

5 **SEC. 2. REFERENCES.**

6 Any reference in a law, map, regulation, document,  
7 paper, or other record of the United States to the Federal  
8 building referred to in section 1 shall be deemed to be  
9 a reference to the “James V. Hansen Federal Building”.

10 **SEC. 3. EFFECTIVE DATE.**

11 This Act shall take effect on January 1, 2004.

12 **SECTION 1. DESIGNATION.**

13 *The Federal building located at 324 Twenty-Fifth*  
14 *Street in Ogden, Utah, shall be known and designated as*  
15 *the “James V. Hansen Federal Building”.*

16 **SEC. 2. REFERENCES.**

17 *Any reference in a law, map, regulation, document,*  
18 *paper, or other record of the United States to the Federal*  
19 *building referred to in section 1 shall be deemed to be a*  
20 *reference to the “James V. Hansen Federal Building”.*
