A BILL

To authorize the exchange of certain land in Everglades National Park.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. EVERGLADES NATIONAL PARK.**

2 *Section 102 of the Everglades National Park Protec-*
3 *tion and Expansion Act of 1989 (16 U.S.C. 410r-6) is*
4 *amended—*

5 *(1) in subsection (a)—*

6 *(A) by striking “The park boundary” and*
7 *inserting the following:*

8 *“(1) IN GENERAL.—The park boundary”;*

9 *(B) by striking “The map” and inserting*
10 *the following:*

11 *“(2) AVAILABILITY OF MAP.—The map”;* and

12 *(C) by adding at the end the following:*

13 *“(3) ACQUISITION OF ADDITIONAL LAND.—*

14 *“(A) IN GENERAL.—The Secretary may ac-*
15 *quire from 1 or more willing sellers not more*
16 *than 10 acres of land located outside the bound-*
17 *ary of the park and adjacent to or near the East*
18 *Everglades area of the park for the development*
19 *of administrative, housing, maintenance, or*
20 *other park purposes.*

21 *“(B) ADMINISTRATION; APPLICABLE LAW.—*

22 *On acquisition of the land under subparagraph*
23 *(A), the land shall be administered as part of the*
24 *park in accordance with the laws (including reg-*
25 *ulations) applicable to the park.”;* and

26 *(2) by adding at the end the following:*

1 “(h) *LAND EXCHANGES.*—

2 “(1) *DEFINITIONS.*—*In this subsection:*

3 “(A) *ADMINISTRATOR.*—*The term ‘Adminis-*
4 *trator’ means the Administrator of General Serv-*
5 *ices.*

6 “(B) *COUNTY.*—*The term ‘County’ means*
7 *Miami-Dade County, Florida.*

8 “(C) *COUNTY LAND.*—*The term ‘County*
9 *land’ means the 2 parcels of land owned by the*
10 *County totaling approximately 152.93 acres that*
11 *are designated as ‘Tract 605–01’ and ‘Tract*
12 *605–03’.*

13 “(D) *DISTRICT.*—*The term ‘District’ means*
14 *the South Florida Water Management District.*

15 “(E) *DISTRICT LAND.*—*The term ‘District*
16 *land’ means the approximately 1,054 acres of*
17 *District land located in the Southern Glades*
18 *Wildlife and Environmental Area and identified*
19 *on the map as ‘South Florida Water Manage-*
20 *ment District Exchange Lands’.*

21 “(F) *GENERAL SERVICES ADMINISTRATION*
22 *LAND.*—*The term ‘General Services Administra-*
23 *tion land’ means the approximately 595.28 acres*
24 *of land designated as ‘Site Alpha’ that is de-*

1 *clared by the Department of the Navy to be ex-*
2 *cess land.*

3 “(G) *MAP.*—*The term ‘map’ means the map*
4 *entitled ‘Boundary Modification for C-111*
5 *Project, Everglades National Park’, numbered*
6 *160/80,007, and dated April 30, 2002.*

7 “(H) *NATIONAL PARK SERVICE LAND.*—*The*
8 *term ‘National Park Service land’ means the ap-*
9 *proximately 1,054 acres of land located in the*
10 *Rocky Glades area of the park and identified on*
11 *the map as ‘NPS Exchange Lands’.*

12 “(2) *EXCHANGE OF GENERAL SERVICES ADMINIS-*
13 *TRATION LAND AND COUNTY LAND.*—*The Adminis-*
14 *trator shall convey to the County fee title to the Gen-*
15 *eral Services Administration land in exchange for the*
16 *conveyance by the County to the Secretary of fee title*
17 *to the County land.*

18 “(3) *EXCHANGE OF NATIONAL PARK SERVICE*
19 *LAND AND DISTRICT LAND.*—

20 “(A) *IN GENERAL.*—*As soon as practicable*
21 *after the completion of the exchange under para-*
22 *graph (2), the Secretary shall convey to the Dis-*
23 *trict fee title to the National Park Service land*
24 *in exchange for fee title to the District land.*

1 “(B) *USE OF NATIONAL PARK SERVICE*
2 *LAND.—The National Park Service land con-*
3 *veyed to the District shall be used by the District*
4 *for the purposes of the C-111 project, including*
5 *restoration of the Everglades natural system.*

6 “(C) *BOUNDARY ADJUSTMENT.—On comple-*
7 *tion of the land exchange under subparagraph*
8 *(A), the Secretary shall modify the boundary of*
9 *the park to reflect the exchange of the National*
10 *Park Service land and the District land.*

11 “(4) *AVAILABILITY OF MAP.—The map shall be*
12 *on file and available for public inspection in the ap-*
13 *propriate offices of the National Park Service.”.*

14 **SEC. 2. BIG CYPRESS NATIONAL PRESERVE.**

15 *Subsection (d)(3) of the first section of Public Law 93–*
16 *440 (16 U.S.C. 698f) is amended by striking “The amount*
17 *described in paragraph (1)” and inserting “The amount de-*
18 *scribed in paragraph (2)”.*
