A BILL

To amend the Small Tracts Act to facilitate the exchange of small tracts of land, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FACILITATION OF EXCHANGE OF SMALL**
4 **TRACTS.**

5 (a) EXPANSION OF AVAILABILITY OF LANDS FOR
6 SALE OR EXCHANGE.—Section 3 of Public Law 97–465
7 (16 U.S.C. 521e; section 3 of the Act commonly known
8 as the Small Tracts Act) is amended—

1 (1) by striking “not practicable” and inserting
2 “either not practicable or not expedient”;

3 (2) by striking “, which have a value as deter-
4 mined by the Secretary of not more than
5 \$150,000,”; and

6 (3) in paragraph (1)—

7 (A) by striking “parcels of forty acres”
8 and inserting “parcels or portions of parcels of
9 100 acres”; and

10 (B) by striking “under the mining laws”.

11 (b) RULES OR REGULATIONS NOT REQUIRED.—

12 Nothing in the amendments made by this Act shall require
13 the Forest Service to issue rules or regulations prior to
14 any sale, exchange, or interchange under Public Law 97–
15 465 (16 U.S.C. 521c et seq.).

16 (c) SPECIAL CASES.—The Forest Supervisor may
17 complete the following interchanges under Public Law 97–
18 465 (16 U.S.C. 521c et seq.), as amended by subsection

19 (a):

20 (1) An acquisition from Irving N. Christensen
21 of that portion of SW¹/₄NW¹/₄ Section 16, T.19N.,
22 R.9E., MDM., lying southwesterly of California
23 State Highway 49 and all that portion of S¹/₂NE¹/₄
24 Section 17, T.19N., R.9E., MDM., lying southwest-
25 erly of California State Highway 49 and northeast-

1 erly of the North Fork Yuba River, through inter-
2 change of an approximately equal value of National
3 Forest System land lying northerly of California
4 State Highway 49 within the N¹/₂N¹/₂ Section 17,
5 T.19N., R.9E., MDM. The Federal land to be inter-
6 changed within the specifications of this paragraph
7 shall be agreed upon by the Forest Supervisor and
8 Irving N. Christensen.

9 (2) An acquisition from Dennis W. McCreary
10 and Cindy M. McCreary of a portion of Lot 19, Sec-
11 tion 35, T. 20 N., R. 10 E, MDM in Downieville,
12 Sierra County, California, through interchange of a
13 portion of National Forest System land in Lot 121,
14 Section 35, T. 20 N., R. 10 E, MDM in Downieville,
15 Sierra County, California. The Federal land to be
16 interchanged within the specifications of this para-
17 graph shall be agreed upon by the Forest Supervisor
18 and Dennis W. McCreary and Cindy M. McCreary.
