A BILL

To amend the Colorado Canyons National Conservation Area and Black Ridge Canyons Wilderness Act of 2000 to rename the Colorado Canyons National Conservation Area as the McInnis Canyons National Conservation Area.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MCINNIS CANYONS NATIONAL CONSERVATION**

4 **AREA.**

5 (a) PURPOSE.—The Colorado Canyons National Con-
6 servation Area and Black Ridge Canyons Wilderness Act
7 of 2000 (16 U.S.C. 460mm et seq.) is amended in sec-

1 tion 2(b) by striking “Colorado Canyons” and inserting
2 “McInnis Canyons”.

3 (b) DEFINITIONS.—Section 3 of such Act is amend-
4 ed—

5 (1) in paragraph (1), by striking “Colorado”
6 and inserting “McInnis”; and

7 (2) in paragraph (2), by striking “Colorado”
8 and inserting “McInnis”.

9 (c) COLORADO CANYONS NATIONAL CONSERVATION
10 AREA.—Section 4 of such Act is amended—

11 (1) in the heading, by striking “**COLORADO**”
12 and inserting “**MCINNIS**”; and

13 (2) in subsection (a), by striking “Colorado
14 Canyons” and inserting “McInnis Canyons”.

15 (d) ADVISORY COUNCIL.—Section 8(a) of such Act
16 is amended by striking “Colorado Canyons” and inserting
17 “McInnis Canyons”.

18 (e) SHORT TITLE.—Section 1 of such Act is amended
19 by striking “Colorado” and inserting “McInnis”.

20 (f) REFERENCES.—Any reference in a law, map, reg-
21 ulation, document, paper, or other record of the United
22 States to the “Colorado Canyons National Conservation
23 Area” shall be deemed to be a reference to the “McInnis
24 Canyons National Conservation Area”.

1 (g) EFFECTIVE DATE.—This section and the amend-
2 ments made by this section take effect on January 1,
3 2005.
