A BILL

To direct the Secretary of the Interior to arrange for the carving of the figure of former President Ronald Reagan on Mount Rushmore National Memorial, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. FIGURE OF FORMER PRESIDENT RONALD**
2 **REAGAN ON MOUNT RUSHMORE NATIONAL**
3 **MEMORIAL.**

4 (a) **AUTHORIZATION.**—The Secretary of the Interior,
5 acting through the Director of the National Park Service,
6 shall arrange for the carving of the figure of former Presi-
7 dent Ronald Reagan on Mount Rushmore National Memo-
8 rial.

9 (b) **DONATIONS.**—The Secretary of the Interior, act-
10 ing through the Director of the National Park Service,
11 shall solicit, accept, and deposit in the fund established
12 under subsection (c) donations from non-Federal sources
13 for carrying out this section.

14 (c) **FUND IN THE TREASURY.**—

15 (1) **IN GENERAL.**—There is created in the
16 Treasury a fund which shall be available to the Sec-
17 retary of the Interior, acting through the Director of
18 the National Park Service, for carrying out this sec-
19 tion. The fund shall consist of—

20 (A) amounts deposited under subsection

21 (b);

22 (B) interest and proceeds received under
23 paragraph (2); and

24 (C) obligations obtained under paragraph

25 (3).

1 (2) DEPOSITS AND CREDITS.—The Secretary of
2 the Treasury shall credit to the fund the interest on,
3 and the proceeds from sale or redemption of, obliga-
4 tions held in the fund.

5 (3) OBLIGATIONS.—The Secretary of the Treas-
6 ury shall invest any portion of the fund that, as de-
7 termined by the Secretary of the Interior, acting
8 through the Director of the National Park Service,
9 is not required to meet current expenses. Each in-
10 vestment shall be made in an interest bearing obliga-
11 tion of the United States or an obligation guaran-
12 teed as to principal and interest by the United
13 States that, as determined by the Secretary of the
14 Interior, acting through the Director of the National
15 Park Service, has a maturity suitable for the fund.

16 (4) ABOLITION.—Upon the final settlement of
17 the accounts of the fund, the Secretary of the Treas-
18 ury shall submit to the Congress draft legislation
19 (including technical and conforming provisions) for
20 the abolition of the fund.

21 (d) COSTS PROVIDED OR REIMBURSED BY NON-FED-
22 ERAL SOURCES.—All costs associated with carrying out
23 this section, including the cost of carving the figure of
24 former President Ronald Reagan on Mount Rushmore Na-

- 1 tional Memorial and other administrative costs, shall be
- 2 provided or reimbursed by non-Federal sources.
