and Maritime Transportation Act of 2004.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Coast Guard and Mari-
3 time Transportation Technical Corrections Act of 2004”.

4 **SEC. 2. REQUIREMENTS FOR COOPERATIVE AGREEMENTS**
5 **FOR VOLUNTARY SERVICES.**

6 Section 93(a)(19) of title 14, United States Code, as
7 amended by section 201 of the Coast Guard and Maritime
8 Transportation Act of 2004 (Public Law 108–293; 118
9 Stat. 1031), is amended by redesignating subparagraphs
10 (1) and (2) in order as subparagraphs (A) and (B).

11 **SEC. 3. CORRECTION OF AMENDMENT TO CHAPTER ANAL-**
12 **YSIS.**

13 Section 212(b) of the Coast Guard and Maritime
14 Transportation Act of 2004 (Public Law 108–293; 118
15 Stat. 1037) is amended by inserting “of title 14” after
16 “chapter 17”.

17 **SEC. 4. RECOMMENDATIONS TO CONGRESS BY COM-**
18 **MANDANT OF THE COAST GUARD.**

19 Section 93(a) of title 14, United States Code, as
20 amended by sections 201 and 217 of the Coast Guard and
21 Maritime Transportation Act of 2004 (Public Law 108–
22 293; 118 Stat. 1031, 1038), is amended by redesignating
23 paragraph (y) as paragraph (24).

24 **SEC. 5. DETERMINING ADEQUACY OF POTABLE WATER.**

25 Section 3305(a) of title 46, United States Code, as
26 amended by section 416(b)(3) of the Coast Guard and

1 Maritime Transportation Act of 2004 (Public Law 108–
 2 293; 118 Stat. 1047), is amended by moving paragraph
 3 (2) two ems to the left, so that the material preceding
 4 subparagraph (A) of such paragraph aligns with the left-
 5 hand margin of paragraph (1) of such section.

6 **SEC. 6. RENEWAL OF ADVISORY GROUP.**

7 Section 418(a) of the Coast Guard and Maritime
 8 Transportation Act of 2004 (Public Law 108–293; 118
 9 Stat. 1049) is amended by striking “of September 30,
 10 2005” and inserting “on September 30, 2005”.

11 **SEC. 7. VESSEL RESPONSE PLANS.**

12 Section 311 of the Federal Water Pollution Control
 13 Act (33 U.S.C. 1321), as amended by section 701 of the
 14 Coast Guard and Maritime Transportation Act of 2004
 15 (Public Law 108–293; 118 Stat. 1067), is amended by
 16 striking “non-tank” each place it appears and inserting
 17 “nontank”.

18 **SEC. 8. CORRECTION TO SUBTITLE DESIGNATION.**

19 (a) REDESIGNATION.—Title 46, United States Code,
 20 is amended by redesignating subtitle VI as subtitle VII.

21 (b) CLERICAL AMENDMENT.—The table of subtitles
 22 at the beginning of title 46, United States Code, is amend-
 23 ed by striking the item relating to subtitle VI and insert-
 24 ing the following:

“VII. MISCELLANEOUS 70101”.

1 **SEC. 9. CORRECTIONS TO CHAPTER 701 OF TITLE 46,**
2 **UNITED STATES CODE.**

3 Chapter 701 of title 46, United States Code, is
4 amended as follows:

5 (1) Sections 70118 and 70119, as added by
6 section 801 of the Coast Guard and Maritime
7 Transportation Act of 2004 (Public Law 108–293;
8 118 Stat. 1078), are redesignated as sections 70117
9 and 70118, respectively, and moved to appear imme-
10 diately after section 70116 of title 46, United States
11 Code.

12 (2) Sections 70117 and 70118, as added by
13 section 802 of such Act (Public Law 108–293; 118
14 Stat. 1078), are redesignated as sections 70120 and
15 70121, respectively, and moved to appear imme-
16 diately after section 70119 of title 46, United States
17 Code.

18 (3) In section 70120(a), as redesignated by
19 paragraph (2) of this section, by striking “section
20 70120” and inserting “section 70119”.

21 (4) In section 70121(a), as redesignated by
22 paragraph (2) of this section, by striking “section
23 70120” and inserting “section 70119”.

24 (5) In the analysis at the beginning of the
25 chapter, by striking the items relating to sections

1 70117 through the second 70119 and inserting the
2 following:

- “70117. Firearms, arrests, and seizure of property.
- “70118. Enforcement by State and local officers.
- “70119. Civil penalty.
- “70120. In rem liability for civil penalties and certain costs.
- “70121. Withholding of clearance.”.

3 **SEC. 10. TECHNICAL CORRECTION REGARDING TANK VES-**
4 **SEL ENVIRONMENTAL EQUIVALENCY EVAL-**
5 **UATION INDEX.**

6 Section 4115(e)(3) of the Oil Pollution Act of 1990
7 (46 U.S.C. 3703a note) is amended by striking “hull” the
8 second place it appears.

9 **SEC. 11. EFFECTIVE DATE.**

10 This Act shall take effect August 9, 2004.
