## RESOLUTION

Providing for consideration of the bill (H.R. 1000) to amend title I of the Employee Retirement Income Security Act of 1974 and the Internal Revenue Code of 1986 to provide additional protections to participants and beneficiaries in individual account plans from excessive investment in employer securities and to promote the provision of retirement investment advice to workers managing their retirement income assets.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order to consider in the House the bill (H.R.  
3 1000) to amend title I of the Employee Retirement In-  
4 come Security Act of 1974 and the Internal Revenue Code  
5 of 1986 to provide additional protections to participants  
6 and beneficiaries in individual account plans from exces-  
7 sive investment in employer securities and to promote the  
8 provision of retirement investment advice to workers man-  
9 aging their retirement income assets. The bill shall be con-  
10 sidered as read for amendment. The amendment rec-  
11 ommended by the Committee on Education and the Work-  
12 force now printed in the bill shall be considered as adopt-  
13 ed. All points of order against the bill, as amended, are  
14 waived. The previous question shall be considered as or-  
15 dered on the bill, as amended, and on any further amend-  
16 ment thereto to final passage without intervening motion  
17 except: (1) one hour and 20 minutes of debate on the bill,  
18 as amended, equally divided among and controlled by the  
19 chairmen and ranking minority members of the Com-  
20 mittee on Education and the Workforce and the Com-  
21 mittee on Ways and Means; (2) the further amendment  
22 printed in the report of the Committee on Rules accom-  
23 panying this resolution, if offered by Representative  
24 George Miller of California or his designee, which shall  
25 be in order without intervention of any point of order,

1 shall be considered as read, and shall be separately debat-  
2 able for one hour equally divided and controlled by the  
3 proponent and an opponent; and (3) one motion to recom-  
4 mit with or without instructions.
