Mrs. MYRICK, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4613) making appropriations for the Department of Defense for the fiscal year ending September 30, 2005, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4613) making appropriations for
6 the Department of Defense for the fiscal year ending Sep-

1 tember 30, 2005, and for other purposes. The first reading
2 of the bill shall be dispensed with. All points of order
3 against consideration of the bill are waived. General de-
4 bate shall be confined to the bill and shall not exceed one
5 hour equally divided and controlled by the chairman and
6 ranking minority member of the Committee on Appropria-
7 tions. After general debate the bill shall be considered for
8 amendment under the five-minute rule. The amendment
9 printed in the report of the Committee on Rules accom-
10 panying this resolution shall be considered as adopted in
11 the House and in the Committee of the Whole. Points of
12 order against provisions in the bill, as amended, for failure
13 to comply with clause 2 of rule XXI are waived. During
14 consideration of the bill for further amendment, the Chair-
15 man of the Committee of the Whole may accord priority
16 in recognition on the basis of whether the Member offering
17 an amendment has caused it to be printed in the portion
18 of the Congressional Record designated for that purpose
19 in clause 8 of rule XVIII. Amendments so printed shall
20 be considered as read. At the conclusion of consideration
21 of the bill for amendment the Committee shall rise and
22 report the bill, as amended, to the House with such fur-
23 ther amendments as may have been adopted. The previous
24 question shall be considered as ordered on the bill and
25 amendments thereto to final passage without intervening

1 motion except one motion to recommit with or without in-
2 structions.

3 SEC. 2. Upon the adoption of this resolution it shall
4 be in order, any rule of the House to the contrary notwith-
5 standing, to consider concurrent resolutions providing for
6 adjournment of the House and Senate during the month
7 of July.
