## A BILL

To amend title 49 of the United States Code to provide flight attendant security training, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Flight Attendant Secu-  
5       rity Training Act”.

6       **SEC. 2. AMENDMENTS TO CREW TRAINING PROVISIONS.**

7       (a) IN GENERAL.—Section 44918(a)(1) of title 49,  
8       United States Code, is amended to read as follows:

9               “(1) IN GENERAL.—

1           “(A) DEVELOPMENT OF TRAINING PRO-  
2           GRAM.—Not later than 60 days after the date  
3           of enactment of the Flight Attendant Security  
4           Training Act, the Administrator of the Federal  
5           Aviation Administration, in consultation with  
6           the Under Secretary of the Transportation for  
7           Security, appropriate law enforcement, security,  
8           and terrorism experts, representatives of air  
9           carriers, and labor organizations representing  
10          individuals employed in commercial aviation,  
11          shall develop detailed guidance for a scheduled  
12          passenger air carrier flight and cabin crew  
13          training program to prepare crew members for  
14          potential threat conditions.

15          “(B) REQUIREMENTS.—The guidance  
16          issued under subparagraph (A) shall include the  
17          following:

18                 “(i) Establishment of the required  
19                 number of hours and qualifications for  
20                 training instructors.

21                 “(ii) Establishment of the intervals,  
22                 number of hours, and elements of recur-  
23                 rent training.”.

1 (b) PROGRAM ELEMENTS.—Section 44918(a)(2) of  
2 such title is amended by striking subparagraph (I) and  
3 inserting the following:

4 “(I) Training in the proper conduct of a  
5 cabin search and explosive recognition, includ-  
6 ing the duty time required to conduct the  
7 search.”.

8 (c) APPROVAL OF PROGRAMS.—Section 44918(a) of  
9 such title is amended by striking paragraph (3) and insert-  
10 ing the following:

11 “(3) APPROVAL.—Within 60 days after the  
12 date the Administrator issues the guidance under  
13 this subsection in final form, each air carrier shall  
14 develop a flight and cabin crew training program in  
15 accordance with that guidance and submit the pro-  
16 gram to the Administrator for approval. Within 30  
17 days after receiving an air carrier’s program under  
18 this subsection, the Administrator shall review the  
19 program and approve it or require the air carrier to  
20 make any revisions deemed necessary by the Admin-  
21 istrator for the program to meet the guidance re-  
22 quirements.”.

23 (d) TRAINING.—Section 44918 of such title is  
24 amended by adding at the end the following:

1       “(d) TRAINING.—Within 180 days after the date the  
2 Administrator approves the training program developed by  
3 an air carrier under this section, the air carrier shall com-  
4 plete the training of all flight and cabin crews in accord-  
5 ance with that program.”.

6       (e) EXISTING PROGRAMS AND UPDATES.—Section  
7 44918(a) of such title is amended—

8           (1) by striking paragraphs (4), (5), and (7);

9           (2) by redesignating paragraph (6) as para-  
10 graph (4); and

11           (3) by adding after paragraph (4), as redesign-  
12 nated, the following:

13           “(5) UPDATES.—The Administrator shall—

14               “(A) update the training guidance issued  
15 under this subsection from time to time to re-  
16 flect new or different security threats; and

17               “(B) require air carriers to revise their  
18 programs accordingly and provide additional  
19 training to their flight and cabin crews.”.

20       (f) ADEQUATE RESOURCES.—Section 44918(a) of  
21 such title, as amended by subsection (e), is amended by  
22 adding at the end the following:

23           “(6) NECESSARY RESOURCES AND KNOWL-  
24 EDGE.—The Under Secretary shall ensure that em-  
25 ployees of the Federal Aviation Administration re-

- 1 sponsible for monitoring the training program have
- 2 the necessary resources and knowledge.”.
