## A BILL

To reauthorize the Upper Colorado and San Juan River Basin endangered fish recovery implementation programs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Upper Colorado and  
5 San Juan Basin Endangered Fish Recovery Implementa-  
6 tion Programs Reauthorization Act of 2005”.

1 **SEC. 2. UPPER COLORADO AND SAN JUAN RIVER BASIN EN-**  
2 **DANGERED FISH RECOVERY IMPLEMENTA-**  
3 **TION PROGRAMS.**

4 Section 3 of Public Law 106–392 (114 Stat. 1602)  
5 is amended—

6 (1) in subsection (a)—

7 (A) by striking “\$46,000,000” and insert-  
8 ing “\$61,000,000”;

9 (B) in paragraph (2), by striking “2008”  
10 and inserting “2010”;

11 (C) in paragraph (3), by striking “2008”  
12 and inserting “2010”;

13 (2) in subsection (b)—

14 (A) by striking “\$100,000,000” and in-  
15 serting “\$126,000,000”;

16 (B) in paragraph (1)—

17 (i) by striking “\$82,000,000” and in-  
18 serting “\$108,000,000”; and

19 (ii) by striking “2008” and inserting  
20 “2010”; and

21 (C) in paragraph (2), by striking “2008”  
22 and inserting “2010”; and

23 (3) in subsection (c)(4)—

24 (A) in the first sentence, by inserting “and  
25 the Elkhead Reservoir enlargement” after  
26 “Wolford Mountain Reservoir”; and

1 (B) in the second sentence, by striking  
2 “\$20,000,000” and inserting “\$31,000,000”.
