A BILL

To amend the David L. Boren National Security Education Act of 1991 to allow scholarship and fellowship recipients to work in a field of education if no position in the Federal Government relating to national security is available.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. NATIONAL SECURITY EDUCATION PROGRAM**
2 **SERVICE AGREEMENT.**

3 Section 802(b)(2) of the David L. Boren National Se-
4 curity Education Act of 1991 (50 U.S.C. 1902(b)(2)) is
5 amended to read as follows:

6 “(2) will—

7 “(A) in the case of a recipient of a scholar-
8 ship, not later than three years after the date
9 of the recipient’s completion of the study for
10 which scholarship assistance was provided
11 under the program, work—

12 “(i) for not less than one year in a po-
13 sition in the Department of Defense, the
14 Department of Homeland Security, the De-
15 partment of State, or any element of the
16 intelligence community that is certified by
17 the Secretary as contributing to national
18 security;

19 “(ii) if such recipient demonstrates to
20 the Secretary of Defense that no position
21 described in clause (i) is available, for not
22 less than one year in a position in another
23 department or agency of the Federal Gov-
24 ernment that is certified by the Secretary
25 as contributing to national security; or

1 “(iii) if such recipient demonstrates to
2 the Secretary of Defense that no position
3 described in clauses (i) or (ii) is available,
4 for not less than one academic year in a
5 position in the field of education in a dis-
6 cipline related to studies supported under
7 this section; or

8 “(B) in the case of a recipient of a fellow-
9 ship, not later than two years after the date of
10 the recipient’s completion of the study for
11 which the fellowship assistance was provided
12 under the program, work—

13 “(i) for not less than one year in a po-
14 sition in the Department of Defense, the
15 Department of Homeland Security, the De-
16 partment of State, or any element of the
17 intelligence community that is certified by
18 the Secretary as contributing to national
19 security;

20 “(ii) if such recipient demonstrates to
21 the Secretary of Defense that no position
22 described in clause (i) is available, for not
23 less than one year in a position in another
24 department or agency of the Federal Gov-

1 ernment that is certified by the Secretary
2 as contributing to national security; or

3 “(iii) if such recipient demonstrates to
4 the Secretary of Defense that no position
5 described in clauses (i) or (ii) is available,
6 for not less than one academic year in a
7 position in the field of education in a dis-
8 cipline related to studies supported under
9 this section.”.
